Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Honolulu Community Action Program, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Honolulu Community Action Program, Inc. Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended September 30, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Honolulu Community Action Program, Inc. Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Honolulu Community Action Program, Inc. Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants

1. DESCRIPTION OF THE PLAN

The following description of the Honolulu Community Action Program, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

a. General

The Plan, established in 1988 by Honolulu Community Action Program, Inc. (HCAP), provides retirement benefits to all eligible employees of HCAP. The Plan is a 403(b) plan, which is subject to the provisions of ERISA.

The Plan was intended to be an ERISA Section 404(c) participant-directed plan, which means that the participants exercise control over the assets in their individual accounts and that Plan fiduciaries may be relieved of liability for losses that are a result of participant investment instructions if certain requirements are met.

b. Eligibility for Elective Deferral and Employer Contributions

Participants will be eligible to begin making elective deferrals to the Plan upon the date their employment begins. Participants will be eligible for employer contributions immediately upon reaching age 18 and the completion of 1,000 hours of service, which is approximately six (6) months of employment.

c. Contributions

Participants will be permitted to make elective deferrals up to the maximum allowed by current law. HCAP will match a percentage of participants' elective deferrals for the plan year. HCAP will determine the uniform matching percentage to be contributed on behalf of participants who are eligible for employer contribution. For purposes of the employer's matching contribution, participants' elective deferrals in excess of a uniform percent of compensation will not be taken into account. The participants may be entitled to share in the contributions made by HCAP to the Plan. The amount of contribution made by HCAP each plan year is based on HCAP's discretion and may be zero in some years.

d. Forfeitures

Participants forfeit nonvested portions of employer contributions when they terminate employment before satisfying the Plan's vesting requirements. In accordance with the Plan document, forfeitures may be used to pay eligible Plan administrative expenses or to reduce future employer contributions. For the year ended September 30, 2024, the amount forfeited totaled \$1,524. No forfeitures were recorded for the year ended September 30, 2023. As of September 30, 2024 and 2023, forfeitures available for use totaled \$113,417 and \$106,072, respectively.

e. Notes Receivable from Participants

Participants are allowed to apply to the Plan Administrator for a loan that may not exceed the lesser of \$50,000, or 50% of their vested interest in the Plan. Any unpaid loan balance will be deducted from participants' benefits when paid as a result of any distributable events.

f. Plan Benefits

Participants will be fully vested in their accounts derived from their elective deferrals. Participants are also vested the applicable percentage of HCAP's contributions as follows:

<u>Years of service</u>	<u>HCAP's contributions</u>
1-2	25%
2-3	50%
3-4	75%
4 or more	100%

Employee benefits under the Plan will be in the form of payments under the investment arrangements, which in the case of an annuity contract, may be in the form of periodic payments at regular intervals either for a period certain or for one or more lives, and in the case of a custodial account, may be in the form of a lump sum payment or payments of a specified amount or for a specified period or such other options as permitted under the custodial agreement.

g. Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of HCAP's matching contribution and Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a. Basis of Accounting

The accompanying financial statements was prepared in accordance with the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under this method, revenues are recognized when received and expenses are recognized when paid, with certain modifications to reflect the recording of investments at fair value.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

b. Investment Valuation

Investments are stated at fair value that is the price that would be received to sell an asset at the measurement date. The Plan's valuation policies utilize information provided by its investment custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recognized when received. Net appreciation or depreciation in the fair value of investments reflects both realized gains and losses on investments sold during the year and the change in unrealized gains and losses on investments held at year-end.

c. Administrative Expenses

Administrative expenses are paid by the Plan as provided by the plan document. Expenses include maintenance charge, separate account charge at an annual rate ranging from 1% to 1.25% of the average daily net asset value of separate account, and cash surrender or withdrawal charge. Charges against separate accounts, paid by the Plan, are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

d. Payment of Benefits

Participant benefits are recorded when paid.

e. Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of American, requires management to make estimates and assumptions that affect the reported amounts of Plan assets and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

f. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of September 30, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the note receivable from the participant to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

g. Revenue Recognition

Contributions from participants and the employer are recognized as additions to net assets when received by the Plan's custodian.

5. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Plan by a letter dated April 29, 1987, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

6. PARTY-IN-INTEREST

The Plan investments are managed by VALIC, custodian as defined by the Plan and, therefore, the transactions qualify as party-in-interest transactions. Fees for the administration services amounts to \$35,459 and \$65,653 for the year ended September 30, 2024 and 2023, respectively. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the HCAP has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts will be become fully vested in participants' accounts.

8. FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted market prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

8. FAIR VALUE MEASUREMENTS (CONTINUED)

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at September 30, 2024.

- Mutual Fund: Valued at fair value based on quoted market prices and contract values
- Annuity Fund: Valued at fair value based on quoted market prices and contract values

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2006, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with VALIC AIG Retirement Services. VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investment and charged for administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by VALIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer up to 20% of their investment at contract value during each Certificate Year. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at September 30, 2024 and 2023 were \$2,578,146 and \$2,674,706, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 2%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the Plan's ability to transact at contract value with VALIC. Such events include, but not limited to: mergers, layoffs, bankruptcy, or plan termination, as that term is defined under federal law and regulations promulgated thereunder, or comparable person as allowed by applicable law. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Either party to the group annuity contract may terminate the contract with at least 30 days advance written notice to the other party. The contract termination date shall be any business day on or after the expiration of the 30-day notification period.

11. SUBSEQUENT EVENTS

Management has evaluated subsequent events and transactions that occurred after the balance sheet date for potential recognition and disclosure through July 8, 2025, the date on which the financial statements were available to be issued.
