### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Yakima Valley Memorial Hospital 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Yakima Valley Memorial Hospital 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2024 and December 31, 2023, and for the period from January 1, 2024 to September 30, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Yakima Valley Memorial Hospital 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter***

As discussed in Note 1 to the financial statements, effective September 30, 2024, the Yakima Valley Memorial Hospital 401(k) Plan assets were merged with and into the MultiCare Health System 401(k) Plan. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Yakima Valley Memorial Hospital 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, no such opinion is expressed.

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Yakima Valley Memorial Hospital 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Note 1 – Description of Plan

The following description of the Yakima Valley Memorial Hospital 401(k) Plan (the Plan), as amended, provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of Plan provisions.

**General** – The Plan, established October 1, 2004, was a defined contribution plan covering almost all employees of the Yakima Valley Memorial Hospital Association (the Hospital). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Hospital had appointed an Administrative Committee (the Committee) to manage the operation and administration of the Plan. Fidelity Management Trust Company acted as trustee to process and maintain the records of participant data.

The Hospital had Section 401(k) Safe Harbor provisions in place.

Effective September 30, 2024, the Plan was merged into the MultiCare Health System 401(k) Plan. As of September 30, 2024, plan assets totaling to \$378,682,868 were transferred to the MultiCare Health System 401(k) Plan. Recordkeeping responsibilities were transferred to Empower Retirement.

**Eligibility** – Employees of the Hospital were eligible to participate in salary reduction contributions immediately upon hire. Participants were eligible to receive matching and nonelective safe-harbor contributions upon one year of service in which the employee had completed at least 501 hours of eligible service.

As defined in the amended adoption agreement, the following employee classes were excluded from participating in the Plan: employees covered by a collective bargaining agreement between the employer and employee representative, leased employees, employees of any member of the controlled and/or affiliated service group employer whose employer does not affirmatively adopt the Plan, employees who are nonresident aliens, and workers who are treated as leased employees or independent contractors but are later determined to be common law employees.

### Contributions

*Participant contributions* – Each year participants were able to make elective deferrals in the form of pretax annual compensation or Roth elective deferrals in any amount up to the maximum, 85% of compensation, as adopted by the employer. Participants eligible to make catch-up contributions were permitted to contribute in excess of the deferral limit up to 100% of the participant's compensation available after other withholding. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants were also able to contribute amounts representing distributions from other qualified defined benefit plans, defined contribution plans, and Roth accounts.

The Plan permitted the automatic enrollment of eligible employees in the Plan with a contribution of 3% of eligible compensation unless the employee affirmatively elects otherwise. Participants who were auto enrolled in the Plan had their deferral increase annually by 1%, on the anniversary of such enrollment date, until a deferral rate of 10% was reached.

*Employer match and nonelective contributions* – The Hospital could elect to make discretionary matching and nonelective contributions to the Plan as follows:

- a. The Hospital matched 16%, 33%, or 50%, based upon years of service of one to four, five to nine, and ten plus years, respectively, of employee contributions, up to 6% of eligible compensation deferred to the Plan. A matching contribution could not exceed 6% of a participant's eligible compensation per pay period. The matching contribution for the period from January 1, 2024 to September 30, 2024, was \$2,961,281.
- b. Employer nonelective safe harbor contributions to eligible participants were equal to 5% of the participant's eligible compensation and were immediately 100% vested. The safe harbor contribution for the period from January 1, 2024 to September 30, 2024, was \$7,606,624.

Contributions were subject to regulatory limitations.

**Participant accounts** – Each participant's account was credited with the participant's contribution, Hospital matching contributions, Hospital safe harbor nonelective contributions, and allocations of Plan earnings and losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. Participants directed the investment of their account into various investment options offered by the Plan.

**Vesting** – Participants were vested immediately in their contributions, employer matching contributions, and safe harbor employer nonelective contributions, plus actual earnings thereon.

**Notes receivable from participants** – Participants could borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All loans must be repaid within a period of one to five years, unless the loan was used to purchase a principal residence, in which case the loan must be repaid within a reasonable period of time not to exceed 10 years. However, loans that originated in plans that merged into the Plan in 2012 may have repayment periods of more than 10 years. Under the terms of the Plan agreement, Plan loans bear interest at a rate determined by the administrator and communicated to the Trustee at a reasonable rate based on the prevailing interest rates charged by persons in the business of lending money for loans. All notes receivable and collateral were transferred to the MultiCare Health System 401(k) Plan effective with the merger.

**Payment of benefits** – On termination of service due to death, disability, or retirement, a participant (or a deceased participant's beneficiary) could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of not more than a participant's (or beneficiary's) assumed life expectancy. For termination of service for other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution. At termination of service, all accounts with a balance less than \$5,000 were automatically distributed in a lump sum payment. Distributions greater than \$1,000 made without the participant's consent, before normal retirement age, were rolled over into an individual retirement plan. The Plan permitted a participant to withdraw regular 401(k) elective deferrals and Roth elective deferrals on account of a hardship.

### Note 2 – Summary of Significant Accounting Policies

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in accordance with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – The investments are reported at fair value. The Plan's trustee, Fidelity Management Trust Company, certifies the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Contributions** – Contributions from participants and corresponding matching and nonelective contributions are recorded in the year in which the related participant compensation is earned.

**Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement. No allowance for credit losses has been recorded as of September 30, 2024 and December 31, 2023.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – General Plan administrative expenses could be paid out of the forfeiture account or paid by the Hospital. Investment management, distribution, and loan transaction fees were paid by the Plan participants.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are issued.

The Plan has evaluated subsequent events through July 11, 2025, which is the date the financial statements were issued.

### Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and December 31, 2023.

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

*Collective trust* – Units held in collective trusts (CT) were valued using the net asset value practical expedient (NAV practical expedient) of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV practical expedient. The CT could be redeemed daily, and there were no redemption restrictions or notice requirements.

The valuation methods used by the Plan could have produced a fair value calculation that was not indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

### Note 4 – Tax Status

The Plan document was volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on March 31, 2014, which stated that the Plan, as then designed, was in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

In accordance with guidance on accounting for uncertainty in income taxes, management evaluated the Plan's tax positions and does not believe the Plan had any uncertain tax positions that would require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### Note 5 – Certified Investment Information

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of September 30, 2024 and December 31, 2023.

- Net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the period from January 1, 2024 to September 30, 2024.

#### **Note 6 – Party-in-Interest Transactions**

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain Plan investments were managed by Fidelity Management Trust Company, the Plan trustee; therefore, transactions with this entity qualify as exempt party-in-interest transactions.

#### **Note 7 – Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments could have materially affected a participant's account balance and the amounts reported in the statements of net assets available for benefits.
