Note 1 – Plan Description

The following description of the Houston Medical Imaging, LLC 401(k) Plan (the “Plan”) provides only general information. Houston Medical Imaging, LLC (the “Company” or “Employer”) is the Plan Sponsor. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that provides retirement savings benefits to eligible employees of the Company. The Plan commenced effective May 1, 2012 and was amended and restated effective January 1, 2021 to comply with the latest rules and regulations. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodian and Trustee

The Plan’s assets are held by John Hancock Life Insurance Company (“John Hancock” or “Custodian”). Among other duties, the Custodian receives contributions, holds and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. An employee of the Company serves as trustee of the Plan.

Pending Asset Transfer

Effective January 1, 2023, Empower Trust Company, LLC (“Empower”) and Empower Retirement, LLC were appointed as the new custodian and record-keeper, respectively. As a result of the change in custodian, the assets of the Plan transferred from John Hancock to Empower, and there was a blackout period from December 23, 2022, until the week of January 20, 2023. During the aforementioned period, participants could not direct or diversify investments, or obtain a distribution from the Plan. The Plan has recorded a corresponding receivable for the pending asset transfer due to the change in custodian during the blackout period in the accompanying financial statements. Plan assets were liquidated on December 30, 2022, and transferred to the new custodian on January 19, 2023. The assets transferred from John Hancock to Empower totaled \$1,386,172.

Eligibility

Employees that are covered by collective bargaining agreements or are non-resident aliens receiving no U.S.-source income are not eligible to participate in the Plan. All other employees become eligible to participate in the Plan after reaching the age of 21 and completing 60 days of service. Eligible employees are permitted to enter the Plan beginning upon the first day of the quarter after which the employee has satisfied the eligibility requirements.

Contributions

Participants may elect to contribute, on a before-tax or Roth basis, a portion of their eligible compensation, as defined in the Plan, up to the maximum amount allowed for deferral annually by the IRC, which was \$20,500 for 2022. Participants who have attained age 50 before the end of the Plan year are also eligible to make catch-up contributions of up to the maximum amount allowed annually by the IRC, which was \$6,500 for 2022.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral amount set at \$25 per pay period.

Note 1 – Plan Description (continued)

Contributions (continued)

Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

The Plan provides for fixed Employer matching contributions. In 2022, the Company matched 100% of each participant’s contributions up to \$25 per pay period, to a maximum of \$650 per year.

Participant Accounts

Each participant account is credited with the participant’s contributions, the Company’s matching contributions, and allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participant Directed Investments

All assets of the Plan are participant directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate allocations of their account balances. Participants may direct their account balances to one or more of these investment options, which vary in types of investments, rates of return, and investment risk.

Vesting

Participants are immediately 100% in their contributions, rollover contributions, and related earnings. Vesting in Employer contributions, plus any income or loss thereon, is based upon years of service according to the following schedule:

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant receives a lump sum amount equal to the value of the participant’s vested interest in his or her account. A participant may withdraw all or a portion of their vested account balance in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59 ½.

Forfeited Accounts

Participants who terminate employment with the Company prior to full vesting forfeit any non-vested portion of the Employer’s contributions. Per the provisions of the Plan Agreement, such forfeited contributions are to be used to pay Plan administrative expenses or to offset Employer contributions. At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$8,616 and \$6,290, respectively.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Certain expenses specifically incurred by, or attributable to, a participant will be paid from that participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Note 3 – Fair Value Measurements (continued)

- **Level 3** – Inputs that are unobservable inputs for the assets or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

- **Pooled Separate Accounts** – Valued using the net asset value (“NAV”) of units held by the Plan at year-end as provided by the Custodian. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee, and is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the pooled separate account, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner. Participant transactions (purchases and sales) may occur daily. There are no significant restrictions on participant redemptions and no unfunded commitments.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2021. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Note 4 – Information Prepared and Certified by the Plan’s Custodian (continued)

The Plan’s independent auditor did not perform auditing procedures with respect to this information except for comparing such information with the related information included in the financial statements and supplemental information.

Note 5 – Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by John Hancock, the Custodian of the Plan. As such, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the Provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7 – Tax Status

The Company has adopted a non-standardized pre-approved profit-sharing plan (the “Pre-Approved Plan”) sponsored by Loren D Stark Company. The IRS has determined and informed the Pre-Approved Plan sponsor by letter, dated November 30, 2020, that the Pre-Approved Plan is designed in accordance with applicable sections of the IRC. Although the Plan has not filed individually with the IRS regarding the Plan’s qualified tax status, the Plan Administrator believes the Plan is designed and currently being operated in compliance with applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax exempt. As such, no provision for income taxes have been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2019.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 – Prohibited Transactions

For the Plan year ended December 31, 2021, the Company failed to remit to the Plan's Custodian certain participant contributions totaling \$5,472 within the timeframe prescribed by the DOL. These transactions are prohibited transactions in accordance with ERISA and the IRC. Delays in remitting contributions to the Custodian were due to unintentional administrative errors. The Company is in the process of correcting contributions to the affected participants' accounts to compensate the participants for potential lost earnings due to the delay.
