### NOTES TO FINANCIAL STATEMENTS

September 30, 2024 and 2023

#### NOTE A - DESCRIPTION OF PLAN

The following description of the Morgan, Lewis & Bockius LLP Defined Contribution Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan is a non-contributory defined contribution plan originally established on October 1, 1994, in conjunction with the Morgan, Lewis & Bockius LLP Defined Contribution Plans B and C, to cover non-associate staff employees, partners and the Executive Director of Morgan, Lewis & Bockius LLP (the "Firm") who have one year of credited service and are age 21 or older. Effective October 1, 2001, only partners are eligible as new participants in the Plan. Effective September 30, 2012, the Morgan, Lewis & Bockius LLP Defined Contribution Plans B and C ("Merged Plans") were merged into the Morgan, Lewis & Bockius LLP Defined Contribution Plan A, this Plan, which was then renamed to the Morgan, Lewis & Bockius LLP Defined Contribution Plan. Non-associate staff employees are also eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

##### **Contributions**

Effective October 1, 2011, the Firm's contribution is as follows: (1) annual contributions on behalf of each partner are in the amount of \$20,000 or the maximum annual addition permitted under section 415(c) of the Internal Revenue Code ("IRC") less the limit under section 402(g) of the IRC for the plan year, which contribution formula is based on that partner's earned income; (2) for each participant who is not a partner, the Firm contributes the greater of 7.5% of annual compensation or \$1,000; and (3) for each participant who becomes a new income partner or lateral partner on or after October 1, 2012, the Firm contributes the lesser of \$10,000 or 7.5% of annual compensation.

##### **Participant Accounts**

Participants direct the investment of the Firm's contributions into any of the various investment funds available under the Plan. These funds are all held within the Morgan, Lewis & Bockius LLP Defined Contribution Plan Master Trust (the "Master Trust") (Note D). Each participant's account is credited with allocations of: (1) the Firm's contribution, as applicable under the Plan; and (2) investment earnings, and charged with (a) withdrawals and (b) an allocation of investment losses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting and Forfeitures**

Firm contributions are 100% vested after three years of service. A year of service for vesting purposes is a plan year in which a participant is credited with at least 1,000 hours of service.

Participants become fully vested in their accounts upon attainment of age 65, death or total disability while employed by the Firm, regardless of their credited years of service. If a participant terminates employment or withdraws from the Firm prior to full vesting, the non-vested portion of the participant's account will be forfeited as of the date of termination or withdrawal. Forfeitures existing at year end are applied to reduce the employer contribution attributable to that plan year. At September 30, 2024 and 2023, forfeited non-vested accounts totaled \$1,531,420 and \$1,612,095, respectively. During the year ended September 30, 2024, \$1,210,319 of forfeitures were used to reduce employer contributions.

***Payment of Benefits***

If a participant retires, dies, becomes disabled or otherwise separates from the Firm, the participant or participant's beneficiary is entitled to the vested value of his or her account. Distributions are made, subject to certain limitations, as lump-sum distributions, partial payments or installments. In addition, participants may elect in-service withdrawals of their account balance after reaching age 62.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investments***

The assets of the Plan are maintained under a Master Trust Agreement in the Master Trust. The Plan's interest in the Master Trust is stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by its investment advisors and the Plan trustee. See Note E for discussion of fair value measurements. Purchases and sales of Master Trust securities are recorded on a trade-date basis. Master Trust interest income is recorded on the accrual basis. Master Trust dividends are recorded on the ex-dividend date. Master Trust net appreciation includes gains and losses on investments bought and sold, as well as held during the year.

***Payment of Benefits***

Benefit payments are recorded when paid.

***Expenses***

Substantially all administrative expenses of the Plan are paid by the Firm.

**NOTE C - INVESTMENT INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company (the "Trustee") has certified the following Plan and related Master Trust information as complete and accurate:

**NOTE D - INTEREST IN MASTER TRUST**

The Master Trust Agreement for the Master Trust was established on September 29, 2005 for the investment of assets of this Plan and the Morgan, Lewis & Bockius LLP Tax-Saver Retirement Plan. Each participating retirement plan has a specific divided interest in the Master Trust based on participant-directed investment activity, and all assets are separately allocated to participant-directed accounts. The assets of the Master Trust are held by the Trustee.

The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the Master Trust plus actual contributions and allocated investment income less actual distributions and allocated investment losses and administrative expenses. Investment management fees and other direct expenses relating to the Master Trust are allocated to the individual plans based on the average daily investment balances. Master Trust total investment income, including net appreciation in the fair value of investments and interest and dividend income, is allocated to the Plan in relation to its proportionate share of the Master Trust assets invested for participant-directed accounts.

**NOTE E - FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) No. 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I measurements) and the lowest priority to unobservable inputs (Level III measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level I - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;

- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for Master Trust assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

- Registered investment companies and self-directed brokerage accounts are valued at the quoted net asset value ("NAV") of shares held by the Master Trust at year end as reported on the active market on which the funds are traded (Level I inputs).
- Collective trust funds: The fair value is based on the NAV, calculated and reported daily. There are no redemption restrictions or unfunded commitments as of September 30, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes the valuation methods used by the Master Trust are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables present information about the Master Trust's investments measured at fair value on a recurring basis as of September 30, 2024 and 2023, and indicate the fair value hierarchy of the valuation techniques utilized by the Master Trust to determine such value:

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

#### NOTE F - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments in registered investment companies, collective trusts funds and self-directed brokerage accounts held within the Master Trust are managed by Vanguard Fiduciary Trust Company, the Trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

#### NOTE G - TAX STATUS

The Plan has received a determination letter from the Internal Revenue Service dated November 4, 2016 stating that the Plan and related Master Trust are designed in accordance with applicable provisions of the IRC. The Plan has been amended since receiving the determination letter. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related Master Trust is tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE H - PLAN TERMINATION

Although it has not expressed any intention to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants would become 100% vested in the Firm's contributions to their accounts.

**NOTE I - RISKS AND UNCERTAINTIES**

The Plan holds an investment interest in the Master Trust, which invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

**NOTE J - SUBSEQUENT EVENTS**

Subsequent events have been evaluated through July 14, 2025, which is the date the financial statements were available to be issued. The Plan is not aware of any subsequent events that would require recognition or disclosure in the financial statements.
