### 1. Plan Description

---

The following brief description of the Sojern, Inc. 401(k) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan was established January 1, 2008 to provide retirement benefits for the employees of Sojern, Inc. (the Company). The Plan covers employees of the Company, excluding temporary employees, interns, residents of Puerto Rico, and other individuals who for any period are classified by the Company as independent contractors. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees are eligible to make pre-tax, after-tax Roth, and effective January 1, 2024, voluntary after-tax contributions and receive discretionary matching and discretionary non-elective contributions on the first day of the month after attaining the age of 21. Eligible employees become Plan participants on the first day of the month following the date on which the entry requirements are fulfilled.

#### ***Contributions***

Participants may make voluntary salary deferral contributions up to 100% of their annual eligible compensation, subject to the maximum dollar amounts allowable by law. Participants are automatically enrolled with an initial 5% deferral contribution. At any time, a participant can elect not to contribute or may increase or decrease his or her deferral rate to any rate allowed under Plan provisions. Participants may also contribute amounts representing distributions from other qualified plans. The Company may make discretionary matching contributions (none in 2024 or 2023) and discretionary non-elective contributions. For the years ended December 31, 2024 and 2023, the Company's discretionary non-elective contributions were based on 2% of the participant's eligible compensation. All participants who are eligible to make deferral contributions and who are projected to attain age 50 before the close of the calendar year are eligible to make catch up contributions, subject to the maximum dollar amounts allowable by law.

#### ***Participant Accounts***

Each participant's account is credited or debited with the participant's contributions and an allocation of a) the Company's discretionary matching contributions, b) the Company's discretionary non-elective contributions, c) Plan earnings or losses d) transaction based fees and e) Plan administration fees. The Company's discretionary matching contributions are allocated to participants based on each participant's elected salary deferral. The Company's discretionary non-elective contributions are allocated based upon eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Transaction based fees for optional services offered under the Plan are allocated to participants who opt for these services. Revenue credits earned by specific investments are allocated pro-rata to participants who invest in the investments subject to credits.

Investments are maintained in individual member accounts managed by Fidelity Management Trust Company (Fidelity).

### ***Vesting***

Participants are vested immediately in their contributions and Company discretionary non-elective contributions plus actual earnings thereon. For discretionary matching contributions, the contributions credited to participants' accounts are vested based on years of continuous service. A participant is 33.3% vested after one year of credited service and vesting increases 33.3% per year until a participant is 100% vested after three years of credit service.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The loans are made on a non-discriminatory basis and are secured by the participant's account and bear interest at rates of 4.25%-9.50% as of December 31, 2024 and 2023. Principal and interest rates are paid ratably through monthly payroll deductions.

### ***Payment of Benefits***

Upon normal retirement, disability, or death, the participant or beneficiary may elect to receive a lump sum or installment payments equal to the value of the vested funds allocated to the participant's account. Upon termination of service for other reasons, the participant may receive a lump sum payment equal to the value of the vested funds allocated to the participant's account. If the value of the vested funds allocated to the participant's account is greater than \$7,000 (\$5,000 prior to January 1, 2024), participants have the option of leaving their funds in the Plan. If the value of the vested funds allocated to the participant's account is between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024), the participant's account will be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. If the value of the vested funds allocated to the participant's account is less than \$1,000, a distribution will be paid out to the participant in the event the participant does not elect a payout option. Participants are allowed to take in-service withdrawals upon attainment of age 59.5. Hardship withdrawals are also based on certain criteria. Benefits are recorded when paid.

### ***Forfeitures***

Upon a participant's termination of employment before normal retirement, disability or death, the portion of their Company contributions not then vested shall be forfeited. Additionally, corrections are allocated to the forfeiture account, and may be used to pay Plan expenses and to reduce the Company's contributions. As of December 31, 2024 and 2023, there were \$996 and \$45,454 of forfeited, non-vested amounts available, respectively. During 2024 and 2023, \$46,767 and \$0 were used to reduce the Company's contributions or pay Plan expenses, respectively.

### 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

#### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

#### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Subsequent Events*

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through July 1, 2025, noting no items requiring disclosure.

### 3. Information Certified by Fidelity

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

#### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

*Mutual Funds and Money Market Funds:* Valued at the daily closing price as reported by the funds. The funds held are open-end funds and are registered with the Securities and Exchange Commission. These funds are required to publish daily net asset value (NAV) and to transact at that price. These funds are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

---

The Plan is qualified as defined contribution plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### 6. Plan Termination

---

Although it has not expressed to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

#### 7. Related Party Transactions

---

Certain Plan investments are mutual funds and a money market fund managed by Fidelity. Fidelity is the custodian as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions.

#### 8. Reconciliation to Form 5500

---
