Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Doctor's Data Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income and Securities Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE A--DESCRIPTION OF PLAN

The following brief description of the Doctor's Data Inc. Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Doctor's Data, Inc. (the "Company") covering all employees of the Company and, as of September 1, 2017, the wholly owned subsidiary, Labrix LLC. The Plan is subject to the provisions of the Employee Retirement Income and Security Act of 1974 ("ERISA"). The Plan Administrator and Plan Trustees are responsible for oversight of the Plan, determining the appropriateness of investment offerings, and monitoring investment performance.

The Plan was originally established on January 1, 1996, subsequently amended and restated September 1, 2017, and most recently amended and restated October 1, 2021. The Plan provides for contributions to be made under salary deferral agreements pursuant to Section 401(k) of the Internal Revenue Code (the "Code"). An eligible full-time employee will become eligible on the date of hire and become a participant on the first day of the month coinciding with or next following the date the eligibility requirement is satisfied.

Contributions

Eligible participants may elect to contribute a minimum of 1% or a maximum of 90% of pre-tax or after-tax (Roth) compensation to the Plan by means of a salary deferral agreement. Contributions are subject to limitations as provided in the Code and as described in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover) in accordance with the Plan provisions.

Unless eligible employees affirmatively elect otherwise, their compensation will be reduced by 3% (the "Automatic Contribution Arrangement"). For each payroll period in which they are an active and eligible participant, a pre-tax deferral contribution at the automatic contribution arrangement rate will be made on the participant's behalf into a default fund as designated by the Plan Trustees.

The Company will make matching contributions equal to 50% on the first 6% of a participant's compensation which is deferred as an elective deferral. The Company may make discretionary matching contributions based on a participant's contributions to the Plan in accordance with Plan provisions. To receive an allocation of the discretionary matching contributions, a participant must have completed three months of employment and be employed at year end.

Contributions-continued

Salary deferral contributions are funded proximate to the withholding date. Discretionary matching contributions, if any, are funded annually after the close of the Plan year and within statutory time frames. All contributions invested are directed by the participant into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, if any, Company matching contributions and Company discretionary matching, if any, as well as allocations of (a) Plan earnings or losses, (b) forfeitures of terminated participants' non-vested accounts, and (c) charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant account balances or compensation, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, participants direct their contributions into a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time in accordance with Plan provisions. During any period in which there is no participant direction on file with Reliance Trust Company, the Custodian, as to the investment of a participant's account, 100% of that participant's account will be invested in the investment option designated from time to time by the Custodian as the default investment. The Plan currently offers various mutual funds and a stable value collective trust fund as investment options for participants.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants vest 100% in the Company's matching contribution portion of their accounts plus actual earnings thereon after one year. Vesting in the Company's discretionary matching portion of their accounts plus actual earnings thereon is based on years of credited service as presented below. A participant is 100% vested in the Company's discretionary matching portion of their accounts after six years of credited service. Participants who attain the normal retirement age of 65, or who terminate employment due to death or disability become 100% vested in their account balances.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. The \$50,000 maximum loan amount is reduced by the participants highest outstanding loan balance in the previous 12 months, if any, on the date a new loan is made. Prior to October 1, 2021, participants were permitted to only have two loans outstanding at a time. The loans are secured by the nonforfeitable balance in the participant's account and bear interest at the prime rate as published in The Wall Street Journal, plus 2%. Loan terms may not exceed 5 years unless the loan is obtained for the purchase of a participant's residence, in which case the loan term may not exceed 30 years. Principal and interest are typically paid ratably through periodic payroll deductions. The interest rate applied to the current loans outstanding ranges from 5.25 to 10.5 percent.

Payment of Benefits

Upon termination of employment due to death, disability, retirement or Plan termination, a participant is entitled to 100% of their account balance in a lump-sum cash distribution or have the payment paid as a direct rollover to an individual retirement account ("IRA"). For termination of employment for other reasons, a participant is entitled to a lump-sum cash distribution of 100% of the participant's contributions and the vested portion of the Company's discretionary matching contributions based upon the Plan's vesting provisions. If a participant's account balance is in excess of \$5,000, a participant may choose to receive installments, request a partial withdrawal or defer receiving payments until age 70 ½.

All distributions will be made as soon as administratively feasible. However, those account balances in excess of \$5,000 (not including rollover account balances), will be made as soon as administratively feasible following the date the Plan Administrator receives a written request for distribution. In-service and hardship withdrawals, subject to certain restrictions, are also permitted.

Mandatory distributions greater than \$1,000 may be paid in a direct rollover to an IRA designated by the Plan Administrator. These distributions will be made if the participant does not elect to have such distributions paid directly to an eligible retirement plan specified by the participant in a direct rollover or does not elect to receive the distribution directly.

Forfeited Accounts

Forfeited non-vested accounts may be used to reduce the employer's discretionary matching or may be used to reduce administrative expenses. There were \$1,184 and \$1,159 of forfeited non-vested accounts at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$3,097 of forfeited non-vested accounts were used to reduce the employer match.

Forfeited non-vested accounts may also be used to reinstate any previously forfeited amounts of certain former participants who are rehired and used to reinstate any previously forfeited amounts of participants that were not located if the participant makes a claim thereafter.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's Administrator to make estimates and assumptions that affect reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in shares of registered investment companies and stable value collective investment trust are reported at fair value. Fully benefit-responsive investment contracts, when present, are reported at contract value. The Plan does not hold any fully benefit-responsive contracts at December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's stable value collective investment trust is valued at the net asset value used as a practical expedient to estimate fair value. The Plan's Administrator and Trustees determine the Plan's valuation policies utilizing information provided by investment advisers, Custodian, and insurance companies. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends, as applicable, are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid through the Plan and subsequently reimbursed by the Company (see Note E). Fees related to the administration of benefit payments and notes receivable from participants are paid by the individual participant accounts. Investment-related expenses are included in net appreciation/depreciation in the fair value of investments.

Subsequent Events

The Plan Administrator has evaluated subsequent events through July 3, 2025 which is the date the financial statements were available to be issued.

NOTE C--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Should an investment be re-characterized from one level to another level, Plan management would state the basis for the change. Under such circumstances, the Plan would report the transfers in and transfers out at the beginning of the Plan quarter when change occurs.

The following is a description of the valuation methodologies used for Plan assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Registered investment companies are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The self-directed brokerage account consists of an FDIC insured deposit account held by a brokerage firm.

The stable value collective investment trust, that is composed primarily of fully benefit-responsive investment contracts, is valued at the NAV of units of the collective trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities' liquidations will be carried out in an orderly business manner.

NOTE E--RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds and common trust funds managed by the Custodian and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for these investment management services are included in net appreciation of fair value of investments on the accompanying statement of changes in net assets available for benefits.

The Custodian provides certain administrative services to the Plan pursuant to a service agreement between the Plan and the Custodian. The Custodian receives revenue from the Plan for performance of these services. This revenue is also used to offset certain amounts owed to the financial advisors, authorized representatives, and other third-party administrators for the services they provide the Plan.

A third-party administrator also performs administrative and recordkeeping services for the Plan and receives fees paid by the Company for these services.

Certain employees of the Company provide administrative services for the Plan and the Company is not reimbursed for their services.

NOTE F--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE G--TAX STATUS

On October 6, 2020, the Internal Revenue Service ("IRS") stated that the prototype adopted by the Plan, as then designed, qualifies under the Code section 401(k). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRS, and therefore believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE H--RISKS AND UNCERTAINTIES

The Plan's assets are invested directly and indirectly in various investment securities which are purchased or managed by the Custodian. These investments are exposed to various risks such as interest rate, market, and credit risks. The Plan's assets are subject to the changes in the value of its underlying investments, including the potential for bankruptcy of one or more of the companies in which they are invested.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The participants who have borrowed from the Plan are all employees of the Company in the United States of America, and their ability to repay the loans could be affected by the economic conditions in the industry in general, the economic conditions in Chicago metropolitan area or the economic situation of the Company itself.
