Independent Auditors' Report

To the Participants and Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of the 403(b) Thrift Plan of Griffith Centers for Children, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of September 30, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended September 30, 2024, stating that the certified investment information as described in Note 9 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statement section –

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of

America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the 403(b) Thrift Plan of Griffith Centers for Children, Inc. and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the 403(b) Thrift Plan of Griffith Centers for Children, Inc.'s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Note 1: Description of Plan

The following description of 403(b) Thrift Plan of Griffith Centers for Children, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers all employees of Griffith Centers (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Certification

The Plan's custodian has certified to the accuracy of the investment transactions, recognition of income, expenses, and assets held as of September 30, 2024.

Contributions

Eligible employees may begin to participate in the Plan with elective deferral contributions immediately after the date of hire on the first day of each pay period. Employees are automatically enrolled at a 1% deferral of their salary, unless the employees elect to have a higher deferral rate or waive their rights to participate. Each year, participants may contribute to the Plan the maximum amount allowed by law. Participants who have attained age 50 during a calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans as rollover contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers thirty-three separate accounts and one interest accumulation account as investment options for participants. A participant is eligible for employer contributions if they are age 21 or older. The Company has the option to match contributions as determined on an annual basis. The Company made no employer matching contributions during the years ended September 30, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and rollover contributions, as well as with investment earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Salary reduction contributions, employer matching contributions, rollovers, and income earned thereon are fully vested immediately and cannot be forfeited, even if employment is terminated or an employee becomes ineligible to participate in the Plan.

Loans to Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, excluding designated Roth balances. This maximum is reduced by the greater of the highest total outstanding Plan loan balance in the 12 months immediately before the date of the participant's new loan or the current outstanding loan balances.

Loans to Participants, continued

The loans are issued directly from the general assets of Mutual of America, and the amount borrowed plus a loan reserve of 20% of the loan amount is secured against the participant's vested balance in the Interest Accumulation Account. Loans require at least quarterly payments under a level amortization schedule over a period not exceeding five years, except if obtained for the purpose of purchasing a primary residence, in which case the term is up to ten years. A participant loan is considered delinquent when payments are 90 days past due, at which time the entire principal balance plus interest becomes payable in full. If a loan goes into default, the participant loan will be considered a deemed distribution in accordance with the terms of the Plan document. Total loans outstanding at September 30, 2024 and 2023 were \$8,642 and \$12,925, respectively. The loans are held as an obligation by Mutual of America and are therefore not reflected separately in the Plan's financial statements.

Payment of Benefits

On termination of service due to death, a single lump-sum cash payment or annuity options will be made to the participant's designated beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, an annuity option or a direct rollover to an individual retirement account or to another employer's tax qualified plan. Participants who are age 59 1/2 and still employed by the Company may withdraw all or a portion of their respective account balance.

Hardship Distribution

The Plan permits the withdrawal of a hardship distribution by a participant to satisfy immediate and heavy financial needs. A hardship distribution may be made only for certain needs, including medical expenses, costs related to the purchase of a principal residence, costs to prevent eviction from a principal residence, burial or funeral expenses, expenses for the repair of damage to a participant's personal residence, or certain education expenses for post-secondary education. Furthermore, the distribution cannot be in excess of the amount of the participant's immediate and heavy financial need; and all other distributions, other than hardship distributions currently available under the Plan must have been exhausted. The distribution can be made only from the participant's salary deferrals (including catch-up contributions).

Administration of Plan Assets

Contributions are held and managed by the custodian, who invests cash received, allocates interest and dividend income, and makes distributions to participants. Employees of the Company perform certain administrative functions for the Plan. Such employees do not receive compensation from the Plan. The Plan's third party administrators and custodians maintain individual participants' accounting records. Income is allocated to the participants' accounts on a daily basis. Statements are prepared and sent to all participants quarterly.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles (U.S. GAAP) requires the plan administrator to make estimates and assumptions that affect

certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with U.S. GAAP.

Investments held by a defined contribution plan are required to be reported at fair value. Contract value is the relevant measurement for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan has no fully benefit-responsive investment contracts at September 30, 2024 and 2023.

Investment Valuation and Income Recognition

Investments are reported at fair value. The market values for guaranteed interest accounts represents contract value adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates. The market values for separate accounts represent the Plan's pro-rata interest in the net assets of each investment and are based on the fair value of the underlying assets. These investments are not publicly traded on national security market exchanges, and may be valued differently than if readily available markets existed for such investments. Management is responsible for the fair value measurement of investments reported in the financial statements and believes that the reported values are reasonable. Investment return consists of the Plan's distributive share of any interest, dividends, capital gains and losses, generated from investments, as well as the change in fair value of the investments. Gains and losses attributable to investments are realized and reported upon a sale or disposition of the investments. Unrealized gains and losses are included in the change in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Plan administration fees are paid from the assets of the Plan to the extent permitted. Expenses may be allocated among all Plan participants or charged directly against individual account balances. Fees charged directly to individual account balances include general recordkeeping fees and expenses related to processing distributions or loans, qualified domestic relations orders, and directing the investment of the participants' account balance.

Note 3: Fair Value Measurement

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. U.S. GAAP establishes a fair value hierarchy that prioritizes investments based on the assumptions market participants would use when pricing an asset. The fair value hierarchy gives the highest priority to quoted prices in active markets (observable inputs) and the lowest priority to an entity's assumptions (unobservable inputs). The Plan groups assets at fair value in three levels based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value.

These levels are:

Level 1 Unadjusted quoted market prices for identical assets or liabilities in active markets as of the measurement date.

Level 2 Other observable inputs, either directly or indirectly, including:

- Quoted prices for similar assets/liabilities in active markets;
- Quoted prices for identical or similar assets in non-active markets;
- Inputs other than quoted prices that are observable for the asset/liability; and,
- Inputs that are derived principally from or corroborated by other observable market data.

Level 3 Unobservable inputs that cannot be corroborated by observable market data.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, an investment's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. These classifications (Level 1, 2 and 3) are intended to reflect the observability of inputs used in the valuation of investments and are not necessarily an indication of risk or liquidity.

Market price is affected by a number of factors, including the type of instrument and the characteristics specific to the instrument, as well as the effects of market, interest and credit risk. Instruments with readily available active quoted prices or for which fair value can be measured from actively quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value. Note 5: Tax Status

The 403(b) Thrift Plan of Griffith Centers for Children, Inc. has been informed by its contract administrator that the 403(b) plan is designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since its adoption. The Company is of the opinion that the Plan is currently being operated and fulfills the applicable requirements of a qualified plan. Accordingly, no provision for federal or state taxes has been provided.

Note 5: Tax Status, continued

The Plan is required to report uncertain tax positions. After evaluating the tax positions taken, none are considered to be uncertain; therefore, no amounts have been recognized as of September 30, 2024 and 2023. If incurred, interest and penalties associated with uncertain tax positions would be recorded in the period assessed as other operating expenses. No interest or penalties have been assessed as of September 30, 2024 and 2023. The Plan files Form 5500, and the three previous tax years remain subject to examination.

Note 6: Related Party and Related Parties-in-Interest

Investment products and plan administrative services were provided by Mutual of America Life Insurance Company, a Mutual of America Company, and Mutual of America. Transactions with Mutual of America Life Insurance Company and Mutual of America qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amount to \$2,548 for the year ended September 30, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules in ERISA.

The Plan Administrator is an independent contractor for the Company who provides administrative services to the Plan. These services include, but are not limited to, maintaining plan records, processing contributions, calculating distributions, and ensuring compliance with ERISA and IRS regulations. The Plan Administrator is compensated by the Plan Sponsor and does not receive compensation directly from Plan assets. While the Plan Administrator is not compensated by the Plan's assets, they are considered a party-in-interest under the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Transactions with parties-in-interest, unless exempted by ERISA, are required to be disclosed. The Plan has evaluated the services provided by the Plan Administrator and determined that the services are necessary for the Plan's operation and are provided at reasonable compensation for such services. This disclosure ensures transparency about the relationship between the plan administrator and the 401(k) plan, fulfilling ERISA requirements despite the administrator's contract status and compensation source.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

For the year ended September 30, 2024, The Plan's sponsor-maintained bond coverage in the amount of \$250,000.
