INDEPENDENT AUDITORS' REPORT

To the Trustee
Evergreen Healthcare Partners, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Evergreen Healthcare Partners, Inc. 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Evergreen Healthcare Partners, Inc. 401(k) Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through June 20, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Evergreen Healthcare Partners, Inc. is the plan sponsor/employer and the plan administrator. MAP Retirement, Inc. is the third party administrator and performs various compliance tests as tax counsel. John Hancock Life Insurance Company (U.S.A.) ("John Hancock") is the investment agent that maintains investment and participant records and is the custodian of plan assets. Park Capital is the plan's investment advisor. An officer of Evergreen Healthcare Partners, Inc. is the plan trustee.

Investments - The plan sponsor/employer determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Participants should refer to the investment account summaries and prospectuses for more information.

At the end of each business day, John Hancock determines the fair value of the investments held in its sub-accounts and allocates the fair value to the participants. Earnings on the John Hancock sub-accounts, including investments bought, sold or held during the years, are reflected in the statements of changes in net assets available for benefits.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

John Hancock sub-accounts - The sub-accounts are valued at the net asset value ("NAV"). The NAV is generally based on the fair value of the underlying investments held by the sub-account less its liabilities. The NAV, as provided by John Hancock, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the sub-account will sell the investment for an amount different than the reported NAV.

- (a) The objective of these funds is to seek current income and capital appreciation using a risk profile that is consistent with the target date of the funds.
- (b) The objective of these funds is to provide for capital appreciation and/or income consistent with the risk and return of the fund type summarized above. These funds utilize various U.S. and foreign equity market segments to accomplish their objectives.

2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan documents for more complete information.

General - The plan was adopted effective September 1, 2017 by the employer for the benefit of eligible employees. The plan is a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible to participate in the plan and receive employer matching contributions immediately following commencement of employment. An employee can enter the plan on the first day of the month following the employee's date of hire.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferrals.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. A matching contribution may be made at the employer's discretion in conjunction with each pay period. The discretionary matching contribution percentage was equal to 100% of the first 6% of employee's compensation contributed to the plan as elective deferral contributions up to a maximum of \$5,000 per year for 2024 and 2023.
- d. Additional qualified nonelective contributions may be made at the employer's discretion. There were no such contributions made in 2024 and 2023.

Participant accounts - Earnings, including the fair value appreciation or depreciation, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of the employer's contributions. Participants are allowed to transfer funds between the various investment options daily. Participants can change their deferral percentage monthly. Participants can stop making contributions at any time.

Vesting - Participants begin vesting in the employer contributions and related earnings upon two full years of service, at which time they are 100% vested. Upon death, disability or attainment of normal retirement age (defined as 59½), participants become 100% vested. Participants are always 100% vested in their elective deferral contributions, rollover contributions, and related earnings.

Payment of benefits - Benefit payments are recorded when paid and may commence upon termination of employment, death, disability, or retirement. Distributions are generally made in the form of a single lump sum payment. In-service withdrawals can commence upon attaining the age of 59½. Hardship withdrawals are permitted under certain circumstances.

Administrative expenses - Certain administrative expenses of the plan are paid by the employer. Certain other administrative expenses are paid directly from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution fees and nonparticipant directed charges for service, administrative and advisory fees. Nonparticipant directed charges are allocated to the participants on an account value basis.

Forfeitures - Forfeited nonvested amounts, which are held in a cash account, are used to reduce employer contributions. Forfeitures used to reduce employer contributions were \$103,000 and \$137,000 in 2024 and 2023. Unapplied forfeitures were \$14,500 and \$2,500 as of December 31, 2024 and 2023.

Notes receivable from participants - Loans to participants are not permitted under the plan.

3. PARTY-IN-INTEREST TRANSACTIONS

The plan investments are managed by John Hancock. John Hancock provides certain administrative services to the plan pursuant to a services agreement between the plan sponsor and John Hancock. John Hancock receives indirect compensation from mutual fund service providers for services John Hancock provides to the funds. This indirect compensation is credited and used to offset certain amounts that would otherwise be owed by the plan to John Hancock for its administrative services to the plan. John Hancock is the investment agent as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions. Direct fees paid to John Hancock by the plan, included as a component of administrative expenses in the accompanying financial statements, were \$52,000 in 2024 and \$45,000 in 2023.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and related earnings.

5. INCOME TAX STATUS

The plan adopted a pre-approved CCH Incorporated volume submitter plan. The pre-approved CCH Incorporated volume submitter plan received its most recent favorable opinion on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) if the plan has taken any uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are no audits in progress.
