INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Tri-City Electric Company of Iowa Profit Sharing 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tri-City Electric Company of Iowa Profit Sharing 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis of Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements, as a whole, are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter

NOTE 1 — PLAN DESCRIPTION

The following brief description of the Tri-City Electric Company of Iowa Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement (Agreement) for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers substantially all non-bargaining unit employees of Tri-City Electric Company of Iowa (the Company) who are age twenty-one or older. Entry into the Plan occurs on the 1st day of each calendar month following an employee meeting the eligibility requirements. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Company has contracted with Empower Annuity Insurance Company of America, formerly Great-West Life & Annuity Insurance, and Empower Trust Company, LLC, formerly Great-West Trust Company, LLC, (collectively, Empower) to hold the Plan's assets and execute investment transactions. The Company also utilizes Empower Annuity Insurance Company of America to provide recordkeeping services on behalf of the Plan.

Contributions

Participants may contribute up to 100% of compensation, as defined by the Plan, subject to Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other qualified plans. The Company may make discretionary matching and profit-sharing contributions. To be eligible for Company contributions, participants must have completed at least one (1) year of eligible service. Profit-sharing contributions of \$878,847 were made to the Plan for the year ended September 30, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, an allocation of the Company's discretionary profit-sharing contribution, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Agreement. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company contribution portions of their accounts, plus earnings thereon, is based on years of continuous service. A participant vests at a rate of 20% per year after one (1) year and is 100% vested after six (6) years of continuous service.

NOTE 1 — PLAN DESCRIPTION (Continued)

Notes Receivable from Participants

Participants may borrow from their account up to a maximum of 50% of their vested account balance or \$50,000, whichever is less. The notes receivable from participants are secured by the balance in the participant's account and bear a reasonable interest rate. There is no limit to the number of loans outstanding at any one time. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants outstanding at September 30, 2024 bear interest at rates ranging from 4.25% to 9.50% and mature between December 2024 and January 2033.

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or be paid in installments. In-service withdrawals of a participant's entire vested account balance is available upon reaching the age of 59 1/2.

Forfeitures

Forfeited accounts can be used to pay Plan expenses and to offset future Company contributions. Unused forfeitures as of September 30, 2024 and 2023 were \$36,342 and \$26,878, respectively. Forfeitures of \$13,621 were used to offset Plan expenses during the year ended September 30, 2024.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accrued benefits of all participants shall be distributed to participants as provided in the Agreement.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's investments in mutual funds and common collective trusts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of the fair value measurements.

The Plan invests in a guaranteed interest account (GIA), which is valued at contract value based on the underlying value of the account's group annuity contract. In the event that the underlying agreements in the Plan's investments in fully benefit-responsive investment contracts are fully or partially terminated, participants will receive the liquidation value instead of the contract value. The Plan Administrator does not anticipate the full or partial termination of such agreements in the foreseeable future. See Note 5 for discussion of the GIA.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance, plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of September 30, 2024 or 2023.

Contributions

Contributions from participants are recorded in the year in which they are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Other expenses related to the Plan are paid by the Company and excluded from the Plan's financial statements. Certain investment-related expenses are included within net appreciation in fair value of investments.

NOTE 4 — FAIR VALUE MEASUREMENTS

GAAP establishes a three-tier fair value hierarchy, which categorizes the inputs used in measuring fair value. These categories include (in descending order of priority): Level 1, defined as observable inputs such as quoted prices in active markets for identical assets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring the Plan to develop its own assumptions. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Mutual funds: Valued based on quoted prices of identical assets in active markets.

Collective trust funds: The fair value of units are valued at net asset value, determined using available market information of the underlying securities including quoted prices for identical or similar securities in active or nonactive markets, similar to a mutual fund. These redemption values are the values at which a participant would transact on a daily basis. There are no restrictions on a participant's ability to transact with the funds at net asset value. Redemptions initiated by the Plan sponsor may be subject to a five-day notice. The trusts may withhold payment on any distribution or withdrawal to the extent necessary to meet liquidity demands or to otherwise reduce or eliminate the potential for an unfair result or adverse impact on the trusts.

NOTE 5 — GUARANTEED INTEREST ACCOUNT

The Plan is a party to a fully benefit-responsive GIA with Massachusetts Mutual Life Insurance Company (MassMutual). The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. MassMutual is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The rate was 2.45% at September 30, 2024 and 2023. Because the GIA is fully benefit-responsive, contract value is the relevant measurement for that portion of the net assets available for Plan benefits and is presented on the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The GIA balance was \$999,615 and \$2,280,328 at September 30, 2024 and 2023, respectively.

NOTE 6 — INCOME TAX STATUS

The Plan was created from a prototype plan developed by Dyatech, LLC. The IRS has issued an opinion letter, dated June 30, 2020, that the prototype plan is qualified, and the trust established under the Plan is tax-exempt under Section 401(a) of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC under the prototype.
