### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Opportunity Alliance 403(b) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).
- The information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### 1. Description of Plan

The following description of the Opportunity Alliance 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan sponsored by The Opportunity Alliance (Organization).

All employees are eligible to participate in the Plan upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

A participant may elect to make pre-tax and Roth deferral contributions to the Plan up to 100% of compensation or the Internal Revenue Service (IRS) limit, whichever is lower. The matching contribution is discretionary. The Organization contributes 50% of the first 8% of employee deferrals contributed to the Plan for participants who have completed one year of service. Participants are immediately vested in their salary deferral contributions. Participants are fully vested in their match contributions after four years of service.

Participant and employer contributions may be invested by the participant in any of the available investment options.

#### Plan Termination

Although it has not expressed any intention to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in the matching contribution portion of their account.

#### Expenses

Administrative expenses paid by the Plan are primarily fees for third-party record-keeping services, investment management and advisor fees, and contract administrative fees. The Organization pays all other fees of the Plan, which are excluded from these financial statements.

### 2. Summary of Significant Accounting Policies

#### Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investments Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for disclosures of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

### **Subsequent Events**

Management has considered transactions or events occurring through July 11, 2025, which is the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### **3. Information Certified by Custodians**

The Plan's investments and notes receivable from participants as of December 31, 2024 and 2023, and net appreciation in fair value of investments and investment and notes receivables from participants interest income for the year ended December 31, 2024, were obtained by management and agreed to or derived from the information certified by Mutual of America Life Insurance Company and Empower Annuity Insurance Company, the custodians of the Plan. This information is included in the following:

### **4. Investment Contract with Insurance Company**

The Plan invests in a Empower Annuity Insurance Company (Empower) guaranteed interest fund. Empower maintains the contributions in a general account. The guaranteed interest fund is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As a general account product offered through the group annuity contract, participant principal and interest are fully guaranteed by the entire general account assets of Empower. There are no reserves against fair value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a pooled basis and is stated as an effective annual rate. Such interest rate is reviewed quarterly for resetting. The average crediting interest rate was approximately 1.91% and 1.73% in 2024 and 2023, respectively.

#### 5. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for the identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued based on quoted market prices of shares held by the Plan at year-end.

*Pooled separate accounts:* Valued at the underlying net asset value of units held by the Plan at year-end. The net asset value is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments in the accounts. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 6. Income Tax Status

The IRS has determined and informed HUB International New England (the Plan's third-party administrator) by letter, dated September 1, 2017, that the volume submitter plan is designed in accordance with Section 403(b) of the Internal Revenue Code (IRC) and the regulations issued thereunder. The plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

#### 7. Party-in-Interest Transactions

Plan investments include mutual funds, pooled separate accounts and fixed income contracts managed by Empower, the primary custodian.

The Plan receives money from certain investment vehicles which is then paid to the investment advisor, this totaled \$39,011 in 2024. The Plan also paid \$10,870 in contract administrative fees, \$5,283 for investment management services, and \$22,354 in recordkeeping fees during 2024. These transactions qualify as party-in-interest transactions.

#### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
