## REPORT OF INDEPENDENT AUDITORS

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Westminster Village North, Inc. 403(b) Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**1. DESCRIPTION OF THE PLAN**

The following description of the Westminster Village North, Inc. 403(b) Pension Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Westminster Village North, Inc. (the Plan Sponsor). Employees are eligible to participate in the Plan upon hire. Participation is voluntary. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is a group annuity contract that has a fixed interest annuity portion and a variable interest annuity portion. The fixed interest annuity earns a guaranteed rate of return established by American United Life Insurance Company (the Custodian of the Plan) and is backed by the Custodian of the Plan's general account fund. The variable interest annuity is divided into investment accounts that invest in shares of specific funds or fund portfolios through pooled separate accounts.

Contributions and Funding Policy

Participants may authorize pre-tax and/or post-tax deferral contributions for a maximum allowed by regulations. Effective February 1, 2018, new employees of the Plan Sponsor will automatically elect to withhold 3% of eligible compensation each payroll period, unless the employee selects otherwise. In addition, participants who started contributing to the Plan through automatic enrollment will have an annual increase of the automatic deferral percentage by 1% at January 1, up to 6% of eligible compensation, unless the participant instructs otherwise.

Participants are generally eligible to receive employer matching contributions upon completion of one year of service for which a participant is credited with 1,000 hours of service during a plan year. The Plan Sponsor matches participant deferrals each pay period with a discretionary contribution based on a percentage of eligible compensation determined by the Plan Sponsor's Board of Directors.

Participants direct the investment of deferral and employer contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contribution, allocations of employer matching contribution and plan earnings (net of certain fund management expenses). Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

The Plan provides that participant's deferral contributions are fully vested immediately at the participant's effective date of participation.

Effective February 12, 2016, the vesting schedule of the employer matching contributions is as follows:

For all participants hired prior to February 12, 2016, employer matching contributions are 100% vested. This includes employer matching contributions made subsequent to February 12, 2016 for all participants hired prior to February 12, 2016.

After termination of employment, the non-vested portion of a participant's account is called a forfeiture and remains in the Plan to reduce future employer matching contributions. During 2024 approximately \$15,000 of forfeitures were used to offset employer matching contributions. As of September 30, 2024 and 2023, forfeited non-vested accounts approximated \$500 and \$-0-, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance, whichever is less. Loan terms shall not exceed 5 years except in the case of the purchase of a primary residence. The loans are generally secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan Sponsor. Principal and interest are paid ratably through payroll deductions or as a lump sum. As of September 30, 2024 and 2023, the Plan had participant loans outstanding that totaled approximately \$146,000 and \$158,000, respectively. As of September 30, 2024 the individual loan balances ranged from approximately \$2 to \$10,000 and bear interest at a 5.50% rate. The loans are due through 2048.

Payment of Benefits

In general, on termination of service a participant may elect to receive their vested interest in the form of a lump-sum amount, an account rollover, an annuity or leave the account in the Plan, subject to a certain limitations and conditions as defined by the Plan.

Expenses of the Plan

The Plan Sponsor pays certain expenses of the Plan, including accounting and other administrative fees.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**2. SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan Sponsor provides certain administrative and accounting services to the Plan at no cost. Certain administrative expenses are paid by the Plan or the Plan Sponsor at the Plan Sponsor's discretion. Administrative expenses incurred by the Plan include loan fees charged directly to the participants' accounts and investment management fees that are netted against investment returns.

Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is July 14, 2025.

**3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Prosperity Investments, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants information reflected on the accompanying statements of net assets available for benefits as of September 30, 2024 and 2023, the schedule of assets at September 30, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended September 30, 2024.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). However, in accordance with Subtopic 820-10, the pooled separate account investments that are measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. There have been no changes in the methodologies used as of September 30, 2024 and 2023.

**5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds an investment contract that is a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contract because this is the amount to be received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contract
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan Sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

**6. PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under the DOL's Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Transactions with parties-in-interest include administrative fees paid to the Custodian of the Plan, notes receivable from participants and auditing fees paid to Blue & Co., LLC. Certain expenses of the Plan are paid by the Plan Sponsor. The Plan held party-in-interest investments with the Custodian of the Plan as of September 30, 2024 and 2023. The Plan invests in various funds of the Custodian of the Plan and receives advisor services from Shepherd Financial Investment Advisory, LLC. The Plan Sponsor provides certain administrative services at no cost to the Plan including accounting fees. These expenses qualify as party-in-interest transactions.

**7. INCOME TAX STATUS**

The Internal Revenue Service has established a program to issue opinion and advisory letters for certain prototype and volume submitter 403(b) plans effective June 28, 2013. Although the plan document has not yet been submitted under the program, the Plan Sponsor believes that the plan document currently satisfies the requirements under the program. Furthermore, the Plan Sponsor believes that the Plan was designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**9. SUBSEQUENT EVENT**

Subsequent to year end, the Plan Sponsor approved a resolution to terminate the Plan. Subsequent to the termination, no contributions were allowed, and participant balances were distributed as directed by the participants. Final payments of benefits were determined based on all participants being 100% vested and were made as soon as possible after the termination date.
