**Note 1 – Description of the Plan:**

The following description of the Kaley Group, Inc./KRSM Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan covering substantially all employees of Kaley Group, Inc. (the “Company”) who are age 21 or older and have completed 3 consecutive months of eligible service. This Plan is subject to the provisions of the Employee Retirement Income Act of 1974 (ERISA).

***Contributions***

Each year, participants may elect to contribute up to the maximum limit established by tax laws. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of all contributions into various investment options offered by the Plan. The Company’s contribution consists of a safe harbor non-elective contribution equal to 100% of participant’s elective deferrals, up to a maximum of 3% plus 50% of deferrals between 3-5% of compensation. To receive this contribution an eligible participant must be 21 years old and have completed one year of eligible service during which 1,000 hours of services were completed. A discretionary contribution may be made to the Plan by the Company annually, no additional contributions were made for the year ended September 30, 2024. Contributions are subject to certain Internal Revenue Service “IRS” limitations.

***Participant Accounts***

Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Company’s safe harbor contribution, (b) Plan earnings, (c) forfeitures of terminated participants’ non-vested accounts and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

***Vesting***

Participants are vested immediately in their contributions, Company safe harbor contributions, and rollover contributions. Vesting in any Company discretionary non-elective contributions is based on years of continuous service. A participant is 100% vested after three years of credited service.

**Note 1 – Description of the Plan (Continued):**

***Notes Receivable to Participants***

Participants may borrow from their accounts at a minimum of \$1,000 up to 50% of their vested account balance to a maximum of \$50,000. A participant is only permitted to have one outstanding loan at any time. The loans are secured by the balance in the participant's account and bear interest at a rate that is consistent with approved market rates. Principal and interest are paid through payroll deductions.

***Payment of Benefits***

On termination of service due to death, disability or retirement, a participant or a designated beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

***Forfeited Accounts***

At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$22,812 and \$27,749. These accounts can be used to restore participant accounts, reduce Company contributions, or pay Plan expenses. Also for the year ended September 30, 2024, \$6,278 were used to pay Plan expenses.

**Note 2 – Summary of Significant Accounting Policies:**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Note 2 – Summary of Significant Accounting Policies (Continued):**

***Contributions***

Contributions from Plan participants and the contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation and for which participant compensation is earned.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as benefits paid to participants in accordance with the terms of the plan document. No allowance for credit losses has been recorded as of September 30, 2024 and 2023.

***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

***Payment of Benefits***

Benefits are recorded when paid.

***Reclassification***

The Plan's policy is to reclassify amounts reported in prior year financial statements when necessary for classifications adopted during the current year.

***Consideration of Subsequent Events***

For the year ended September 30, 2024 the Plan has evaluated subsequent events for potential recognition and disclosure through July 11, 2025, the date the financial statements were available to be issued.

**Note 3 – Certified Investments:**

Certified information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at September 30, 2024 and 2023 and net appreciation in fair value of investments, interest, interest income on notes receivable from participants, and dividends for the year ended September 30, 2024, was obtained or derived from information supplied to the plan administrator and certified as completed and accurate by Capital Bank and Trust Company, the custodian of the Plan.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 4 – Fair Value Measurements:**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2- Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a brief description of the valuation methodologies used for assets measured at fair value, except for those measured and reporting using NAV. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Mutual Funds – Are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund – is an investment contract issued in a common collective trust fund (CCT). The fund is valued using the net asset value (“NAV”) practical expedient provided by the administrator of the trust. The NAV is based on the value of the underlying assets by the trust, minus its liabilities, then divided by the number of shares outstanding. The CCT is comprised primarily of passive funds that provide for daily liquidity for the various plan options. Participant-directed purchases and sales are transacted at the NAV.

Money Market Funds – Are public investment vehicles using \$1 for the net asset value (“NAV”).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 – Related Party Transaction and Party-in-Interest Transactions:**

Plan investments are managed by Capital Bank and Trust. Capital Bank and Trust is the custodian for the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred by the investment management services are reported on the statement of changes in net assets available for benefits as administrative expenses. These transactions qualify as party-in-interest transactions. Additionally, the Plan issues loans to participants, which are secured by the participant's account balance. These transactions qualify as party-in-interest transactions.

**Note 6 – Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their entire account balance.

**Note 7 – Tax Status:**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America (U.S. GAAP) require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 – Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
