Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the United Way of Tarrant County 403(b) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statement of net assets as of September 29, 2024 (in Liquidation) and the statement of net assets available for benefits as of December 31, 2023 (Ongoing), and the related statement of changes in net assets for the period from January 1, 2024 to September 29, 2024 (in Liquidation) and the statement of changes in net assets available for benefits for the year ended December 31, 2023 (Ongoing), and the related notes to the financial statements (the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from qualified institutions as of September 29, 2024 and December 31, 2023 and for the period from January 1, 2024 to September 29, 2024, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient, appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements may have been affected by these conditions.

Further, as described in Note C to the financial statements, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets for the period from January 1, 2024 to September 29, 2024 (in Liquidation) and statement of net assets available for benefits for the year ended December 31, 2023 (Ongoing). The amounts of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America ("GAAP") require that these accounts and the related income and distributions be included in the accompanying financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient, appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Plan Termination and Liquidation Basis of Accounting

As discussed in the notes to the financial statements, the Plan was terminated effective January 1, 2024. The Plan was fully liquidated as of September 29, 2024. As a result, the Plan's 2024 financial statements have been prepared using the liquidation basis of accounting. Our opinion is not modified with respect to the matter.

NOTES TO FINANCIAL STATEMENTS

September 29, 2024 (in Liquidation) and December 31, 2023 (Ongoing)

A. Description of the Plan

General

The following brief description of the United Way of Tarrant County 403(b) Plan (the “Plan”) is provided for general information purposes only. The Plan is sponsored by United Way of Tarrant County (the “Organization”). Participants should refer to the Plan document for more complete information. The Organization’s corporate offices are located in Fort Worth, Texas.

The Plan was effective November 1, 2003, restated most recently effective January 1, 2020, and is a defined contribution plan available to all employees of the Organization. Eligible employees may enter the Plan on the first day of the month following the date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The purpose of the Plan is to encourage the Organization’s employees to save and invest, systematically, a portion of their current compensation so that they and their families may have a source of additional income upon their retirement, or in the event of death.

The Plan was terminated with an effective date of January 1, 2024. The Plan was fully liquidated as of September 29, 2024.

Contributions

Effective December 17, 2023, the Organization discontinued allowing employee contributions. Prior to this date, participants could contribute up to 100% of pre-tax annual compensation, as defined by the Plan. Participants could designate all or a portion of their elective deferrals as after-tax Roth contributions. Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code (the “Code”) as defined in the Plan document. Eligible participants could have made rollover contributions to the Plan.

Participants who were eligible to make salary deferral contributions under the Plan and who had attained age 50 before the close of the year could have made catch-up contributions in accordance with, and subject to, the limitations imposed by the Code.

The Organization matched every dollar contributed by each eligible participant, up to a maximum of four percent of participants’ eligible compensation. In addition, eligible participants received an additional match equal to four percent of eligible compensation for the year, regardless of whether or not participants made contributions to the Plan. Participants must have been: (1) at least 21 years old, and (2) completed one year or 1,000 hours of service to be eligible to receive these contributions.

A. Description of the Plan – continued

Participant Accounts

Each participant’s account was credited with the participant’s contributions and allocations of: (a) the Organization’s contributions and (b) Plan earnings. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that could be provided from the participant’s vested account.

Vesting

In connection with the Plan termination, all participants became 100% vested in their accounts as of the termination date. Prior to this, participants were immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer contribution portion of accounts, plus actual earnings thereon, were as follows:

In the event of disability, early retirement, or death, participants became fully vested.

Notes Receivable from Participants

Prior to the Plan termination, participants could borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balances. Loan terms ranged up to five years. The loans were secured by the balance in the participant’s account and bore interest at a rate commensurate with local prevailing rates as determined by the Organization. As of December 31, 2023, interest rates ranged from 3.25% to 8.50%. There were no notes receivable from participants as of September 29, 2024. Principal and interest were paid ratably through payroll deductions or installments paid directly to the custodians in accordance with the note receivable amortization schedule. Participant loans are classified as notes receivable from participants in the Plan’s financial statements.

Benefit Payments

Participants withdrawing during the year for reasons of service or disability, retirement, death, or termination are entitled to their vested account balances. Benefits are distributed in the form of rollovers or lump-sum payments. If withdrawing participants are not entitled to their entire account balances, the amounts not received are forfeited.

A. Description of the Plan – continued

Benefit Payments – continued

Prior to the Plan termination, certain in-service withdrawals were allowed. A participant could also elect to withdraw all or a portion of his/her vested account balance while employed after reaching age 59 ½. A participant could receive a hardship distribution from salary reduction contributions if the distribution was: (1) on account of uninsured medical expenses incurred by the participant, his/her spouse, or dependents; (2) to purchase (excluding mortgage payments) a principal residence of the participant; (3) for the payment of post-secondary tuition expenses; (4) needed to prevent eviction of the participant from his/her principal residence or foreclosure upon the mortgage of the participant's principal residence; (5) payments for burial or funeral expenses for the participant's parent, spouse, children, or dependents; or (6) expenses for the repair of damage to the participant's principal residence.

The Plan's hardship withdrawal provisions were updated in connection with the Bipartisan Budget Act. Participants no longer (1) were required to obtain a loan prior to requesting a hardship withdrawal; (2) participant deferral contributions were no longer be suspended after receipt of a hardship withdrawal; and (3) earnings on elective deferral contributions in a participant's account were included as part of a hardship withdrawal. The reasons for heavy financial need were also expanded to include certain disaster events and casualty losses not associated with disasters.

Forfeitures

Forfeited balances of terminated participants' non-vested accounts may be used to offset employer matching contributions and non-elective contributions for the year or to pay administrative expenses. Forfeitures of approximately \$15,000 were used to pay administrative expenses during the period from January 1, 2024 to September 29, 2024. For the year ended December 31, 2023, approximately \$13,000 in forfeitures were used to reduce employer contributions. There were no significant unallocated forfeitures at September 29, 2024 and December 31, 2023.

Investment Options

Prior to the Plan termination, upon enrollment in the Plan, a participant could direct his/her salary deferrals in 1% increments into any of the Plan's investment options.

Plan Expenses

Employees of the Organization perform certain administrative functions with no compensation from the Plan. In accordance with Plan provisions, the Organization or the Plan can pay Plan expenses. During 2024 and 2023, the Organization paid all of the administrative expenses on behalf of the Plan, with the exception of amounts paid for participant fees, loan set-up and maintenance fees, overnight fees, short-term, and annual fees, which are paid by the participants.

B. Summary of Significant Accounting Policies

Basis of Accounting

As discussed in Note A, on January 1, 2024, the Plan was effectively terminated and, as a result, the Plan has changed its basis of accounting from the accrual (ongoing) basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include expected income and costs of the disposal of assets and other costs expected to be incurred during the liquidation process. All assets of the Plan were fully liquidated as of September 29, 2024.

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Contributions

Contributions from the Organization and participants are accrued as they become obligations of the Organization, as determined by the plan administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

Investment Valuation and Income

The investments of the Plan are stated at fair value as of the end of the period (except for the fully benefit-responsive investment contract) and are subject to market or credit risks customarily associated with equity investments. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and requires disclosures about assets and liabilities measured at fair value. See Note D for information related to the Plan’s valuation methodologies.

Investment gains and losses are accounted for using the average cost basis of the securities sold. The net realized and unrealized gains and losses on investments include realized gains and losses on sales of investments during the period and unrealized increases or decreases in the market value of investments held at the end of each period. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are recorded at the unpaid principal balance.

Payment of Benefits

Benefits are recorded when paid.

Recently Adopted Accounting Pronouncements

The Plan adopted Accounting Standards Update No. 2013-07, *Presentation of Financial Statements – Liquidation Basis of Accounting*, which provides clarifying guidance for the liquidation basis of accounting, effective January 1, 2024. The adoption did not have a material effect on the financial statements, other than adding additional disclosures regarding the Plan's termination and related liquidation of Plan assets for the period from January 1, 2024 to September 29, 2024.

C. Excluded Investments and Activity

The Plan has excluded from investments in the accompanying financial statements certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded from the accompanying financial statements. The amounts of these excluded annuity and custodial accounts and the related income and distributions are not determinable. GAAP requires these accounts and the related income and distributions to be included in the accompanying financial statements.

D. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a three-tier hierarchy that is used to identify assets and liabilities measured at fair value. The hierarchy focuses on the inputs used to measure fair value and requires that the lowest level input be used. The three levels defined in GAAP are as follows:

- Level 1 — observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets.
- Level 2 — observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.
- Level 3 — inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

D. Fair Value Measurements – continued

Described below are the methodologies used to measure each major category of investment. There have been no changes in the methodologies used at September 29, 2024 or December 31, 2023.

- *Mutual of America mutual funds* – Mutual funds held by Mutual of America Life Insurance Company are registered with the Securities and Exchange Commission and are carried at the net asset value (“NAV”). Inputs used for valuing securities are not an indication of the risk associated with investing in those securities. These mutual funds are not publicly traded. The mutual funds are within an insurance contract and are privately held but operate like a publicly traded fund. All of the mutual funds are contained in a pooled separate account. As such, management has categorized the investments as Level 2 within the fair value hierarchy. There are no significant redemption restrictions on these investments at NAV.
- *Principal mutual funds* – Mutual funds held by Principal Trust Company are valued at the published NAV of shares held by the Plan and are classified within Level 1 of the valuation hierarchy.
- *Mutual of America General Account* – The Mutual of America General Account (the “General Account”) assets are invested in the Mutual of America Interest Accumulation account, which is an insurance company general account. The General Account is credited with a contractual rate of return. The General Account is valued at contract value (book value) which approximates fair value. Below are additional characteristics of the General Account:
 - There are no front- or back-end charges; therefore investments in the General Account are completely liquid;
 - The interest rate credited to investments in the General Account is a current rate and is not dependent upon the length of time the assets are invested with Mutual of America Life Insurance Company (the custodian);
 - Requests for withdrawal can be made at any time and are processed on the day that they are received; they are not dependent on the Organization having to liquidate securities in order to generate a payment;
 - The value shown on the pension fund report is the redeemable value of the fund; there are no deferred sales charges, load assessments, or interest rate adjustments that would affect the value as a result of a withdrawal request; and
 - Mutual of America’s investment committee sets the interest rate.

Management has categorized the General Account investment as Level 2 within the fair value hierarchy.

These items are classified in their entirety based on the lowest priority level of input that is significant to the fair value measurement. The assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the placement of assets and liabilities within the levels of the fair value hierarchy.

E. Fully Benefit-Responsive Investment Contract

The Plan holds a traditional guaranteed investment contract through a group annuity contract supported by the general assets of Principal Life Insurance Company. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The interest rate credited to participants ranged from 1.55% to 1.75% for the period from January 1, 2024 through September 29, 2024 and for the year ended December 31, 2023.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also limit the ability of the Plan to transact at contract value with the participants.

F. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at September 29, 2024 and December 31, 2023, and net realized and unrealized gains on investments, interest and dividends, and interest income from notes receivable from participants for the period from January 1, 2024 to September 29, 2024 and for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company and Principal Life Insurance Company, (the trustees of the Plan).

G. Tax Status

The Organization most recently restated the Plan, effective January 1, 2020, by adopting the Principal Life Insurance Company Prototype Non-standardized 403(b) Plan (the “Principal Prototype”). The Principal Prototype obtained an opinion letter dated March 31, 2017, in which the Internal Revenue Service (“IRS”) concluded that employers adopting the plan may rely on the letter with respect to qualification of the plan under Section 403(b) of the Code.

The Plan may rely on this letter with respect to the qualification of the Plan under Code Section 403(b) with certain limitations. The Plan has been amended since receiving the advisory letter.

Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The plan administrator believes that the Plan is operating in accordance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related custodial accounts and tax-deferred annuities were tax exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of September 29, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

H. Plan Termination

The Plan was terminated with an effective date of January 1, 2024, at which time all amounts credited to participants’ accounts became 100% vested. Participants were permitted to take a lump-sum distribution paid to them or to an eligible retirement plan through a direct rollover. Participants who do not elect to take a distribution had their balances distributed by the plan administrator in accordance with the Plan document. The participant account balances were fully distributed as of September 29, 2024.

I. Parties-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

The Plan invested in shares of mutual funds and the General Account managed by Mutual of America Life Insurance Company, as well as in an investment contract managed by Principal Trust Company. Mutual of America Life Insurance Company and Principal Trust Company act as custodians for only those investments as defined by the Plan. Transactions in such investments, as well as notes receivable from participants, qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.

J. Risks and Uncertainties

The Plan invested in various investment securities prior to liquidation. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, prior to liquidation, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

K. Subsequent Events

In preparing the accompanying financial statements, management of the Organization has evaluated all subsequent events and transactions for potential recognition or disclosure through July 14, 2025, the date the financial statements were available for issuance.
