Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Nelson - Jameson, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Nelson - Jameson, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS
SEPTEMBER 30, 2024 AND 2023

NOTE 1 - Description of Plan

The following description of the Nelson – Jameson, Inc. Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan, as adopted effective January 1, 1990, covering all full-time employees of Nelson – Jameson, Inc., and its subsidiaries, Kaestner, LLC and Next Logistics, Inc. (collectively referred to as the “Company”), who have attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions - Participants may elect to contribute a portion of their compensation to the Plan, not to exceed the amount allowed by the Internal Revenue Service (“IRS”). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently has automatic enrollment upon meeting eligibility requirements for employees who are not participating in the Plan, except for employees who have affirmatively elected in writing not to participate. For the year ended September 30, 2023, and for the period October 1, 2023, to December 31, 2023, the automatic enrollment feature provides that, unless elected otherwise by the employee, 6% of the employee’s compensation will be contributed to the Plan as a salary deferral. For the period January 1, 2024, to September 30, 2024, the automatic enrollment feature provides that, unless elected otherwise by the employee, 8% of the employee’s compensation will be contributed to the Plan as a salary deferral. Employees contributing via the automatic enrollment feature will have their deferral percentage increased annually by 1% until they reach a deferral percentage of 10%.

The Company may make a discretionary matching contribution to the Plan, to be determined annually. For the year ended September 30, 2023, and for the period October 1, 2023, to December 31, 2023, the Company contributed 50% of the first 6% of salary reduction contributions that a participant contributed to the Plan. For the period January 1, 2024, to September 30, 2024, the Company contributed 50% of the first 8% of salary reduction contributions that a participant contributed to the Plan. Additionally, the Company may also make discretionary profit-sharing contributions. Participants who worked 1,000 hours and are employed on the last day of the Plan year will share in the discretionary profit-sharing contributions based on relative compensation.

Participant Accounts - Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s discretionary matching contribution, (b) the Company’s discretionary profit-sharing contribution, and (c) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the remainder of their accounts is based on years of credited service. A participant is 100 percent vested after three years of credited service.

Participant Loans - The Plan includes a provision allowing eligible participants to borrow, from their fund accounts, a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participants may not have more than three loans outstanding at one time. Loan terms are limited to five years, except loans for the purchase of a primary residence which may exceed the five-year term. The loans are secured by the balance in the participant’s account and bear interest at a rate determined by the Plan Administrator. The Plan Administrator shall take into consideration rates currently being charged by commercial lenders for loans of comparable risk on similar terms and for similar durations, so that the interest will provide a return commensurate with rates currently charged by commercial lenders for loans made under similar circumstances. Interest rates range from 3.25 to 8.50 percent. Principal and interest are paid ratably through payroll deductions.

NOTE 1 - Description of Plan - Continued

Payments of Benefits - Upon death, termination of service, or obtaining retirement age, participants with an account balance exceeding \$5,000 may elect to receive the value of their vested account balance in either a lump-sum distribution, a rollover, a series of substantially equal periodic installment not to exceed the participant's life expectancy, or partial withdrawals, as described in the Plan's provisions. Participant accounts with an account balance up to \$1,000 are paid in a lump-sum as soon as feasible. Participant accounts with a value greater than \$1,000 (including amounts attributable to rollover contributions) and not exceeding \$5,000 will be directly rolled over into an individual retirement plan designated by the Plan Administrator, unless the participant elects to have the distribution paid directly (in a direct rollover) to an eligible retirement plan.

Administrative Expenses - All administrative expenses may be paid out of the Plan unless paid by the Company. For the years ended September 30, 2024 and 2023, expenses were paid by both the Plan and the Company.

Forfeited Accounts - Nonvested portions of participants' accounts will be forfeited upon termination of employment. Upon rehire, a participant's account balance may be reinstated under certain circumstances. Dollars forfeited due to terminations of employment will be used to reduce future employer discretionary matching contributions or to pay administrative expenses of the Plan. At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$10,286 and \$3,021, respectively. During the years ended September 30, 2024 and 2023, discretionary matching contributions or administrative expenses were reduced by \$0 and \$0, respectively.

NOTE 2 - Summary of Significant Accounting Policies

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements and supplemental schedule is as follows:

Basis of Accounting and Presentation - The financial statements of the Plan are prepared using the accrual method of accounting and are presented in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) as codified by the Financial Accounting Standards Board.

Notes Receivable from Participants - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value (except for fully benefit-responsive contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions - Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Use of Estimates - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - The Plan has evaluated subsequent events through July 10, 2025, the date which the financial statements were available to be issued.

NOTE 4 - Fair Value Measurements

The Plan has determined the fair value of certain assets in accordance with the provisions of U.S. GAAP, which provides a framework for measuring fair value under generally accepted accounting principles.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at September 30, 2024 and 2023.

- **Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - Fully Benefit-Responsive Investment Contract

The Plan entered into a fully benefit-responsive investment contract with The Lincoln National Life Insurance Company. The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the fully benefit-responsive investment contract was \$265,222 and \$237,773 at September 30, 2024 and 2023, respectively.

The traditional investment contract held by the Plan is a group fixed annuity contract. The contract issuer is contractually obligated to repay the principal and interest at a specific rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and may not be less than the guaranteed minimum interest rate (may not be less than 0%). The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code.
2. Premature termination of the contract.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

NOTE 6 - Information Certified by the Plan Custodians

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at September 30, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the years ended September 30, 2024 and 2023, was obtained or derived from the information furnished to the Plan administrator and certified as complete and accurate by Principal Life Insurance Company, as of September 30, 2024 and September 30, 2023 and for the period October 1, 2022 to September 30, 2024, and Fidelity Management Trust Company as of September 30, 2024 and September 30, 2023 and for the period December 14, 2022 to September 30, 2024, the custodians of the Plan.

NOTE 7 - Tax Status

The Company became a participating employer in The Principal Life Insurance Co. Prototype Non-Standardized Profit Sharing Plan with CODA effective September 12, 2014, and is relying on its determination letter dated June 30, 2020. The Company became a participating employer in the FMR LLC Non-Standardized Profit Sharing Plan with CODA effective December 14, 2022, and is relying on its determination letter dated June 30, 2020. The Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (the "IRC"). The Plan has been amended since receiving the determination letter. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE 8 - Transactions With Related-Parties and Parties-in-Interest

Certain Plan investments are managed by Fidelity Management Trust Company and Principal Life Insurance Company. Fidelity Management Trust Company and Principal Life Insurance Company are the custodians and recordkeepers for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Fidelity Management Trust Company provides certain administrative services to the Plan pursuant to an agreement between the Company and Fidelity Management Trust Company. Fidelity Management Trust Company receives revenue from providers for services Fidelity Management Trust Company provides. This revenue is used to offset certain amounts owed to Fidelity Management Trust Company for its administrative services to the Plan.

If the revenue received by Fidelity Management Trust Company from service providers exceeds the amount owed, Fidelity Management Trust Company remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. For the Plan years ended September 30, 2024 and 2023, excess revenue was \$1,505 and \$2,048, respectively. The Plan or Plan Sponsor may make a payment to Fidelity Management Trust Company for administrative expenses not covered by revenue sharing.

Fees for professional services rendered to the Plan may be paid for by the Company at its discretion. The Plan invests in certain investments that are managed by the Plan custodian. The Plan allows participants to take out loans against their account balances and those activities are deemed party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

NOTE 9 - Amounts Owed to Participants Withdrawing from the Plan

There were no amounts owed to participants who had elected to withdraw from the Plan but had not been paid as of September 30, 2024 and 2023.

NOTE 10 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 11 - Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.
