NOTE 1: DESCRIPTION OF PLAN

The following description of The Horst Group Profit Sharing and Employee Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Horst Group, Inc., (the "Company" or "Employer") is the sponsor of the Plan.

General

The Plan is a defined contribution plan that is intended to qualify as a profit sharing plan under Section 401(a) of the Internal Revenue Code (IRC) and includes a cash or deferred arrangement that is intended to qualify under IRC Section 401(k). The Plan is maintained for the exclusive benefit of eligible employees and their beneficiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective October 1, 2017, the Plan was amended, making all employees eligible to participate in the Plan upon date of employment. Employees are eligible to receive any Employer matching contributions and become eligible to participate in Employer profit sharing contributions, upon date of employment.

Prior to October 1, 2017, employees were eligible to contribute to the Plan upon completion of two months of service, with the exception of employees subject to prevailing wage rules (see below), who were eligible upon employment, and both classes of employees were eligible to receive any Employer matching contributions upon meeting eligibility requirements. Employees became eligible to participate in Employer profit sharing contributions as of the next enrollment date after one year of eligibility service and at least 1,000 hours of service during the eligibility computation period.

Contributions

Participants may make a pre-tax deferral and/or a Roth contribution up to the maximum amount allowable under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various retirement options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rates set at 6% of eligible compensation, which will increase annually by 1% up to a maximum of 10%. These elective deferral contributions are fully vested and nonforfeitable.

The Company is making matching contributions equal to 20% of employee contributions up to 6% of employee compensation for the Plan year ended September 30, 2024.

The Plan allows prevailing wage contributions to participants who perform services subject to the Services Contract Act, Davis-Bacon Act, or federal, state, or municipal prevailing wage statutes. Excess fringe benefits under prevailing wage statutes are classified as employer contributions. Participants receiving prevailing wage contributions are immediately fully vested in these contributions, and participants receiving these contributions are not subject to any age, service, or condition requirements. Prevailing wage contributions for the Plan year ended September 30, 2024, were \$130,188.

Contributions (Continued)

Additional employer contributions may be made for safe harbor retroactive matching contributions and profit sharing contributions. During the Plan year ended September 30, 2024, safe harbor retroactive matching contributions of \$272,306 were made to the Plan. During the Plan year ended September 30, 2023, safe harbor retroactive matching contributions of \$100,432 were made to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The participant's allocation of the employer's discretionary profit-sharing contribution is based upon the number of points credited to the participant as compared to the aggregate number of points credited to all participants for the period. A participant receives one point for every \$100 of salary/wage, up to a maximum of \$170,000 or 1,700 points, and ten points for each year of service (1,000 hours worked) with no maximum. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested portions of their account balance. Participants may have no more than one loan outstanding at one time. The loans are secured by the vested balance in the participant's account. Interest is charged at rates commensurate with current interest rates charged for loans made under similar circumstances by persons in the business of lending money. The term of the loan cannot exceed five years unless its purpose is to purchase a principal residence. Principal and interest are paid ratably through biweekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, a direct rollover to another retirement plan or individual retirement account, or some combination of cash and direct rollover distributions. Normal retirement age is 65. Participants may also have their benefits paid in substantially equal amounts over a period of time.

Forfeited Accounts

At September 30, 2024 and 2023, forfeited non-vested accounts totaled \$6,807 and \$2,895, respectively. These accounts can be used to reduce future employer contributions or pay down administrative expenses. During the year ended September 30, 2024, \$52,516 of forfeitures were used to reduce employer contributions. During the year ended September 30, 2024, \$352 of forfeitures were used to pay Plan administrative expenses.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts and liabilities and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Plan trustee. See Note 8 for discussion of fair value information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans or outstanding loans existing upon a participant's exit out of the Plan are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan are deducted from participant accounts on a pro-rata basis. Investment-related expenses are included in administrative expenses.

Subsequent Events

Events that occurred subsequent to September 30, 2024, have been evaluated by the Plan through July 14, 2025, which is the date the financial statements were available to be issued.

NOTE 3: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 4: TAX STATUS

The Plan has adopted a prototype document that was restated to comply with various tax law changes. The latest prototype Plan received a favorable opinion letter dated March 31, 2014. Plans that use prototype documents are not required to file for an individual determination letter. Although the Plan has been amended since receiving this determination letter, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

NOTE 5: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6: INFORMATION CERTIFIED BY THE TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at September 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended September 30, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Principal Trust Company ("Principal"), the trustee of the Plan.

NOTE 7: RELATED-PARTY TRANSACTIONS

The Plan invests in shares of mutual funds managed by Principal at September 30, 2024 and 2023. Principal acts as a trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$119,638 for the year ended September 30, 2024.

NOTE 8: FAIR VALUE

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value:

Money market and mutual funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds with the U.S. Securities and Exchange Commission. The mutual funds are required to publish their net asset values and to transact at those prices. The mutual funds held are deemed to be actively traded.

Pooled separate accounts

Valued at net asset value, which is not publicly quoted, but is available to current Plan participants on their online accounts. The investments can be redeemed at the option of the investor of the funds. There are no circumstances noted in which redeemable investments might not be redeemed.

NOTE 9: INVESTMENT CONTRACTS

The Plan invests in the Principal Fixed Income Guaranteed Option contract, of which Principal Trust Company is the custodian. The Principal Fixed Income Guaranteed Option contract guarantees principal and provides a stated crediting rate backed by Principal Life. As a guaranteed insurance contract, this is not an investment, but is a group annuity contract with a guarantee backed by the assets in the multi-billion dollar general account of Principal Life. The general account consists of over 6,600 investments, which include corporate bonds, asset-backed securities, commercial real estate mortgages, government bonds, and short-term cash equivalents.

The contract seeks to provide a conservative foundation for retirement by offering stability of principal, a declared interest rate, and that no transfer charges will apply to participants.

Interest rates are established on the product every six months (on January 1 and July 1). All of the prior-year guaranteed interest balances continue, and another guaranteed rate of interest is set, based upon an asset-weighted average of all underlying guaranteed interest balances.

Participants invested in the contract are notified approximately 30 days prior to the effective date of the interest rate that will be credited to their account.

NOTE 9: INVESTMENT CONTRACTS (Continued)

The contract does have surrender charges if it is terminated by the contract holder or a plan terminates its interest in such contract within certain time periods.

The contract is a fully benefit-responsive investment contract. As described in Note 2, because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract.

Certain events limit the ability of the fund to transact at contract value. Such events include but may not be limited to the following: (1) Plan termination, (2) material adverse change to the provisions of the Plan, and (3) an employer election to withdraw from a contract in order to switch to a different investment provider.

The Plan sponsor is not aware of any circumstances that would limit the ability of the fund to transact at contract value.
