### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of St. Camillus Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the St. Camillus Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Note 1: Description of Plan

The following description of St. Camillus Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a participant-directed defined contribution plan sponsored by a not-for-profit organization, commonly known as a Code Section 403(b) savings plan. St. Camillus Health System, Inc. is the Plan sponsor (the "Sponsor") and is a not-for-profit corporation as described in Section 501(c)(3) of the Internal Revenue Code ("IRC"). The Plan covers eligible employees of the Sponsor and its affiliates. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA, and therefore, provides that participants may choose to direct their contributions and/or all or part of their account balances among the Plan's investment alternatives. All investments are participant-directed.

#### Eligibility

Employees are eligible to participate in the Plan upon hire.

Eligible employees begin receiving discretionary Sponsor contributions coincident with or immediately following attainment of age 18, completion of one year of employment, and 1,000 hours of service.

#### Contributions

Each year, participants may contribute between 1% and 100% of compensation, as defined in the Plan, not to exceed the limits of the Internal Revenue Service ("IRS"). In addition, the Sponsor contributes a discretionary match. For the year ended September 30, 2024, the Sponsor's discretionary matching contribution was equal to 50% of the participant's contribution, not to exceed 5% of participant's eligible compensation.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan also allows for Roth contributions.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Sponsor's contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1: Description of Plan (Continued)

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the Sponsor's contributions are based on years of service as follows:

<i>Years of Service</i>	<b>Vesting %</b>

1 year	20 %
2 years	40 %
3 years	60 %
4 years	80 %
5 years	100 %

A participant's accrued benefit is 100% vested upon a participant's death, total disability, or attainment of normal retirement age 65. Participants are credited with a year of vested service for completing 1,000 or more hours in the Plan year.

#### Notes Receivable from Participants

Participants may borrow from their account balance the lesser of \$50,000 or 50% of the participant's vested account balance. Participants may only have one loan outstanding at any particular time. The loans are secured by the vested balance in the participant's account and bear interest at a fixed rate determined by the Plan Administrator based on prevailing market rates. Interest rates on existing loans ranged between 3.25% and 9.25%. Loans are repaid over various terms. Principal and interest is paid ratably through payroll deductions.

#### Payment of Benefits

Benefits are paid to the participant or beneficiary upon death, disability, hardship, retirement, or termination of employment, up to the amount of the participant's vested account. Benefits may be paid in a lump-sum distribution or installment distributions. The Plan also allows for in-service distributions once a participant has reached the age of 59 ½.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Sponsor before becoming 100% vested in the Sponsor's contributions. These forfeitures may be used to reduce future Sponsor contributions or may be used to pay administrative expenses in accordance with the Plan document. At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$4,454 and \$221, respectively. Forfeitures used to reduce Sponsor contributions in 2024 were \$45,609. No forfeitures were used to reduce administrative expenses in 2024.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value [except for fully benefit-responsive investment contracts ("FBRICs")]. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

The Sponsor can elect to pay or may require Plan participants to pay custodian fees and other Plan costs, including professional services provided to the Plan, which can be allocated proportionately to Plan participants based on their respective account balance or as an equal dollar amount based on the number of Plan participants. Generally, investment-related fees are allocated proportionately to Plan participants based on their respective account balances. Fees and costs paid by the Sponsor are not included in the accompanying financial statements.

#### Subsequent Events

Subsequent events have been evaluated through July 14, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of September 30, 2024 and 2023:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 4: Stable Value Fund

The Plan entered into fully benefit-responsive investment contracts with Lincoln National Life Insurance Company ("LNL"), a subsidiary of Lincoln Financial Group Trust Company. LNL maintains the contributions in a general account. LNL is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value for the stable value fund is derived based on the provisions for the Unallocated Group Fixed Annuity Contract with LNL.

Because the stable value fund is fully benefit-responsive, contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the investment contracts. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on completing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that causes a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The stable value fund, issued through a group annuity contract, does not permit the issuer to terminate the agreements prior to the scheduled maturity date.

### Note 5: Information Certified by Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. The Plan's custodian, Lincoln Financial Group Trust Company, Inc. (the "Custodian"), as of September 30, 2024 and 2023, and for the year ended September 30, 2024, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- (a) Investments as shown in the statements of net assets available for benefits.
- (b) Interest and dividends and net appreciation in fair value of investments as shown in the statement of change in net assets available for benefits.
- (c) Schedule of Assets (Held at End of Year).

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

### **Note 6: Party-In-Interest Transactions**

Plan investments are managed by the Custodian and the third-party administrator, Lincoln Financial Group. The plan also utilizes SageView Advisory Group, LLC ("SageView") for investment advisory services. Transactions with the Custodian, third-party administrator, SageView and notes receivable from participants are party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA. Administrative fees incurred by the plan for services provided by the Custodian were \$47,563 for the year ended December 31, 2024. Fees paid to SageView for investment advisory services were \$22,383 for the year ended December 31, 2024.

### **Note 7: Plan Termination**

Although it has not expressed any intention to do so, the Sponsor has the right to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their Sponsor contributions.

### **Note 8: Tax Status of the Plan**

The Sponsor adopted a nonstandard prototype document with an IRS notification letter dated March 3, 2017, which states the prototype plan document is in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
