### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Comprehensive Decommissioning International 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of September 26, 2024 (liquidated) and December 31, 2023 (in liquidation), and the related statement of changes in net assets available for benefits for the period January 1, 2024 through September 26, 2024 (liquidated), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Comprehensive Decommissioning International 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of September 26, 2024 (liquidated) and December 31, 2023 (in liquidation), and for the period ended September 26, 2024 (liquidated), stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ### **Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting**

As discussed in Note 1 to the financial statements, in December 2022 the Comprehensive Decommissioning International 401(k) Plan's management announced intentions to terminate the Comprehensive Decommissioning International 401(k) Plan and completed the liquidation of plan assets as of September 26, 2024. In accordance with accounting principles generally accepted in the United States of America, the Plan's accompanying financial statements have been prepared using the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3) (C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Comprehensive Decommissioning International 401(k) Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. # **Comprehensive Decommissioning International 401(k) Plan Notes to Financial Statements September 26, 2024 (liquidated) and December 31, 2023 (in liquidation)**

## **1. Description of Plan**

The following description of Comprehensive Decommissioning International 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan was a defined contribution plan established effective March 15, 2019, as restated July 31, 2022. The Plan covered all employees, excluding nonresident aliens, part-time, temporary or seasonal employees, independent contractors, persons paid outside of the payroll system and out-sourced workers, of Comprehensive Decommissioning International, LLC (the "Company"). To receive safe harbor contributions, participants must attain one year of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

### **Plan of Termination and Liquidation Basis of Accounting**

The Company was a joint venture formed by two companies that came to an end on April 30, 2022. As a result of the termination of the joint venture the Company decided on December 22, 2022, to terminate the Plan. The Plan was amended on March 21, 2024 to terminate the Plan effective January 1, 2024.

As of September 26, 2024, all assets were distributed out of the Plan and all participants became 100% vested in all contribution sources, regardless of status or years of vested service.

### **Contributions**

Each year, participants could contribute up to 50% of pretax annual compensation, as defined in the Plan document, for up to the maximum limits of the Internal Revenue Code ("IRC"). Participants could also designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan included an automatic enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants had their deferral rate increase by 1% on the anniversary of their enrollment date until their deferral rate reaches 10%. Additional discretionary amounts could be contributed by the Company at its discretion. For the period January 1, 2024 through September 26, 2024 (liquidated), there were no discretionary contributions to the Plan. Contributions were subject to certain Internal Revenue Service ("IRS") limitations.

### **Participant Accounts**

Each participant's account was credited with the participant's contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings (losses). Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

### **Vesting**

Effective with the Plan's termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service.

### **Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons, a participant could elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance is less than or equal to \$5,000, the amount was automatically distributed in the form of lump sum cash. In addition, the Plan allowed for hardship distributions if certain criteria were met.

# **Comprehensive Decommissioning International 401(k) Plan Notes to Financial Statements September 26, 2024 (liquidated) and December 31, 2023 (in liquidation)**

## **Notes Receivable From Participants**

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate, determined at the time of the note, was set at the reasonable fixed rate of interest to be determined by the loan administrator, as defined. Principal and interest were paid ratably through payroll deductions. Terms ranged up to five years or greater for the purchase of a primary residence. As of September 26, 2024 (liquidated), all participant notes have either been transferred out or repaid in full.

## **Forfeited Accounts**

As of September 26, 2024 (liquidated) and December 31, 2023 (in liquidation), forfeited nonvested accounts totaled \$-0- and \$5,227, respectively. Forfeitures were first used to pay administrative expenses. Remaining forfeitures, if any, could then be used to reduce employer contributions made after the forfeitures were determined. Forfeitures that have not been used to pay administrative expenses or used to reduce employer contributions were allocated as soon administratively feasible. During the period January 1, 2024 through September 26, 2024 (liquidated), plan administrative expenses were reduced by \$5,255, from forfeited nonvested accounts, in accordance with Plan provisions.

## **2. Summary of Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). The Plan has adopted the liquidation basis of accounting due to the termination as described in Note 1.

### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP required management to make estimates and assumptions that affected the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments were reported at fair value or net asset value ("NAV"), which approximated fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determined the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on an accrual basis. Related fees were recorded as administrative expenses and were expensed as incurred.

### **Payment of Benefits**

Benefits were recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in net appreciation in fair value of investments.

### **Subsequent Events**

The Plan's management evaluated events that occurred after September 26, 2024 through July 10, 2025, the date the financial statements were available to be issued. Based on that evaluation, the Plan has determined that no subsequent events have occurred which require disclosure in the financial statements.

**3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

*Level 1* - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of September 26, 2024 (liquidated) and December 31, 2023 (in liquidation).

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Investments Measured at Net Asset Value:* Consisting of common-collective trusts, valued at the NAV of units of a bank collective trust. NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its evaluation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Information Certified by Trustee (Unaudited)**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Principal Trust Company, the Trustee of the Plan, has certified the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of September 26, 2024 (liquidated) and December 31, 2023 (in liquidation) and the related investment activity and interest income on notes receivable from participants reported in the statement of changes in net assets available for benefits for the period January 1, 2024 through September 26, 2024 (liquidated).

**5. Related-Party and Party-in-Interest Transactions**

Certain Plan investments were managed by the trustee, and therefore, these transactions qualified as party-in-interest transactions. Fees incurred by the Plan for the investment management services were included in net appreciation in the fair value of the investment. Additionally, the Plan issued loans to participants, which were secured by the participants' account balances. These transactions qualified as party-in-interest transactions. Certain administrative functions of the Plan were performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

**6. Tax Status**

The Plan adopted a pre-approved plan offered by Principal Life Insurance Company. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust were designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan administrator believes that the Plan is designed, and was operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan was qualified, and the related trust was tax exempt.

Plan management was required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress.

**7. Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
