Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Supermercados Econo, Inc. Savings and Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 - Description of the plan

The following description of Supermercados Econo, Inc. Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on July 1, 2021, as a defined contribution plan, covering all full-time employees of Supermercados Econo, Inc. (the Plan Sponsor), who have three months of service and are age 18 or older, pursuant to the Popular Master Defined Contribution Retirement Plan document. Effective July 1, 2021, the Plan Sponsor adopted the Popular Master Defined Contribution Retirement Plan Master Trust (the Master Trust) managed by Banco Popular de Puerto Rico (the Trustee). The Plan is subject to the provisions of the Employee Retirement Income Security of 1974 (ERISA) and Section 1081.01 of the Puerto Rico Internal Revenue Code.

Contributions

Each year, participants may contribute an amount of their compensation not exceeding the maximum deferral specified by local law and those who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan's Sponsor may contribute a discretionary percentage of the amount of the participant's contribution.

Participant accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and allocations of: (a) the Plan Sponsor's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses unless paid by the Plan Sponsor. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements – (Continued)

Note 1 - Description of the plan – (continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contributions portion of their accounts plus earnings thereon is based on years of continuous service as follows:

Investment options

The Plan Sponsor and participant's contributions are invested in various investment funds provided by the Trustee, as permitted in the Plan Agreement.

Notes receivable from participants

Notes receivable from participants are not permitted.

Excess participant's contribution payable

Participants at times may contribute excess contributions to the Plan. Such contributions have been historically reimbursed to the participants. Excess contributions are recorded as a liability in the statements of net asset available for benefits and as a reduction of participant-directed contributions for the year.

Qualified non-elective contribution

Rather than refund contributions to the highly compensated employees' group, the U.S. Internal Revenue Service allows an employer to make an additional contribution to the non-highly compensated employees group to help pass the discrimination test. This contribution is called qualified non-elective contribution. This contribution must be 100% vested and is subject to the withdrawal restrictions applicable to salary deferrals.

Note 1 - Description of the plan – (continued)

Payment of benefits

Upon termination of service due to death, disability or retirement, a participant or the participant beneficiaries may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or periodic installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures

Upon a participant's termination from the employment or withdrawal from the Plan for any reason other than death, retirement or disability, the employer contributions on behalf of the participants not then vested are forfeited and used first to reduce the Plan's administrative expenses and then to reduce future Plan Sponsor's contributions. At December 31, 2024 and 2023, the forfeitures account balance amounted to \$7,250 and \$2,606, respectively.

Administrative expenses

Administrative expenses, unless paid directly by the Plan Sponsor, will be paid from the trust fund and will be charged against participant's accounts.

Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Plan amendment

On February 21, 2023, the Plan Sponsor amended the Plan effective April 1, 2023. The amendments were as follow; exclude leased employees from participating in the plan, the service requirement for new participants was changed from one year of service to three months of service, and the auto-enrollment section was amended to add the automatic enrollment feature, in which all existing eligible employees that currently do not participate in the plan (including those who already elected to opt out) and new eligible employees hired after the effective date of the amendment and that do not otherwise make an election to participate (or not to participate) in the Plan will be automatically enrolled to make a pre-tax contribution of 3% of their compensation commencing with the first payroll period following completion of eligibility requirement of the Plan, unless the new eligible employee elects otherwise.

Note 2 - Summary of significant accounting policies

Basis of accounting and presentation

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) and under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment valuation and income recognition

The Plan's investments consist of its interest in the Master Trust, which is reported at fair value. The fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received.

Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Benefits payable

The Plan accounts for benefits payable in accordance with the guidance provided by the *AICPA Audit and Accounting Guide, Audits of Employee Benefit Plans*. This guidance requires that benefits payable to people who have withdrawn from participation in a defined contribution plan be disclosed in the notes to the financial statements rather than recorded as a liability of the Plan. As of December 31, 2024 and 2023, no benefits payable were owed to the participants.

Note 3 - Information certified by the trustee (unaudited)

The plan administrator has elected the method of compliance permitted by Section 103(a)(3)(C) of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information in the accompanying financial statements and ERISA required supplemental schedules related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation /depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by Banco Popular de Puerto Rico, a qualified institution.

Note 4 - Interest in the Master Trust

The Plan's investment consists of its interest in the Master Trust, which was established for the investment of the assets of plans sponsored by those single employers or groups of employers under common control that execute the corresponding adoption agreement. The Plan has a divided interest in the Master Trust. The assets of the Master Trust are held by the Trustee.

The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's specific interest in the Master Trust, plus actual contributions and allocated investment income, less actual distributions and allocated administrative expenses. Total investment income (including net appreciation (depreciation) in the fair value of investments) of the Master Trust is allocated to the Plan based upon the specific investments comprising the Plan's interest in the Master Trust.

Note 5 - Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework, for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active market that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liabilities.
Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used by the Plan for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Plan's interest in the Master Trust that is measured at fair value consists of shares of mutual funds that are valued at the net asset value of the specific shares corresponding to the Plan at year end. Such mutual funds are classified as Level 1.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 - Party-In-Interest Transactions

The Plan’s investment consists of its interest in the Master Trust, which is managed by the Trustee, therefore, these transactions qualify -in- interest transactions.

Note 7 - Non-Discrimination Test

The Plan did not comply with the discrimination test for the years ended December 31, 2024 and 2023. This test requires compliance with a determined percentage of contributions to the Plan as established in Section 1081.01 of the Code. The Plan Sponsor elected to reimburse highly compensated employees for the excess contributions made during the years ended December 31, 2024 and 2023, amounting to \$4,029 and \$25,003, respectively. Excess contributions are recorded as a liability in the accompanying statements of net assets available for benefits. Those participants received their excess contributions in April 2025 and February 2024, respectively.

Note 8 - Tax status

The Plan constitutes a qualified plan exempt from income taxes under the provision of Section 1081.01 of the Internal Revenue Code of Puerto Rico (the Code), as amended.

The Plan obtained its determination letter on August 19, 2024, in which the Commonwealth of Puerto Rico tax authorities stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code.

Management has evaluated the Plan's tax position and concluded that the Plan has maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements.

Note 9 - Subsequent events

The Plan has evaluated subsequent events through June 30, 2025, which is the date these financial statements were available to be issued. Except as disclosed in Note 7, no other events have occurred subsequent to the statement of net assets available for benefits date and to the date the financial statements were available to be issued, that would require additional adjustment to, or disclosure in the financial statements.
