Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of North Canyon Medical Center, Inc. 403(b) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

1. Description of Plan:

The following description of North Canyon Medical Center, Inc. 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined-contribution plan, originally effective March 23, 2008, covering all eligible employees of North Canyon Medical Center, Inc. (the Employer). The Plan has been amended throughout the years to comply with tax legislation. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Employer’s Board of Directors is responsible for oversight of the Plan. The Employer’s Board of Directors is also responsible for determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Eligibility – All employees are immediately eligible to participate in the Plan.

Contributions – Each year, participants may contribute up to 100 percent of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans. The Employer then matches a portion of the amount elected to be deferred, based on the amount determined by the Employer at its discretion. For the year ended September 30, 2024, the Employer matched 100 percent of participant deferrals up to the limits specified below, which are determined using anniversary years of service. The Employer calculates and deposits the match portion per pay period. No additional discretionary contributions were made for the year ended September 30, 2024.

Participant accounts – Each participant’s account is credited with the participant’s contributions and allocations of (a) the Employer’s contribution, (b) the Plan’s earnings and losses, and (c) forfeitures of terminated participants’ nonvested accounts, and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the plan document. Income is allocated daily based on the shares in the participant’s account. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment options – Upon enrollment in the Plan, a participant may direct contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

1. Description of Plan (continued):

Vesting – Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Participants vest in the Employer’s nonelective contribution according to a graduated schedule based on years of service. Participants are 100 percent vested after five years of service.

Forfeited accounts – Forfeited balances from terminated participants are used to reduce future employer contributions or to pay plan expenses.

Benefit payments – Participants may elect to receive (1) a lump-sum amount equal to the value of their vested interest, (2) installments, or (3) annuities as defined in the plan document upon retirement, termination, death, or disability. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions may be made at the participant’s election prior to termination upon attainment of early retirement age 59.5 or hardship as defined in the plan document.

Death benefits – The designated beneficiary is entitled to a death benefit distribution equal to the larger of the participant’s vested account balance or the contributions less withdrawals plus the guaranteed minimum rate.

Plan termination – The plan sponsor may terminate the Plan at any time at its sole discretion. Upon termination, no further contributions will be made to the Plan, and the plan custodian will distribute the plan funds to the plan participants or will transfer the funds to another 403(b) plan, if directed to do so by the plan participants.

2. Summary of Significant Accounting Policies:

Basis of accounting – The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates – The preparation of financial statements in conformity with GAAP requires the plan sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies (continued):

Payment of benefits – Benefit payments to participants are recorded upon distribution.

Administrative expenses – Certain administrative expenses are paid by the plan sponsor as provided in the plan document.

Subsequent events – The plan sponsor has evaluated subsequent events through July 8, 2025, the date on which the financial statements were available to be issued.

3. Fair Value of Investments:

The Financial Accounting Standards Board (FASB) Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at September 30, 2024 and 2023.

Mutual funds – Mutual funds are valued at the net asset value of shares held by the Plan at year end.

3. Fair Value of Investments (continued):

The methods described above may produce a fair value calculation that may not be indicative of net realizable value, or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in fair value levels – The availability of observable market data is monitored to assess the appropriate classifications of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended September 30, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2, or 3.

4. Certification of Investment Information:

Empower Annuity Insurance Company of America (Empower), the custodian of the Plan, has supplied the plan administrator with certifications as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of September 30, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended September 30, 2024, and the supplemental Schedule H, Line 4i – schedule of assets (held at end of year) as of September 30, 2024.

5. Insurance Contract:

The Plan's fully benefit-responsive fixed investment option with Empower Investments is maintained in Empower Investments' general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed interest investment option issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

5. Insurance Contract (continued):

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Empower Investments, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: 1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, or 4) the failure of the plan sponsor to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

6. Related-party and Party-in-interest Transactions:

The following transactions are considered party-in-interest transactions under ERISA regulations, but are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA:

- The plan sponsor provides to the Plan certain accounting and administrative services for which no fees are charged to the Plan. The employees who provide these services also are participants in the Plan.
- Some plan investments are managed by Empower. Empower is the custodian as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Empower also manages the individual participant accounts and provides bookkeeping services to the Plan. Fees paid by the Plan for the investment management services were included as a reduction of the return earned on each fund. In addition, \$92,158 and \$72,513 was paid for other services rendered for the years ended September 30, 2024 and 2023, respectively.
- The plan auditor performs the required annual audit of the Plan.

7. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investments will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Plan Tax Status:

The plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the IRC to maintain the exclusion from tax for plan participants. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements. The plan administrator intends to apply for a determination letter on the Plan when the government opens such a program.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.
