### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Community Hospital Association, Inc. 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ### 1. Plan Description

---

The following brief description of the Community Hospital Association, Inc. 403(b) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Community Hospital Association, Inc. (the Association).

Employees become eligible to make salary deferral contributions and to receive discretionary matching contributions upon employment. Participants who have completed one year of service are also eligible to receive discretionary non-elective contributions if they are 21 years of age and credited with 1,000 hours of service during the Plan year.

#### **Contributions**

Each year, participants may contribute a portion of their annual pre-tax compensation in accordance with the provisions of the Plan, up to the maximum amounts allowable by law. Effective January 1, 2024, the Plan also allows participants to designate a portion or all their elective contributions as designated Roth after-tax contributions. The Association may also make discretionary matching and non-elective contributions. Participants may also contribute amounts representing distributions from other qualified plans.

All participants who are eligible to make deferral contributions and who will attain age 50 before the end of the calendar year are eligible to make catch-up contributions. Contributions are subject to certain limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of a) the Association's discretionary matching and non-elective contributions and b) Plan earnings or losses. Discretionary matching contributions are allocated among participants based upon each participant's elected salary deferral. Discretionary non-elective contributions are allocated to participants based upon compensation of eligible participants. Plan earnings or losses are allocated on the basis of actual results of investments held in participant accounts. Investments are maintained in individual member accounts managed by American United Life Insurance Company (American United Life).

#### **Vesting**

Employees are vested immediately in their contributions plus actual earnings thereon, and are 100% vested in the Association's contributions after three years of credited service.

### ***Payment of Benefits***

Upon termination of service, retirement, disability or death, the participant or beneficiary may elect to receive a lump sum payment equal to the value of the participant's vested account. Participant balances between \$1,000 and \$5,000 (\$7,000 effective January 1, 2025) will be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Benefits are recorded when paid.

### ***Forfeitures***

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of the Association's contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to pay Plan expenses or to reduce the Association's contributions. As of December 31, 2024 and 2023, there were \$1,529 and \$1,606 of forfeited, non-vested amounts available, respectively. During 2024 and 2023, forfeitures totaling \$5,359 and \$5,680, respectively, were used to reduce discretionary matching contributions.

## 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis and in conformity with the accounting principles generally accepted in the United States of America.

### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments, except for fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. The Association determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in fully benefit-responsive contracts through unallocated insurance contracts.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

### *Risks and Uncertainties*

The Plan utilizes various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and market risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and, that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Other*

Certain expenses of maintaining the Plan, including audit fees, are paid directly by the Association and are excluded from these financial statements. Other certain expenses specifically incurred by or attributable to individual participants are charged directly to the participant's account and are included in administrative expenses. Investment management expenses are paid by the Plan and included in net appreciation in fair value of investments.

### *Subsequent Events*

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through July 2, 2025. See "Payment of Benefits" section of Note 1 for a description of a subsequent event.

#### 3. Information Certified by American United Life

---

#### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023, except for applying the net asset value (NAV) practical expedient to 2024 and 2023 investment balances.

*Pooled Separate Accounts:* Pooled separate accounts (PSA's) are valued at NAV based on the market value of its underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these PSA's meet those requirements. Participants can redeem the PSA's at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Investment Contracts with Insurance Company

The Plan has entered into investment contracts with American United Life. American United Life maintains the contributions in pooled separate accounts and unallocated insurance contracts. These accounts are credited with the earnings on the underlying investments and assessed for Plan withdrawals and administrative expenses.

The pooled separate accounts, as reported to the Plan by American United Life, are included in the financial statements at fair value, which represents contributions made under the contracts, plus earnings, less withdrawals and administrative expenses.

As the unallocated insurance contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the unallocated insurance contracts. Contract value, as reported to the Plan by American United Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

### 6. Tax Status

---

The Plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The Plan Administrator intends to apply for a determination letter on the Plan when the government opens such program. The Plan is required to operate in conformity with the Code to maintain its tax exemption. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

### 7. Plan Termination

---

Although it has not expressed any intent to do so, the Association has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed as soon as practicable after the termination date.
