Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter – supplemental schedules required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule, that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - PLAN DESCRIPTION

The following brief description of the J. J. Keller & Associates, Inc. Employees' 401(k) Savings and Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

J. J. Keller & Associates, Inc. (the Company) established the Plan on May 1, 1988 to continue its effort to stimulate and reward the efforts of its employees and to encourage their continued service by providing retirement benefits. The Plan is a defined contribution plan covering substantially all employees of the Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

OneAmerica Retirement Services, LLC (OneAmerica) is the Plan record-keeper and Matrix Trust Company (Matrix) is the Plan's trustee.

Contributions

Participants may elect to make contributions to the Plan by deferring pre-tax and/or after-tax compensation, as defined in the Plan document, up to the maximum percentage allowable, not to exceed the limits of the Internal Revenue Code (IRC). All new employees are automatically enrolled at a deferral percentage of 5% until an alternative election is made by the employee. All participants in the Plan will have a 1% annual increase in deferral percentage until a maximum contribution percentage of 10% is reached, unless the participant opts-out of the auto-escalation feature. Each eligible participant may elect to make catch-up contributions to the Plan, as defined in the Plan document.

The Company may make discretionary matching contributions. Prior to January 1, 2024, the Company matched an amount equal to 25% of each participant's deferral contributions (not to exceed 1% of the participant's compensation for the Plan year). Effective January 1, 2024, the Company matched an amount equal to 50% of each participant's deferral contributions (not to exceed 5% of the participant's deferral contributions for the Plan year).

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and an allocation of Plan earnings and losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan's provisions.

Investment Options

Upon enrollment in the Plan, a participant may direct investments consisting of his or her employee contributions and Company contributions, plus actual earnings thereon, in 1% increments in any of the investment options offered by the Plan. Participants may change their investment options daily.

Vesting

Participant contributions to the Plan, including earnings thereon, are 100% vested. Prior to January 1, 2024, participants were immediately 100% vested in employer contributions. Effective January 1, 2024, participants become 100% vested in employer contributions after one year of service.

Participant Benefits

Upon termination of service, participants have the option to receive payment of the vested portion as either lump sum and/or periodic distributions. Any non-vested portion of a terminated participant's account is forfeited. Forfeitures may be used to pay plan expenses or to reduce employer matching contributions. There were no forfeitures used to reduce employer matching contributions for the Plan years ended December 31, 2024 and 2023. The forfeiture account balance was \$16,173 and \$3,630 as of December 31, 2024 and 2023, respectively.

Required minimum distributions are required upon the participant meeting the relevant required minimum distribution age.

NOTE B - SIGNIFICANT ACCOUNTING POLICIES

A summary of the Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

Basis of Accounting

The accounting records of the Plan are maintained and the financial statements are prepared on the accrual basis.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administrative Expenses

The Plan pays certain Plan administrative costs which are expensed when incurred. Other expenses are paid by the Company.

NOTE C - INVESTMENTS

The Plan's investments are held in a trust fund managed by the trustee.

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE D - FAIR VALUE MEASUREMENTS

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Valued at the net asset value (NAV) of shares held by the Plan at year end, which is obtained on an active market.

Collective Trust Fund - Valued at the NAV of units of a bank collective trust. The NAV, as provided by the record-keeper, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - INCOME TAX STATUS

Effective January 1, 2024, the Company is a participating employer in the OneAmerica Financial Partners, Inc. Defined Contribution Pre-Approved Plan, a pre-approved plan approved by the Internal Revenue Service (IRS). The pre-approved plan obtained its latest approval letter on August 19, 2020, in which the IRS stated the plan, as then designed, was qualified under Section 401(a) of the Internal Revenue Code (IRC). The Plan has adopted certain discretionary amendments. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

Prior to January 1, 2024, the Plan had obtained its latest determination letter on March 28, 2014, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan had been amended and restated since receiving the determination letter, the Plan administrator believed that the Plan was currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require

recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by OneAmerica. OneAmerica is the Plan record-keeper as defined by the Plan and, therefore, transactions with OneAmerica qualify as party-in-interest transactions.

The Company pays certain administrative expenses of the Plan.

NOTE H - INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee has certified that the following data included in the financial statements and supplemental schedule is complete and accurate:

- Cash and investments, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023; and
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE I - SUBSEQUENT EVENTS

The Plan evaluated its December 31, 2024 financial statements for subsequent events through July 14, 2025, the date the financial statements were issued. The Plan administrator is not aware of any subsequent events which would require recognition or disclosure in the Plan's financial statements.
