## INDEPENDENT AUDITORS' REPORT

To the Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Glass Gardens, Inc. ## INDEPENDENT AUDITORS' REPORT

**NOTES TO FINANCIAL STATEMENTS**

**Note 1 - Description of the Plan:**

The following description of the Glass Gardens, Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** - The Plan is sponsored by Glass Gardens, Inc. (the “Company” or “Plan Sponsor”) and is a discretionary qualified defined contribution plan subject to the provisions of the Employee Retirement Income Security Act (“ERISA”). All non-union employees who reach age 20 and 1/2 during the plan year are automatically enrolled in the plan year in which they complete one year of service and work at least 1,000 hours. Non-union hourly employees who complete one year of service and work at least 1,000 hours are automatically enrolled at age 18. The Company may elect to contribute an amount, subject to the Internal Revenue Code, (“IRC”) limitations for profit sharing plans.

**Plan Administration** - The Plan is administered by the Plan Sponsor. The Plan’s assets are held by Fidelity Management Trust Company (the “Trustee”), who is responsible for the custody and management of the Plan’s assets.

**Contributions** - The Company may make discretionary contributions to the Plan in which all eligible employees will receive a portion of the Company’s contribution. Such contributions are subject to certain limitations as defined. Participants direct the investment of Company contributions into various investment options offered by the Plan.

**Vesting** - All Company contributions made to the Plan are vested based on number of years of service and are subject to forfeiture. A participant’s interest in the Company’s contributions and earnings thereon vests according to the following:

<u>Completed Years of Service</u>	<u>Percent Vested</u>
Less than 2 years	0%
2 years but less than 3	20%
3 years but less than 4	40%
4 years but less than 5	60%
5 years but less than 6	80%
6 years or more	100%

**Participant Accounts** - Individual accounts are established for each plan participant. Each participant’s account is credited with the allocation of (a) the Company’s contribution and (b) Plan earnings or losses, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested amount.

**Payment of Benefits** - On termination of service due to death, disability or retirement, a participant (or their legal representation) may elect to receive an amount equal to the value of the participant’s vested interest in their account in either a lump-sum or in annual installments as deferred annuity if the participant’s account balance exceeds \$7,000 upon retirement or disability. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution if certain Plan requirements are met. If death occurs prior to retirement, the participant’s account is paid to the designated beneficiary.

***Forfeitures*** - Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may first be used to pay Plan administrative expenses and to reduce the employer's future contributions to the Plan, as directed by the employer. To the extent that forfeitures are not used to reduce administrative expenses under the Plan or to reduce the employer's future contributions to the Plan, forfeitures will be allocated to eligible participants in accordance with the terms of the Plan Document. Forfeited, non-vested amounts totaled \$78,675 and \$203,192 for the years ended September 30, 2024 and 2023, respectively. Forfeitures used to pay administrative expenses and reduce employer contributions totaled \$24,500 and \$52,000 for the year ended September 30, 2024, respectively.

**Note 2 - Summary of Significant Accounting Policies:**

***Basis of Accounting*** - The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates*** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America, requires the Plan administrators to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in net assets available for benefits during the reporting period. Actual results, as determined at a later date, could differ from those estimates.

***Investment Valuation and Income Recognition*** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants*** - Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and benefit payment is recorded.

***Administrative Expenses*** - Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, withdrawals and recordkeeping are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

***Benefits Paid to Participants*** - Benefits paid to participants are recorded at the date they are paid.

***Money Market Fund*** - Includes a money market fund containing highly liquid short-term investments purchased with maturities of three months or less.

**Subsequent Events** - The Plan administrators have reviewed and evaluated all events and transactions from September 30, 2024 through July 14, 2025 the date the financial statements were available to be issued. The effects of those events and transactions that provide additional pertinent information about conditions that existed at the Statements of Net Assets Available for Benefits date have been recognized in the accompanying financial statements.

**Note 3 - Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Company decides to terminate the Plan, plan participants' become fully vested in their accounts. Under no circumstances may the Company take ownership of any of the Plan's assets as a result of such amendment or termination.

**Note 4 - Certified Investment Information:**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Trustee, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- a) Investments, as shown in the Statements of Net Assets Available for Benefits as of September 30, 2024 and 2023.
- b) Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended September 30, 2024.
- c) Investment information included in Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year), as of September 30, 2024, as shown on the ERISA-required supplemental schedule of assets (held at end of year).

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

**Note 5 - Fair Value Measurement:**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements FASB ASC 820, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

- Mutual funds: Valued at the closing price reported in the active market in which the fund is traded.
- Money market fund: Valued at the closing price reported in the active market for similarly traded funds.
- Self-directed brokerage accounts: Contains interest-bearing cash, common stock, and mutual funds. Interest-bearing cash is valued at the closing price of a similarly traded fund in which it is traded. Common stock and mutual funds are valued at the closing price reported on the active market in which they are traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Transfers Between Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended September 30, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2, or 3.

**Note 6 - Risks and Uncertainties and Concentration of Investment Risk:**

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

The Plan may invest in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

The Plan's investment in two funds comprises approximately 27% and 24% of total investments at September 30, 2024 and 2023, respectively.

**Note 7 - Tax Status:**

The Plan was written on an Internal Revenue Service (“IRS”) non-standardized pre-approved document, which obtained its latest opinion letter on June 30, 2020 in which the IRS stated that the Plan as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**Note 8 - Notes Receivable from Participants:**

Participants may obtain loans from the Plan at a minimum of \$1,000 and maximum of 50% of a participant’s account balance, or \$50,000 whichever is less. Loans bear a reasonable interest rate as reflected by local banks and are collateralized by a participant’s account balance. Loans are generally payable through payroll deductions within five years unless it pertains to the purchase of a principal residence in which case loans are payable within ten years.

**Note 9 - Party-in-Interest:**

The Trustee manages the Plan’s investments which include various Fidelity Investment mutual funds. Additional recordkeeping and administrative fees are also charged to the Plan. These investment, recordkeeping, and administrative fees qualify as party-in-interest. Fees paid to the Trustee by the Plan totaled \$10,769 for the year ended September 30, 2024. Furthermore, third-party advisory fees also charged to the Plan totaled \$3,000 for the year ended September 30, 2024.
