### Independent Auditor's Report

To the Trustee and Plan Management

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Prime Materials Recovery, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

### **FOR THE YEARS ENDED SEPTEMBER 30, 2024 AND 2023**

#### **NOTE 1 - DESCRIPTION OF THE PLAN:**

The following description of Prime Materials Recovery, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement and any amendments thereto, for a more complete description of the Plan's provisions.

##### **General:**

The Plan was adopted October 1, 2002 as a 401(k) plan. The Plan is a multiple employer defined contribution retirement plan covering all eligible employees of Prime Materials Recovery, Inc., IMC-Metals America, LLC, Fluoropolymer Resources, LLC, Allied Metals, LLC, Fluorogistx CT, LLC, G&S Metals, LLC, and Ames Copper Group, LLC (collectively, the "Company") who are age 21 or older and who have completed 3 months of service with the Company, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan's trustee is responsible for the oversight of the Plan. The trustee and plan management determine the appropriateness of the Plan's investment offerings and monitor investment performance.

##### **Contributions:**

Each year, participants may contribute up to 100% of their pretax compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees or rehires employed on or after October 1, 2015 are automatically enrolled in the Plan after 3 months unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated target date fund until changed by the participant. The Plan currently offers a variety of mutual funds and a guaranteed investment contract as investment options for participants. The Plan also provides for a 50% match in contributions up to 6% of the qualifying participant's compensation. Additional profit sharing amounts may be contributed at the option of the Company's board of directors. For the plan year ended September 30, 2024, the Board of Directors did not elect to make a profit sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

**NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED):**

Participant Accounts:

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All other charges related to the administration of the Plan are paid by the Company.

Vesting:

Participants are immediately vested in their contributions plus earnings thereon. In the event of termination due to death, total and permanent disability or normal retirement, participants shall become 100% vested in the employer contributions portion of their account. For all other participants, vesting in the employer contributions portion of their account is based on credited years of service, as defined in the Plan, according to the following schedule:

Notes Receivable from Participants:

Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance of the participant's account. The loan interest rate is set at 1 percent above the prime rate, as defined. Principal and interest are paid ratably through regular payroll deductions.

#### **NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED):**

##### **Payment of Benefits:**

Upon termination of service for any reason, participants with a vested account balance less than \$1,000 will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants with a vested account balance greater than \$1,000 may defer payment of benefits until a later date.

Participants may apply for a hardship withdrawal, as defined, to meet excessive medical or educational expenses, expenses incurred to either purchase a principal residence or prevent eviction or foreclosure on a participant's principal residence, payment of funeral expenses or expenses to repair a principal residence due to a casualty. The application for the hardship withdrawal must be approved by the plan administrator.

Participants who are at least 59½ years of age may withdraw all or a portion of the balance of their account prior to termination for any reason.

##### **Forfeited Accounts:**

At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$41,937 and \$58,103 respectively. Any forfeited nonvested employer contribution sourced amounts can be applied to pay administrative expenses of the Plan or used to reduce future employer contributions. During the plan year ended September 30, 2024, employer contributions were reduced by \$39,976 from forfeited nonvested accounts.

#### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

##### **Basis of Accounting:**

The accompanying financial statements have been prepared using the accrual method of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):**

##### Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investment Valuation and Income Recognition:

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### Excess Contributions Payable:

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants subsequent to the Plan years ended September 30, 2024 and 2023.

##### Payment of Benefits:

Benefits paid to participants are recorded when paid.

##### Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in investment income.

##### Subsequent Events:

Management has evaluated subsequent events through July 14, 2025, the date which the financial statements were available to be issued.

#### **NOTE 3 - FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT:**

The Plan maintains a traditional fully benefit-responsive investment contract with Empower Annuity Insurance Company of America ("EAIC"). The balance in the traditional investment contract was \$328,309 and \$768,643 as of September 30, 2024 and 2023, respectively. EAIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay principal at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer, but may not be less than zero. The crediting rate is reviewed on a quarterly basis for resetting. The average interest rate credited to the Plan was 1.38% and 1.16% for the years ended September 30, 2024 and 2023, respectively. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary), (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

#### **NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:**

The Plan's investments in mutual funds and the Key Guaranteed Portfolio Fund are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively "Empower"). Empower is custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The Plan allows participants to take loans against their account balances, which are also considered exempt party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

#### **NOTE 7 - PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

#### **NOTE 8 - TAX STATUS:**

The IRS has determined and informed the Company by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 9 - RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the Statements of Net Assets Available for Benefits.

**NOTE 10 - NON-EXEMPT TRANSACTIONS:**

As reported on the supplemental schedule of delinquent participant contributions (Schedule H, Line 4a), certain Plan contributions were not remitted to the custodian within the time frame specified by the Department of Labor's Regulation 29 (CFR 2510.3-102), thus constituting nonexempt transactions between the Plan and the Company for the fiscal year ended September 30, 2024. During 2025, the Plan sponsor remitted the delinquent contributions, plus lost earnings, to the Plan.
