Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Lynn University Defined Contribution Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Lynn University Defined Contribution Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering employees of Lynn University (the “Employer” or “Organization”). All permissible employees of the Organization, as defined in accordance with the universal availability standards, are eligible to enroll on their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Employees are immediately eligible to defer a portion of their eligible compensation, as defined, into the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Participants age 50 or older or that have 15 years of service are allowed to make catch-up contributions, as defined in the Plan.

Participants are eligible to receive employer contributions after completing one year of eligible service and attaining age 21.

Effective January 1, 2023, the Plan was amended to increase the amount the Organization will contribute. In addition to the 2% of base compensation which the Organization contributes to eligible participants as a nonelective contribution, after January 1, 2023 the Organization will contribute base compensation between 3% and 5% provided that the participant makes an elective deferral that ranges from 5% to 7% of his or her base compensation to the Plan, respectively. Regardless of the participant’s deferral percentage there will be no Employer match above 7% of Participant deferrals. Contributions are subject to certain Internal Revenue Code (the “IRC”) limitations.

Participant Investment Account Options

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan invests in insurance contracts issued by Teachers Insurance and Annuity Association of America (“TIAA”) and College Retirement Equities Fund (“CREF”), various mutual funds and a real estate separate account.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Organization’s contributions and (b) Plan earnings and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting

All participants benefits are 100% vested from the first day of enrollment in the Plan.

Assets Pledged as Collateral

Until December 31, 2021, TIAA permitted participants to obtain loans directly from TIAA. These loans are no longer offered effective January 1, 2022. The minimum amount of a loan was \$1,000 and the maximum was the lesser of \$50,000, or 1) 45% of the participant's combined TIAA accumulation attributable to this Plan; or 2) 90% of the participant's TIAA Traditional Annuity account. Plan loans were issued directly from the funds owned by TIAA, and loan proceeds were not removed from a participant's account balance. However, a portion of the participant's account balance was reserved, or held in collateral, to cover 110% of the outstanding loan amount for the period of time the loan is outstanding. See Note 5 for discussion of the Traditional Annuity. At December 31, 2024 and 2023, participants had outstanding Plan loan balances due to TIAA of \$44,241 and \$110,556, respectively. These loans were collateralized by Traditional Annuity account balances of \$48,664 and \$121,612 as of December 31, 2024 and 2023, respectively. These amounts are included in the Traditional Annuity account balances reported in the accompanying statements of net assets available for benefits. Interest expense is offset by the income received by the participants on the collateralized annuity contracts.

During 2024, accumulations totaling \$48,193 were used to satisfy Plan loan defaults, which have been recorded as distributions in the accompanying statement of changes in net assets available for benefits.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to the lesser of 50% of the participant's vested account balance, or \$50,000. Loan terms must not be less than one year and not greater than five years unless the loan principal is used for the acquisition of a primary residence in this case not more than 10 years. A participant can have three loan(s) currently outstanding from the Plan. The loans are secured by the vested balance in the participant's account and bear interest at the Wall Street Journal Prime Rate plus 1.00%. Principal and interest are paid ratably to TIAA. The outstanding loans as of December 31, 2024 had maturity dates ranging from January 2025 to November 2029. Interest rates on notes receivable from participants were 4.25% - 9.50% and 4.25% - 9.50% for the years ended December 31, 2024 and 2023, respectively.

Payment of Benefits

Upon termination, retirement, disability or death, a participant or beneficiary receives the entire amount credited to the participant's account in either a single sum or, at the discretion of the participant's election, in installments. The participant's account may also be used to purchase an annuity contract. The Plan does provide for in-service distributions for either hardship reasons or when a participant reaches the age of 59 ½. The Plan complies with the minimum distribution requirements of Internal Revenue Service Code Subsection 401(a)(9).

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments, other than fully benefit responsive investment contracts, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative and Investment Management Expenses

Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in net investment income reported by the Plan.

NOTE 3 - CERTIFIED INFORMATION

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. TIAA and CREF are insurance carriers regulated, supervised and subject to periodic examinations. As such, TIAA and CREF certify the Plan investments and related investment activity for the Plan's investments issued by TIAA and/or CREF, respectively. This certification also extends to those investments, if any, which TIAA Trust, N.A., a national trust bank, held as a directed trustee or custodian that were record kept by TIAA for the years ending December 31, 2024 and 2023, respectively:

- Investments, at fair value and contract value and notes receivable from participants, as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year), as of December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- Level 1 - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2 - Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 - Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value.

- *Mutual Funds*: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).
- *Registered Investment Companies*: The fair values of accumulation units held by the Plan in registered investment companies held as variable annuity accounts are based on each account's daily net asset value ("NAV"), which is considered by Plan management to be the best approximation of fair value. Variable annuity accounts are not exchange traded. Data for NAVs, are available daily to plan administrators and client investors on National Association of Securities Dealers Automated Quotations website, and provide sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources.
- *Pooled Separate Account*: The fair value of the Plan's interest in the TIAA Real Estate Account (a pooled separate account) is on the fund's daily NAV, which is considered by Plan management to be the best approximation of fair value. The unit value of the fund is calculated daily and available to plan administrators and client investors on NASDAQ's website. Underlying holdings are primarily valued using independent appraisals or independent pricing sources. Although the underlying assets of the fund cannot be quickly sold and converted to liquid assets, the TIAA general account provides the fund with a liquidity guarantee whereby TIAA ensures that the fund has funds available to meet participant redemption, transfer or cash withdrawal requests.
- *Guaranteed interest accounts*: Investments in non-benefit-responsive Traditional Annuity contracts are reported at contract value, which approximates fair value. As these investments are contract-based, observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs (Level 3). The contract value equals the accumulated cash contributions, interest credited to the plan's contracts, and less transfer in (if any), less any withdrawals and transfer out (if any). Contract value is deemed to approximate fair value for Retirement Choice ("RC"), Retirement Annuity ("RA") contracts based on observation of recent participant investments at contract value and by comparison of historical and current yields of highly

rated long-term corporate bonds to historical and current crediting interest rates of the contracts, taking into consideration the liquidity restrictions applicable to the contracts. See also Note 5 for discussion of the annuities.

The interest rate ranges were RA: 3.65% - 6.50% and RC: 3.90% - 6.75% as of December 31, 2024 and RA: 4.00% - 6.75% and RC: 4.25% - 7.00% as of December 31, 2023.

NOTE 5 - TIAA TRADITIONAL ANNUITY

The TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to Plan participants. Each contract is fully unconditionally guaranteed by TIAA. The TIAA Traditional Annuity is offered through following contracts: RC; RA: Group Supplemental Retirement Annuity ("GSRA"); and a Supplemental Retirement Annuity ("SRA"). Participants with RC and RA contracts have certain restrictions over the availability of lump sum withdrawals from the contracts as well as over the number of installments in which participant-initiated transfers and participant initiated withdrawals are made. Based on these provisions, the RC and RA contracts are non-benefit responsive. The GSRA and SRA, as well as holdings reported in the Plan Loan Default Fund on the statement of changes in net assets available for benefits have no liquidity restrictions and are considered to be benefit-responsive. Participants in the Plan hold investments in various contracts through the TIAA Traditional Annuity.

Participants who chose to allocate a portion of their retirement savings to the TIAA Traditional Annuity make contributions that purchase a specific amount of lifetime income based on the contractual rate of interest guaranteed by TIAA's claims paying ability. The TIAA Traditional Annuity also provides an opportunity for participants to receive additional amounts, which the TIAA Board of Trustees may declare on a year by year basis. These additional amounts, when declared, remain in effect for the 12 month "declaration year" that begins each March 1, for accumulating annuities and January 1 for lifetime payout annuities; they are not guaranteed for future years. Together the guaranteed minimum and additional amounts make up the crediting interest rate. The guaranteed minimum interest rate for TIAA Traditional Annuity contracts is 3.00% except for RC which is between 1.00% to 3.00%. The crediting interest rate is 4.50% for GSRA and SRA, 5.25% for RA, and 5.50% for RC for 2024 and crediting interest rate is 6.00% for GSRA and SRA, 6.75% for RA, and 6.50% for RC for 2023.

When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.

There are no conditions specified in any of the contracts under which participant withdrawals and transfers would be restricted or made at a value other than contract value or the annuity or lump-sum benefit, as

defined in the contracts. The contracts do not provide any provisions that would allow the issuer to terminate the contracts between the Issuer and the participants.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan's investments are issued by TIAA and CREF and, therefore, these transactions and the Plan's payment of investment management fees to TIAA and CREF qualify as party-in-interest transactions. TIAA Trust, N.A. acts as the custodian for the mutual funds held by the Plan. Investment management fees and expenses are paid by the Plan to parties-in-interest, which are reflected as a reduction of investment returns recorded by the Plan. The Plan made direct payments to TIAA and CREF related to administrative expenses for the year ended December 31, 2024. Certain expenses are paid by the Plan, and others are paid by the Organization related to the Plan's operations.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 8 - TAX STATUS

The Internal Revenue Service issued an opinion letter dated August 7, 2017, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is designed and is being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through July 10, 2025, which is the date the financial statements were available to be issued.
