## **Note 1. Description of the Plan**

The following brief description of the Hospice of Surry (the “Hospice”) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

### ***General***

The Hospice established the Plan to provide employees with a systematic means of savings and investing for the future. All permissible employees of the Hospice, as defined in accordance with the summary plan description are eligible to enroll on their date of hire. Deferrals begin on the first day of the payroll period subsequent to enrollment. With respect to non-salary reduction contributions, such as employer matching contributions, eligibility occurs when the employee has completed one year of service, has attained age 21, and worked at least 1,000 hours during the plan year. The Plan is a 403(b) defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective October 1, 2019, the Plan began to transition recordkeeping services to Principal Financial Group. As of September 30, 2024 and 2023, there is approximately \$52,000 and \$325,000, respectively, still held by VALIC, which will be distributed over time.

### ***Contributions***

Each year, participants may contribute compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Hospice matches participant contributions, up to 2% of their base compensation. Contributions are subject to certain limitations, as defined by law.

### ***Investment Options***

Upon enrollment in the Plan, participants may direct the investment of their contributions and the Hospice’s contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, a guaranteed investment contract, and group annuity contracts as investments.

### ***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and allocations of the Hospice’s contributions and Plan earnings (losses) and charged with benefit payments and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### ***Payment of Benefits***

On termination of service, a participant may elect to receive an amount equal to the value of the participant’s vested interest in his or her account in either a lump-sum amount or various installment and annuity options as provided by the Plan. Amounts contributed on a before-tax basis may only be withdrawn upon demonstration of financial hardship, disability, or after the participant reaches the age of 59.5 years.

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Hospice's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service according to the following schedule:

Less than 1 year of service	0%
1 but less than 2 years of service	20%
2 but less than 3 years of service	40%
3 but less than 4 years of service	60%
4 but less than 5 years of service	80%
5 or more years of services	100%

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. At September 30, 2024, outstanding loans bore interest rates of 2.50% - 10.50%. Principal and interest are paid ratably through payroll deductions.

***Forfeited Accounts***

At September 30, 2024 and 2023, forfeited non-vested accounts totaled \$485 and \$4, respectively. The balances of forfeited accounts are used by the Hospice to offset part of its future contributions to the Plan. During the year ended September 30, 2024, approximately \$18,128 of the forfeited non-vested accounts balance was used to reduce the employer contribution.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Valuation of Investments***

Investments are reported at fair value, except for group annuity contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Investments in group annuity contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to group annuity contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefits are recorded upon distribution.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Hospice, as provided by the Plan document. Certain administrative functions are performed by employees of the Hospice. No such employee receives compensation from the Plan.

***Subsequent Events***

The Plan has evaluated subsequent events through July 11, 2025, the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1**     Observable inputs such as quoted prices in active markets.
- Level 2**     Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3**     Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at September 30, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

***Mutual funds***

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

**Guaranteed investment contract**

Due to significant unobservable inputs included in the valuation model for the guaranteed investment contract, the resulting fair value of these securities is classified as Level 3. The fair value of the guaranteed investment contract was estimated by the Principal by considering many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the general account.

Level 3 assets measured at fair value on recurring basis for the years ended September 30, 2024 and 2023 and included purchases of \$716 and \$31,736, respectively. Sales for the year ended September 30, 2023 were \$108,125. There were no sales for the year ended September 30, 2024. There were transfers in Level 3 assets of \$20,144 for the year ended September 30, 2024. There were no other issuances or transfers out for the year ended September 30, 2024. There were no issuances and no transfers in and out of Level 3 assets for the year ended September 30, 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Unaudited Information Certified by the Trustees**

The accompanying financial statements include the following unaudited information as of September 30, 2024 and 2023, and for the year ended September 30, 2024, that was obtained from data prepared and certified to be complete and accurate by the Plan's trustees:

**Note 5. Investment Contracts with Insurance Companies**

The Plan has a non-fully benefit-responsive guaranteed investment contract sponsored by Principal Life Insurance Company ("Principal"), the Fixed Income Guarantee Account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative fees. The contract is included in the financial statements at fair value, as reported to the Plan by Principal, totaling \$60,718 and \$39,607 at September 30, 2024 and 2023, respectively. Fair value represents the amount the participant would receive if the contract was terminated at the reporting date, which is contract value less an early withdrawal charge.

The guaranteed investment contract is valued at fair value by Principal, by considering many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the general account. The assumptions and inputs used by the insurance company to determine the value of the contract are not specifically quantified in the information provided to the plan sponsor. Disclosure of unobservable inputs to fair value measurement have not been included for the guaranteed investment contract because quantitative unobservable inputs are not developed by the Plan when measuring fair value and have not been made available to the Plan by the custodian.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The minimum guaranteed interest rate varies by participant and depends on the date the participant established an account.

The Plan has also entered into a group annuity contract with Variable Annuity Life Insurance Company ("VALIC") totaling \$3,082 and \$264,671 at September 30, 2024 and 2023, respectively. VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Contract value, as reported to the Plan by VALIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than one percent. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with group annuity contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) premature termination of the contracts, (4) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (5) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation or (4) a material amendment to the agreements without the consent of the issuer.

**Note 6. Exempt Party-In-Interest Transactions**

Certain plan investments are shares of mutual funds and investment contracts managed by Principal and VALIC. Principal and VALIC are the trustees as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid to the trustees by the Plan for administrative services were \$97,134 for the year ended September 30, 2024.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Hospice has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Hospice may determine.

**Note 8. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan is relying on the IRS approval of the standardized prototype plan that it is utilizing. The IRS has determined and informed the custodian by a letter dated March 31, 2017 that the prototype plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
