### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of Quantum Design International, Inc. Safe Harbor and Retirement 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

### (1) Description of Plan

The following description of the Quantum Design International, Inc. Safe Harbor Match and Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or summary plan description for a more complete description of the Plan's provisions.

#### *General*

The Plan, which was adopted on October 1, 1986, is a defined contribution plan covering substantially all employees of Quantum Design International, Inc., Quantum Design, Inc. and Magnabiosciences, LLC (collectively, the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is administered by the Company’s Investment Committee (“Committee”), which is a committee of the Board of Directors of the Company. The Committee has overall responsibility for the operation, administration and oversight of the Plan. The Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance of the Plan’s investment offerings. Certain officers of the Company serve as the Plan’s trustees.

Effective July 15, 2019, the Plan was amended to change the name of the Plan from Quantum Design International, Inc. Profit Sharing & 401(k) Plan to the Quantum Design International, Inc. Safe Harbor Match and Retirement Plan.

On August 19, 2024, the Company entered into an agreement and plan of merger (“Merger”) with Carlson Private Capital Partners LLC (“CPC”), an unrelated third party. See Note 11.

#### *Eligibility*

Employees, excluding leased employees, who are 21 years of age are eligible to participate in the Plan on the first day of the month coinciding with or next following the date eligibility requirements are satisfied.

#### *Contributions*

Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

*Participant contributions:* Participants may contribute up to 100% of annual compensation as pre-tax or Roth contributions, as defined by the Plan. Additionally, participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Such contributions are 100% vested and non-forfeitable.

### *Contributions, cont'd*

*Participant rollover contributions:* Participants are allowed to make rollover contributions into the Plan of amounts representing distributions from other retirement plans and certain individual retirement accounts (“IRAs”). Such contributions are 100% vested and non-forfeitable.

*Employer safe harbor matching contributions:* A safe harbor 401(k) plan is a plan design where the employer commits to making certain contributions to simplify the administration of the Plan by ensuring that nondiscrimination regulations are met. To maintain “safe harbor” status, the Company has elected to make a safe harbor matching contribution equal to 100% of salary deferrals that do not exceed 5% of the participant’s compensation. To be eligible for safe harbor matching contributions, participants must have attained age 21 and completed one year of service, defined as 1,000 hours of service. Such contributions are 100% vested and non-forfeitable.

*Employer discretionary matching contributions:* The Company may make a discretionary matching contribution equal to a uniform percentage of participant salary deferrals. To be eligible for employer discretionary matching contributions, participants must have attained age 21 and completed one year of service, defined as 1,000 hours of service. For the year ended September 30, 2024, the Company elected not to make a discretionary matching contribution.

*Employer discretionary profit sharing contributions:* The Company may make a discretionary profit sharing contribution, which will be allocated among participants eligible to share in the contribution for the Plan year. To be eligible for employer discretionary profit sharing contributions, participants must have attained age 21, completed one year of service, defined as 1,000 hours of service, and be employed on the last day of the Plan year. For the year ended September 30, 2024, the Company elected make a discretionary profit sharing contribution equal to 5% of the first \$160,200 and 10% of the remaining of the participant’s compensation up to \$330,000.

### *Participant accounts*

Participants direct the investment of their contributions into various investment options offered by the Plan. Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contributions and the Plan’s investment earnings. Allocations are based on participant’s compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### *Vesting*

Participants' contributions, rollover contributions, employer safe harbor matching contributions plus actual earnings thereon are 100% vested immediately. Employer discretionary matching contributions, employer discretionary profit sharing contributions plus actual earnings thereon are subject to the following vesting schedule:

To earn a year of service, a participant must be credited with at least 1,000 hours of service during a plan year, as defined in the Plan document.

### *Forfeitures*

At September 30, 2024 and 2023, forfeited nonvested accounts held by the Plan totaled \$15,536 and \$73,095, respectively. These accounts may be used to pay administrative expenses of the Plan or to reduce employer contributions. During the year ended September 30, 2024, forfeited nonvested accounts totaling \$164,201 were used to pay administrative expenses of the Plan and \$1,449,055 were used to reduce employer contributions.

### *Notes receivable from participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The repayment terms provide for notes to be amortized over a reasonable period of time not to exceed five years. The notes are secured by the balance in the participant's account and bear an interest rate equal to 1% above the prime rate, as defined.

### *Payment of benefits*

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

### *Payment of benefits, cont'd*

The distribution shall be made to the participant or beneficiary in accordance with the election of the participant. Participants may defer receiving these benefits until their normal retirement age if their vested account balance exceeds \$5,000. Participants may also elect to withdraw in cash certain vested amounts within his or her contribution account to the extent necessary to meet a financial hardship, in accordance with the regulations and rulings of the IRC. After the withdrawal, a stipulated period of time must lapse, as defined by the Plan, before a participant can make additional contributions.

### **(2) Summary of Significant Accounting Policies**

#### *Basis of accounting*

The financial statements of the Plan are presented on the accrual basis of accounting.

#### *Use of estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### *Investment valuation and income recognition*

Investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Principal and interest are paid ratably through payroll deductions. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### *Payment of benefits*

Benefits are recorded when paid.

### *Administrative expenses*

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### **(3) Information Certified by the Custodian**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and its subsidiaries, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate with respect to investments:

- Investments at fair value
- Fully benefit-responsive investment contract at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

#### (4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### (5) Investment Contract with Insurance Company

The Plan has a fully benefit-responsive guaranteed investment contract with Massachusetts Mutual Life Insurance Company. Massachusetts Mutual Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting interest rate is reviewed and determined by the contract issuer prior to the last day of the previous calendar quarter. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by Massachusetts Mutual Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

### **(5) Investment Contract with Insurance Company, Cont'd**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merge with another plan), (2) changes to the Plan's prohibition on competing investment options or deleting of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestiture or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemptions under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants. The guaranteed investment contract requires 30-day written notice to terminate the agreement.

### **(6) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

### **(7) Tax Status**

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America requires management of the Plan to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Company has analyzed the tax positions taken by the Plan and has concluded that as of September 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine income tax examinations by taxing jurisdictions; however, there are currently no income tax examinations for any tax periods in process.

### **(8) Party-In-Interest Transactions**

Certain of the Plan assets are invested in shares of mutual funds and units of a guaranteed investment account managed by Massachusetts Mutual Life Insurance Company, an affiliate of Empower Annuity Insurance Company of America who serves as the recordkeeper for the Plan. Members of the Committee are officers of the Company, current participants in the Plan and serve as the Plan's trustees. These transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

### **(9) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **(10) Reconciliation of Financial Statements to Schedule H of Form 5500**

Net assets available for benefits, as reported in the financial statements, are consistent with the amounts reported in Schedule H of the Form 5500.

### **(11) Subsequent events**

Effective October 10, 2024, CPC merged with and into the Company, with the Company continuing as the surviving corporation. In connection with Merger, effective October 10, 2024, participant accounts totaling \$7,804,401 were transferred from the Quantum Design International, Inc. Employee Stock Ownership Plan into the Plan.

The Plan has evaluated subsequent events through July 14, 2025, which is the date the financial statements were available to be issued. No other significant matters were identified for disclosure during this evaluation.
