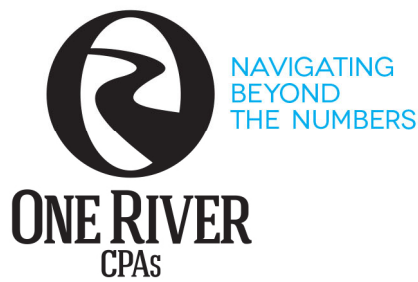

## Independent Auditors' Report

To the 403(b) Thrift Plan for Employees of  
Downeast Community Partners and Participants

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan for Employees of Downeast Community Partners, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 403(b) Thrift Plan for Employees of Downeast Community Partners' financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Notes 3 and 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States

of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of 403(b) Thrift Plan for Employees of Downeast Community Partners and to meet our ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(c) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about 403(b) Thrift Plan for Employees of Downeast Community Partners' ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of 403(b) Thrift Plan for Employees of Downeast Community Partners (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

*General* – Downeast Community Partners (the Organization) established the Plan to provide employees with a systematic means of savings and investing for the future. All permissible employees of the Organization, as defined in accordance with the universal availability standards, are eligible to enroll on their date of hire. Deferrals begin as soon as administratively possible after enrollment, or no later than the first day of the month subsequent to enrollment. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Plan Contributions* – Each year, participants may contribute up to the IRS limit of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts and a guaranteed interest fund, both under a group annuity contract, as investment options for participants. The Organization matches 100% of eligible compensation from 2% up to 8%, depending on the participant's length of service. The Organization may also make qualified nonelective and discretionary contributions. There were no nonelective or discretionary contributions made during the years ended September 30, 2024 and 2023.

*Participant Accounts* – Each participant's account is credited with the participant's contribution, allocations of (a) the Organization's matching contributions, and, (b) Plan earnings (losses). The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

*Vesting* – Participants are immediately vested in their voluntary contributions and become vested over a five-year period for the Organization's qualified nonelective and qualified matching contributions.

*Contract Loans* – Participants may borrow directly from Mutual of America, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the present value of the vested accrued benefit of the Mutual of America Interest Accumulation Account. The participant must pledge sufficient collateral, generally 120% of the principal. The collateral of the loans must be maintained in the Mutual of America Interest Accumulation Account.

The loans are not shown in the Plan's statements of net assets available for benefits as the loans are not made from plan assets and are, therefore, not considered assets of the Plan. Loan interest rates are variable, based on 3% above the Mutual of America Interest Accumulation Account interest rate. Principal and interest are paid ratably through bi-weekly payroll deductions. A default charge will be assessed against the portion of the loan collateral used to foreclose on all or part of any loan.

**NOTE 1 – DESCRIPTION OF THE PLAN, CONTINUED**

*Contract Loans, Continued* – Loan balances outstanding from Mutual of America to the Plan’s participants were \$4,389 and \$16,697 as of September 30, 2024 and 2023, respectively. At September 30, 2024 and 2023, there were no loans to participants in default and subject to repayment from participants’ accounts at the time of distribution.

*Payment of Benefits* – Upon retirement, death, or disability, a participant or beneficiary receives the entire amount credited to the participant’s account in a lump sum. Upon termination, other than by retirement, disability, or death, a participant becomes eligible to receive the current value of the participant’s vested account in a lump sum.

*Forfeited accounts* – Forfeited nonvested accounts are used to reduce employer contributions. During the year ended September 30 2024, employer contributions were reduced by \$13,491 from forfeited nonvested accounts.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting* – The financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

*Use of Estimates* – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of certain assets, liabilities, and disclosures. Accordingly, the actual results may differ from those estimates.

*Investment Valuation and Income Recognition* – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan’s valuation policies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan’s gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits* – Benefits are recorded when paid. At both September 30, 2024 and 2023, there were \$0 of benefits processed and approved for payment, but not paid.

*Expenses* – Certain expenses of maintaining the Plan are paid by the Organization and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

*Subsequent Events* – Subsequent events were evaluated through the report date, which is the date the financial statements were available to be issued.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

*Pooled separate accounts (PSAs):* Units held in PSAs are valued net asset value (NAV) of the fund. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of a pooled separate account is calculated based on a compilation of primarily observable market information as the underlying mutual funds are actively traded.

*Guaranteed investment contracts – Not fully benefit-responsive (NFBR):* Valued by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issues.

**NOTE 4 – GROUP ANNUITY CONTRACTS WITH INSURANCE COMPANIES**

The Plan invests in unallocated guaranteed investment contracts with the Mutual of America Life Insurance Company (MOA) and Voya Retirement Insurance and Annuity Company (Voya). As part of the contracts, MOA and Voya maintain a portion of the contribution in a "general account." The account is credited with earnings on the underlying investments and charged for withdrawals and administrative expenses charged by MOA and Voya. The guaranteed minimum rate of interest is determined annually. Any additional interest is not guaranteed.

**NOTE 4 – GROUP ANNUITY CONTRACTS WITH INSURANCE COMPANIES, CONTINUED**

All guaranteed investment contracts are considered to be not fully benefit-responsive. These contracts are included in the financial statements at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering credit worthiness of the issuer. These contracts are subject to certain withdrawal periods. Upon termination of the contracts, the amount of each transfer payout annuity payment will be determined as of the annuity starting date for the transfer payout annuity by the amount of the General Account's accumulation and the interest rates in the rate schedules under which any premiums, additional amounts, and internal transfers were applied to the account.

**NOTE 5 – CERTIFICATION OF ASSETS**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at September 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended September 30, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company and Voya Retirement Insurance and Annuity Company.

**NOTE 6 – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are in pooled separate accounts containing shares of mutual funds managed by Mutual of America and Voya. Mutual of America and Voya are the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services, included in net appreciation in fair value of investments in the statement of changes in net assets available for benefits, amounted to \$758 for the year ended September 30, 2024.

The Organization provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged.

All of these party-in-interest transactions are exempt from prohibited transaction rules of ERISA.

**NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

**NOTE 8 – INCOME TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the terms of the Plan have been prepared to conform with the requirements of Section 403(b) of the IRC, and is currently being operated in conformity with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

**NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks.
