1. DESCRIPTION OF PLAN

The following description of the Picut Industries, Inc. 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established January 1, 1989 and most recently restated effective April 4, 2022, is a 401(k) plan covering all eligible employees of Picut Industries, Inc. and its affiliates (collectively, “the Company”), except nonresident aliens and employees covered by a collective bargaining agreement.

Employees who have completed 6 months of service and attained 21 years of age are eligible to make elective deferrals into the Plan and receive Company safe harbor matching contributions, discretionary matching contributions, and non-elective contributions. Eligible employees must have completed 1,000 hours of service during the year and be employed on the last day of the year to be eligible to receive non-elective contributions. Employees can enter the Plan on the first day of each month of the Plan year upon satisfying the eligibility requirements. The Plan is a defined contribution plan subject to the provisions of the Employees Retirement Income Security Act of 1974 (“ERISA”).

Contributions

The Plan allows for pre-tax elective deferrals. Effective November 3, 2023, the Plan permits Roth contributions. Participants may contribute up to 100% of annual compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Rollover contributions are subject to the terms of the Plan and are fully vested and non-forfeitable. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment feature under which newly eligible employees are automatically enrolled to make pre-tax contributions into the Plan at a rate of 5% of compensation, and their accounts under the Plan are automatically invested in the Plan’s Qualified Default Investment Alternative (“QDIA”), unless the employee elects otherwise. The Plan has elected Fidelity Advisor Freedom Fund series as its QDIA. The Plan also includes an automatic escalation feature whereby the deferral rate of automatically enrolled participants will increase annually on March 31st by 1% up to a maximum of 10%, unless the employee elects otherwise.

The Company makes safe harbor matching contributions to the Plan equal to 100% of the first 3% of the participant's compensation contributed to the Plan and 50% of the next 2% of the Participant's compensation contributed to the Plan, as defined. For the year ended

December 31, 2024, the Company made \$877,718 of safe harbor matching contributions to the Plan. The Company may elect to make discretionary matching contributions and discretionary non-elective contributions. The Company did not make any discretionary employer matching contributions or non-elective contributions to the Plan during the year ended December 31, 2024. Contributions are subject to certain statutory limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and safe harbor matching contributions, as well as an allocation of the discretionary matching contributions and discretionary non-elective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their participant contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the discretionary non-elective contribution and matching contributions portion of their accounts is based on years of continuous service as follows:

2	50%
3	75%
4 or more	100%

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are secured by the balance in the participant's account. The interest rates on outstanding loans at December 31, 2024 range from 4.25% to 9.50% per annum. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, substantially equal installments or partial payments. Participants shall be entitled to receive in-service withdrawals upon

attainment of age 59 ½ or as a hardship distribution, as defined in the Plan document.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$255 and \$0, respectively. Forfeitures, if any, can be used to reduce employer contributions or pay plan expenses. During the year ended December 31, 2024, no forfeiture accounts were used.

Revenue Credit Program

The Plan's service agreement with Fidelity includes a Revenue Credit Program. The Plan receives a defined percentage of total Plan assets determined based upon average quarterly assets, multiplied by one-quarter, billed and payable quarterly, subject to certain offsets. These amounts may be used to pay administrative expenses of the Plan or allocated to participants in accordance with the service agreement. At December 31, 2024 and 2023, the revenue credit account balance was \$6,487 and \$5,847, respectively. During the year ended December 31, 2024, the Plan used \$9 from the revenue credit account to pay administrative expenses. For the year ended December 31, 2024, the Plan received \$86,064 in revenue credits that were allocated to participants and are included in other income on the statement of changes in net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and employer contributions from the Company are recorded in the year in which the participant contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change in fair value of investments.

3. CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, at fair value, and notes receivable from participants held at December 31, 2024 and 2023, and net change in fair value of investments, interest and dividends, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Fidelity Workplace Services, LLC (“Fidelity”) is the recordkeeper of the Plan and therefore certain transactions qualify as party-in-interest transactions. \$44,617 in administrative fees were paid to Fidelity from the Plan during the year ended December 31, 2024.

OneDigital Investment Advisors LLC is the investment advisor of the Plan, and therefore certain transactions qualify as exempt party-in-interest transactions. Advisor fees of approximately \$74,200 were paid to OneDigital Investment Advisors LLC during the year ended December 31, 2024.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

7. TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been

amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through July 15, 2025, the date the financial statements were available to be issued.
