## INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor and Participants

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements***

We have performed audits of the financial statements of Ross Downing Chevrolet Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ### NOTE 1 – DESCRIPTION OF PLAN

The following description of Ross Downing Chevrolet, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

Effective January 1, 1983, Ross Downing Chevrolet, Inc. (the Company) established the 401(k) Plan. The plan also covers employees of Ross Downing Buick GMC Cadillac LLC; Ross Downing Automotive LLC; and Ross Downing CDJR LLC. The Plan is a defined contribution plan covering all full-time employees of the Company who have one year of service with 1,000 hours worked and are age 21 or older, with an amendment made during the 2024 plan year to waive length of service requirements for new participants acquired during the recent acquisition of Ross Downing CDJR LLC. The plan includes an Eligible Automatic Contribution Arrangement (EACA) but not a Qualified Automatic Contribution Arrangement (QACA). The effective date of participation for an eligible employee is the first day of the plan year quarter coinciding with or next following the date the employee successfully met the eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Contributions**

Each year, participants may contribute up to a dollar amount set by law of pretax annual eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). The Company may make matching contributions equal to a discretionary percentage, to be determined by the employer, of the participant's contributions. The Company may also make an additional discretionary matching contribution and a discretionary profit-sharing contribution as stated in the plan document. Contributions are subject to certain limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, rollover contributions and allocations of the Company's contribution, if applicable, and Plan earnings less expenses. The net investment income of the Plan is allocated based on the actual earnings for each participant's individual account. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Investment Options**

Investments are currently held by the Standard Insurance Company. Upon enrollment in the Plan, a participant may direct employee contributions in any of the available investment options offered by the Plan. Participants may change their investment options at any time.

#### Vesting

Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Vesting in the Company's matching, additional discretionary matching, and profit sharing portions of their accounts plus actual earnings thereon is based on years of continuous service as follows:

#### Note Receivable from Participant

Loans to participants are not permitted under the Plan.

#### Payment of Benefits

On termination of service due to death, disability, or normal retirement, a participant, or their beneficiary, may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or over a period not to exceed participant's (or beneficiaries') life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Hardship withdrawals are allowed as defined in the Plan agreement. Additionally, the Plan allows for in-service distributions at age 59 ½ if fully vested without being required to terminate employment.

#### Forfeited Accounts

Forfeitures are used to reduce employer contributions or pay Plan expenses. During the year ended December 31, 2024, forfeitures of \$3,530 were used to offset employer contributions or Plan expenses. The balance in the forfeiture account as of December 31, 2024 and 2023, totaled \$60,488 and \$46,844, respectively.

#### Excess Contributions Payable

Contributions received from participants are net of payments made in the following year to certain participants to return their excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan. At December 31, 2024 and 2023, there were no excess contributions payable.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Plan assets must be used for the exclusive benefit of participants. In the event of Plan termination, participants will become 100% vested in all amounts credited to their accounts.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting and Use of Estimates**

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP), which requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

The Financial Accounting Standards Board (FASB) has adopted the Accounting Standards Codification (ASC) as the sole source of authoritative GAAP. The FASB will issue Accounting Standards Updates (ASU) from time to time to make adjustments to GAAP.

#### **Investment Valuation**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. The Plan's investments are valued daily.

The insurance company general account determines its fair value using the net asset value (NAV) of the fund. The NAV is determined by the trustee of the fund using the fair value of the underlying securities within the fund at year end. Purchases and sale of securities are recorded on a trade-date basis. Interest income is recorded on the accrual method. Dividends are recorded on the ex-dividend date.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

The Plan permits the payment of the Plan expenses to be made from the Plan assets. If the Company does not pay these expenses, then the expenses paid using the Plan assets will be allocated among the participant accounts. Expenses relative to certain fees were allocated to participants accordingly and totaled \$21,497 for the year ended December 31, 2024.

### NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE (UNAUDITED)

All of the Plan's assets are held by the Standard Insurance Company, the trustee of the Plan. The following information included in the accompanying financial statements and the supplementary schedule were summarized from information furnished by the trustee. The plan administrator has received from the trustee a certification that the information furnished by the trustee is complete and accurate.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan has adopted FASB ASC 820, *Fair Value Measurement*. FASB ASC 820 defines fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

- Level 1 consists of unadjusted quoted prices in active markets for identical assets or liabilities and has the highest priority.
- Level 2 consists of inputs other than quoted prices within Level 1 that are observable for the asset or liability, either directly or indirectly
- Level 3 consists of significant unobservable inputs for the asset or liability and has the lowest priority

The Plan used appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The description of the valuation methodology used for assets measured at fair value at December 31, 2024 and 2023. This is consistent with prior years methodology.

*Pooled Separate Accounts* – Valued at the net asset value (NAV) of units of the separate accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimating fair value. The NAV is based on fair value of the underlying investments held by the account less its liabilities. The practical expedient is not used when it is determined to be probable that the separate account will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner. The pooled separate accounts are redeemed on a daily basis and do not have any redemption restrictions. Additionally, there were no unfunded commitments.

*Standard Stable Asset A* – The Plan has an investment in the group annuity contract with the Standard Insurance Company. Contract value represents contributions made, less withdrawals, and administrative expenses, plus interest credited. The crediting rate is declared in advance and reset quarterly. Daily liquidity at contract value is available for participant contributions and withdrawals. Contract value is an approximate measure for the Standard Stable Asset A for reporting and financial statement purposes, and the Standard believes that contract value approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of pooled separate accounts managed by Standard Insurance Company. Standard Insurance Company is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Expenses paid to the trustee to manage the funds totaled \$21,497 for the year ended December 31, 2024, and were paid out of the assets of the Plan. Additional investment fees paid are netted against investment returns.

### NOTE 6 – TAX STATUS AND UNCERTAIN TAX POSITIONS

The Plan, which is a prototype of a plan that has qualified under the Internal Revenue Code as exempt from federal income tax, has received a favorable tax determination letter on June 30, 2020, from the Internal Revenue Service. The Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan administrator is not aware of any events that have occurred which might adversely affect the Plan's qualified status.

As of December 31, 2024, the amount of net assets available for benefits that were in accounts of participants that are no longer employees of the plan sponsor totaled \$983,115. Of those balances, no amounts had been requested to be paid to the participants but were not paid until subsequent to the Plan's year end.
