**Note 1 - Description of Plan**

The following description of the Super Vacuum Manufacturing Company, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all regular employees of the plan sponsor who are age eighteen or older and have one year of entry service, which consists of 1,000 or more hours of service. The Plan was established on December 31, 1973 and amended from time to time. The Plan was restated effective February 17, 2022 to conform the Plan to new tax laws and incorporate past amendments. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and has been amended to incorporate legislative change under the Pension Protection Act (PPA).

The Trustees of Super Vacuum Manufacturing Company, Inc. 401(k) Profit Sharing Plan (the Company) administer the Plan. Principal Life Insurance Company and Principal Trust Company, members of Principal Financial Group (Principal) serve as custodians, manage the Plan assets and maintain the Plan's records.

Contributions - Participants may make before-tax or after-tax (Roth) contributions, up to a maximum of 100%, of their total compensation each year instead of receiving that amount in cash. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The amount of the deferral is limited to the maximum allowed by law. The Plan also allows rollover contributions from qualified plans. Employee contributions are withheld from the participants' payroll each pay period. Participants are automatically enrolled in the plan one month after they have met the eligibility requirements of the Plan unless they affirmatively elect not to participate in the Plan. Participants enrolled through automatic enrollment will have an automatic deferral percentage increase of 1%, up to 6%, each year effective on July 1, 2022.

The Company makes qualified matching contributions in the amount of 100% of the employee's contribution up to 4% of gross compensation. In addition, the Company may make discretionary contributions for each plan year in an amount determined by the Company. No discretionary contributions were made to the Plan for the year ended December 31, 2024.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocation of (a) the Plan sponsor's contribution (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in all elective deferral contributions into the Plan as well as employer qualified matching contributions. Participant vesting with regards to employer discretionary contributions is determined by years of service. The table below outlines the vesting schedule for employer discretionary contributions into the Plan:

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. A participant may only have one loan outstanding at any given time. The notes receivable are secured by the balance in the participant's account and bear interest rates determined by the loan administrator. The interest rates on outstanding notes receivable from participants were between 5.25% and 10.50%. Interest income on notes receivable from participants is recognized in the period it is earned. Installment payments including principal and interest on the notes receivable are withheld from participant payroll every pay period. Loans mature through August 10, 2029.

Notes receivable from participants are considered in default if any scheduled payment remains unpaid for more than 90 days after due. Upon default, the Participant has the opportunity to repay the note receivable, resume current status of the note receivable by paying any missed payment plus interest, or request distribution of the note. If the note receivable remains in default, the Plan Administrator will offset the Participant's vested account balances by the outstanding balance of the note receivable to the extent permitted by law. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum distribution equal to the vested value of the participant's account, or installments under a systematic withdrawal plan. The normal retirement age under the Plan is 65.

Forfeitures - According to the Plan document, all forfeitures will first be used to pay administrative expenses and then to reduce the earliest Employer contributions made after the forfeitures are determined. Any remaining forfeitures will then be deemed to be additional Employer contributions. As of December 31, 2024 and 2023, there were no forfeited amounts available for future utilization by the Plan and none used during the year ended December 31, 2024.

**Note 2 - Summary of Significant Accounting Policies**

Basis of Accounting - The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investments advisors, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - According to the Plan document, it is anticipated that all administrative expenses shall be paid by the Company. However, to the extent that the administrative expenses are not paid by the Company, such expenses shall be paid out of the Plan upon the direction of the plan sponsor provided that such payments are consistent with ERISA. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Company has evaluated all subsequent events through June 11, 2025, the date the financial statements were available to be issued.

**Note 3 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC are described as follows:

Level 1 Fair Value Measurements - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in an active market which the Plan has the ability to access at the measurement date.

Level 2 Fair Value Measurements - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in an active market;
- Quoted prices for identical or similar assets or liabilities in an inactive market;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust fund:* Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Note 4 - Fully Benefit-Responsive Investment Contracts**

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal) totaling \$595,169 for 2024 and \$575,773 for 2023. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.60 percent for the period from January 1, 2024 to June 30, 2024 and 1.40 percent for the period from July 1, 2024 to December 31, 2024. The crediting rate is reviewed on a semi-annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on completing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**Note 5 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated for any reason, all participants become 100% vested, and the Plan administrator is to distribute each participant's interest to the participant or beneficiary.

**Note 6 - Tax Status**

Principal Life Insurance Company obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Prototype Non-Standardized Profit Sharing Plan with CODA, as designed, is in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term (as defined within one year) and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8 - Information Prepared and Certified by Custodian**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company (the trustees of the Plan).

**Note 9 - Related-Party and Party in Interest Transactions**

Certain Plan investments are shares of mutual funds and common/collective trust funds managed by the custodians, Principal Life Insurance Company and Principal Trust Company. The transactions in these investments qualify as party-in-interest transactions. Some of the fees incurred by the Plan for the investment management services are paid as a direct payment. As described in Note 2, the Plan made a direct payment to the third party administrator of \$52,250 which was not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.
