Basis for Opinion

Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENTS SEPTEMBER 30, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of VISIONS/Services for the Blind and Visually Impaired Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established effective August 27, 1984 as a defined contribution 403(b) plan that provides retirement benefits for all employees of VISIONS/Services for the Blind and Visually Impaired (the "Organization"). The Plan has no service or age requirements for elective deferral contributions. For discretionary employer contributions, employees must have one year of service and have attained 21 years of age. Upon eligibility, participants can begin receiving discretionary contributions immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may elect to contribute a percentage of their annual wages on a pre-tax basis to the plan. Contributions are subject to certain limitations as defined by the Plan and the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Contributions are subject to certain statutory limitations.

The Organization may elect to make a discretionary employer contribution to the Plan, to be allocated to each person who has met the eligibility requirements stated above. The discretionary contribution is calculated as 5% of all eligible employee wages.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Organization's discretionary employer contributions and the Plan's earnings and losses thereon. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings and losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

The Plan currently offers mutual fund accounts and insurance contracts. Participants may change their investment options daily.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their contribution and the earnings and losses thereon. Once eligible, participants are also immediately 100% vested in all discretionary contributions and any earnings from them.

Withdrawals

Withdrawals of all vested amounts may be made after a participant attains 65 years of age or if the withdrawal is for reason of hardship (as defined).

A participant may also request a withdrawal upon attainment of age 59 1/2 or upon demonstration by the participant to the plan administrator that the participant is suffering from "hardship". Hardship is defined by the Plan as a certain, immediate, and heavy financial need for specific qualifying expenses. Hardship distributions are only available from participant contributions.

Payment of Benefits

On termination of service due to disability or retirement, if the participant's account is greater than an amount specified by the U.S. Department of Labor ("DOL") (currently \$5,000), the participant may elect to receive payment of their vested account balance in either a lump sum or under a continuous right of withdrawal pursuant to which a participant may withdraw such amounts at such times as they will elect. For death benefits, amounts can be paid as a single lump sum to the participant's beneficiary or under one of the two optional formats stated in the plan document. For vested account balances less than \$5,000, the amount specified by the DOL as the force out threshold, the plan administrator is required to roll those amounts into an individual retirement account ("IRA") designated by the plan administrator if not elected to be distributed directly to the participant or rolled into an eligible retirement plan of their choice. Vested account balances of terminated employees less than \$5,000 are subject to the involuntary cash out requirement.

Administrative Expenses

Plan expenses related to the administration of the Plan or associated with the investment of Plan assets may be paid by the Plan or by the Organization. If the Organization does not pay Plan-related expenses, such fees or expenses will be allocated to Participant accounts either proportionally or as an equal dollar amount.

Notes Receivable From Participants

Participants may borrow from their fund accounts up to a maximum amount that is equal to the lesser of \$50,000 or 50 percent of the value of the vested portion of the participant's accounts and greater than \$1,000. The maximum repayment terms of loans are 5 years for general purpose loans and 10 years for principal residence loans. The amounts borrowed are transferred from the investment funds in which the participant's accounts are currently invested. Repayment and interest thereon are credited to the participant's current investment funds through payroll deductions made each pay period. The loans are secured by the vested balance in the participant's account and bear interest ranging from 2.50% - 7.50%. The participant loan interest rates are adjustable and are established in the calendar quarter in which the loan is issued. The interest rate is subject to change at the annual loan anniversary date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

In accordance with U.S. GAAP, fixed annuity contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, currency and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amount reported in the financial statements.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the accompanying financial statements and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. The Plan has determined an allowance for uncollectible notes receivable from participants is unnecessary at September 30, 2024 and 2023.

Investment Valuation and Income Recognition

Investments in mutual funds are stated at fair value based upon quoted market prices at the Plan’s year end. Fully benefit responsive guaranteed annuity contracts are stated at contract value, as this is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan’s interest in the guaranteed annuity contract is held with Variable Annuity Life Insurance Company (VALIC). Funds under these contracts that have been allocated and applied to purchase annuities are excluded from the Plan’s assets. Purchased annuities are contracts under which the insurance company is obligated to pay benefits to named participants or their beneficiaries. The fund is fully benefit-responsive, which means withdrawals from the fund may be made for qualifying benefit payments, including participant-directed transfers. Participants can transfer funds from the fund to other non-competing investment options. Amounts transferred from the fund may not subsequently be transferred to a competing fixed option or withdrawn for 90 days. Participant contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. VALIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. VALIC guarantees the interest rate, approximating at least 1%, until the end of the year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition (Continued)

Certain events may limit the Plan's ability to transact at contract value with VALIC. Such events may include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that may limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

Changes in the fair value of investments, including realized/unrealized gains and losses on assets sold during the year or held at year-end, are reflected in the statements of changes in assets available for benefits as net appreciation (depreciation) of investments. Purchases and sales of securities are reflected on a trade day basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The methodology described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Payment of Benefits

Benefits are recorded when paid.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

3. FAIR VALUE MEASUREMENTS (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Organization believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used in the prior year.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended September 30, 2024 and 2023, there were no transfers into or out of Level 3.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of September 30, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by VALIC. Transactions between Variable Annuity Life Insurance Company and the Plan qualify as party-in-interest transactions since this organization also provides custodial and recordkeeping services to the Plan. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

In addition, the Plan also allows participants of the Plan to receive loans under specific circumstances. As such, transactions between participants with loans and the Plan qualify as party-in-interest transactions.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. However, their accounts will be held under the Plan and continue to be adjusted for investment gains and losses until distributed.

7. TAX STATUS

The Plan is designed through a prototype plan sponsored by The Variable Annuity Life Insurance Company to qualify under Section 403(b) of the Internal Revenue Code ("Code"). The prototype plan has received an opinion letter, dated February 1, 2018, from the Internal Revenue Service ("IRS") which stated that the prototype plan is qualified, and the related trust is tax-exempt. The prototype plan opinion letter has been relied upon by this Plan. The prototype sponsor as well as the Plan's sponsor believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and has no income subject to business income tax.

8. PROHIBITED TRANSACTIONS

During 2024 and 2023, the Organization failed to transmit certain participant contributions totaling \$244,717 and \$175,643, respectively, within the time period prescribed by Department of Labor regulations. While the Organization fully corrected the 2023 untimely remittances, the Organization is in the process of entering into a voluntary fiduciary correction program (VFCP) for the 2024 untimely remittances.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through June 20, 2025, which is the date the financial statements were available to be issued.
