Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTES TO FINANCIAL STATEMENTS

NOTE A - Description of Plan

The following description of the Sure Alloy Steel/Astech 401(k) Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a 401(k) defined contribution profit sharing plan covering all employees of SAS Global Corporation and Astech, Inc. (Company) who have completed three months of service as defined in the plan and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year participants may contribute up to 100% of pretax annual compensation or the maximum amount permitted by law, as defined in the Plan. Participants may also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may make discretionary matching contributions based on a percentage, to be determined annually by the Company’s Board of Directors, of the employees’ deferral contributions to the Plan. The Company may also make annual profit sharing contributions to the Plan at the discretion of the Company’s Board of Directors.

Participants may direct employee and employer contributions in a broad range of investments including registered investment funds and a stable value fund. Participants may change their investment options each business day.

Participant Accounts

Each participant's account is credited with the participant's contributions, related employer matching contributions and discretionary profit sharing contributions and forfeitures of terminated participants’ nonvested accounts. The Plan’s income is allocated to the participants based on their respective fund earnings or account balances, as defined in the Plan.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. A participant is 100% vested in any matching Company contribution plus actual earnings thereon after six years of credited service. A participant is 100% vested in any discretionary Company contribution plus actual earnings thereon after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their accounts balance, whichever is less. Loan terms range up to five years or up to fifteen years for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at the prevailing prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

NOTE A - Description of Plan (continued)

Payment of Benefits

On termination of service, death, disability or retirement, a participant or his or her beneficiaries may elect to receive the value of his or her vested interest in a lump-sum or installments over a period of years. Participants may also request a distribution for all or part of their account that is attributable to their voluntary contributions in the event of financial hardship, as defined in the Plan.

Forfeited Accounts

Forfeited amounts may be reallocated to participants in the same manner as employer discretionary contributions or used to pay plan expenses. Forfeited amounts were used to reduce employer contributions by approximately \$13,000 for the year ended September 30, 2024. Forfeited amounts approximated \$85 and \$0 at September 30, 2024 and 2023, respectively.

NOTE B - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies, utilizing information provided by the investment advisor and trustee. See Note D for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses consist of loan initiation and maintenance fees, short term redemption fees applicable to certain funds and certain fees related to the overall operation of the Plan. Fees are either charged to the specific accounts of the participants who incurred these charges or allocated to participant accounts. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in the net appreciation (depreciation) of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 14, 2025, the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

NOTE C - Information Certified by the Trustee

Certain information related to the Plan's investments and notes receivable from participants included in the financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at September 30, 2024 and 2023, and the associated investment income (loss) and interest income on notes receivable from participants for the year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan. This information has not been audited by the independent accountants.

NOTE D - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at September 30, 2024 and 2023.

Registered investment funds: Valued at the daily closing price as reported by the fund. Registered investment funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value fund: Investment contract with an insurance company that is valued at contract value, which approximates fair value. The value is based on principal plus credited interest. Interest is determined semi-annually.

NOTE E – Parties-in-Interest

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Investment management fees are paid for by the Plan to investment managers who qualify as parties-in-interest. These investment management fees are reflected in the financial statements as a reduction on the return of the Plan’s investments. Certain plan assets are investment funds managed by Transamerica Life Insurance Company and certain affiliated companies, the administrator of the Plan’s assets and, therefore, these transactions qualify as party-in-interest transactions. Other transactions during the year with parties-in-interest include administrative and plan advisory services. Notes receivable from participants also reflect party-in-interest transactions. The plan sponsor pays certain administrative fees, see Note B.

NOTE F - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE G - Tax Status

The Company has adopted a non-standardized pre-approved plan document sponsored by CCH Incorporated. The Internal Revenue Service has informed the non-standardized pre-approved plan sponsor with an opinion letter dated June 30, 2020, that the non-standardized pre-approved plan satisfies the applicable provisions of the Internal Revenue Code. The Plan itself has not received a determination letter from the Internal Revenue Service. However, the Plan’s administrator and the Plan’s trustee believe that the Plan is designed and is currently being operated in compliance with the non-standardized pre-approved plan document and applicable requirements of the Internal Revenue Code.

NOTE G - Tax Status (continued)

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions: however, there are currently no audits for any tax periods in progress.

NOTE H - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risk such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
