(1) Description of the Plan

The following brief description of the EXO-S US, LLC 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan's provisions.

- (a) General - The Plan is a qualified 401(k) and profit sharing plan covering all employees of EXO-S US, LLC (the "Company" or "Employer") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Any employee age 18 or older and has completed three consecutive months of service, or one year of service if earlier are eligible to participate.
- (b) Plan Expenses - Certain direct expenses are paid by the Plan. All other administrative expenses are paid by the Company.
- (c) Contributions - Contributions to the Plan are made by the participant and on a discretionary basis by the Company. An individual participant may elect to contribute a percentage of their salary or a defined dollar amount of their compensation not to exceed Internal Revenue Service ("IRS") limits. Participants direct their contribution into various investment options. Additional catch-up contributions are allowed for participants age 50 and over. The Company provides a matching contribution at their discretion for eligible employees who have attained age 18 and have completed at least three months of service during the Plan year. The Employer matched 50% of participant contributions up to 4% during the years ended December 31, 2024 and 2023. The Company may also provide discretionary profit sharing contributions to all employees who have attained age 18 and have completed one year of service. The profit sharing contribution for the years ended December 31, 2024 and 2023 was 1.34% of eligible compensation.
- (d) Forfeitures - Forfeitures may be used to reduce Company contributions or Plan expenses. Forfeitures used during the years ending December 31, 2024 and 2023 amounted to \$37,989 and \$54,757, respectively. The remaining balances of forfeited non-vested accounts were \$35,624 and \$15,421 as of December 31, 2024 and 2023, respectively.
- (e) Withdrawals and Benefits - Distributions from the Plan may begin when a participant reaches the age of 59 ½. Distributions are also allowed for death, disability, or termination of employment. The Plan allows for hardship withdrawals in accordance with Plan restrictions. Distributions may be made in the form of a lump-sum distribution or annual installments. The value of the account, regardless of payment method, will be equal to the vested account balance at the time of retirement.
- (f) Vesting - Participants are immediately vested with respect to their deferrals. Employer discretionary profit sharing and matching contributions are subject to the following vesting schedule: Participants are 25% vested after one year of service; the vested portion increases to 50% after two years of service, 75% after three years of service, and 100% after four years of service. A participant who dies, reaches the age of retirement, or becomes permanently disabled immediately becomes 100% vested in matching and discretionary profit sharing contributions.

- (g) Participant Accounts - Each participant's account is credited with the participant's contributions and their allocation of (a) the Company's matching or profit sharing contribution and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participants' earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- (h) Notes Receivable - A participant is permitted to borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans can be for no longer than a 5-year term, except for the purchase of a principal residence. Loans are repaid through payroll deductions. The interest rate on a loan is the prime rate listed in the Wall Street Journal plus 1% at the time each loan was disbursed.

(2) Summary of Significant Accounting Policies

- (a) Basis of Accounting - The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- (b) Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. If available, quoted market prices are used to value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- (c) Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- (d) Risks and Uncertainties - The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.
- (e) Payment of Benefits - Benefits payments are recorded when paid.

Summary of Significant Accounting Policies (continued)

- (f) Notes Receivable - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.
- (g) Subsequent Events - The Plan evaluated subsequent events through July 15, 2025, the date the Plan's financial statements were available to be issued.

(3) Information Certified by the Plan's Custodian

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by Empower Trust Company, LLC, the custodian of the Plan, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule. The custodian has certified to the completeness and accuracy of all amounts and types of investments reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024, and the related investment activity reflected on the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.

(4) Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances. Additionally, the Company may amend the Plan at any time without the consent of any participant or beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

During the year ended December 31, 2024, the Plan experienced a 34% reduction in the number of active participants resulting in a partial plan termination under Internal Revenue Code Section 411(d)(3). As a result, all affected participants who were terminated during the year became fully vested in their account balances as of their termination date.

(5) Fair Value Measurements

Generally accepted accounting principles in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund.

Common Collective Trust Fund: Valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(6) Income Taxes

The Plan is a prototype plan that has obtained an opinion letter stating that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code. The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(7) Related Party Transactions

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.
