Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Rockford Manufacturing Company Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Rockford Manufacturing Company Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Rockford Manufacturing Company Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Rockford Manufacturing Company Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Rockford Manufacturing Company Savings Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan covering all full-time employees of the Company, who have ninety (90) days of service (See Note 11 for change in eligibility effective April 28, 2025). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), Uruguay Round Agreements Act (GUST and generally referred to as GATT), the uniformed Services Employment and Reemployment Rights Act of 1994 (VJERRA), the Small Business Job Protection Act of 1996 (SBJPA), and the Taxpayer Relief Act of 1997 (TRA). Also, Rockford Manufacturing Company (employer) adopted a Prototype Non-Standardized 401(k) Profit Sharing Plan and Trust.

The Trustee and custodian of the Plan is Newport Trust Company, an Ascensus company. Newport Trust Company retained the services of Matrix Trust Company to be a sub-custodian/trading partner.

Other Plan provisions are as follows:

- a. Contributions – Participants may elect to contribute not less than 3% and up to 100% of compensation. The Company will match 100% of the eligible contributions up to 3%. Additional amounts may be contributed at the option of the Plan Sponsor’s Board of Directors.
- b. Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocation of (a) the Company’s contribution and (b) Plan earnings of terminated participants’ non-vested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account. Participants direct the investment of their contributions into various investment options offered by the Plan’s trustee, Newport Trust Company.
- c. Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. A participant is 100 percent vested in the remainder of their accounts after three years of credited service.
- d. Payment of Benefits – A participant will receive a lump-sum amount equal to the value of his or her account as soon as administratively possible following attainment of normal retirement age, or as soon as administratively possible when the participant requests a distribution of his or her account for all other voluntary or involuntary terminations.
- e. Participant Loans – The Plan does not allow its participants to borrow against their respective accounts nor to pledge or otherwise assign their interest in the Plan.
- f. Forfeited Accounts – At December 31, 2024 and 2023, there were no forfeited nonvested accounts. For the year ended December 31, 2024, nonvested accounts in the amount of \$5,545 were forfeited and applied to reduce employer contributions.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. At December 31, 2024 and 2023, the Plan had no fully benefit-responsive investment contracts.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Contributions Receivable

Contributions receivable consists of employer matching and profit-sharing contributions that are contributed to the plan shortly after year end. No allowance for credit loss is deemed necessary.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan’s gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits – Benefits are recorded when paid.

Expenses – With the exception of a portion of the audit fee expenses of maintaining the Plan are paid by the Plan. Investment expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events – The Plan has evaluated subsequent events through June 11, 2025 the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 and Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

Level 2 Fair Value Measurements

The fair value of corporate bonds and U.S. government securities are valued using a market approach on yields currently available on comparable securities of issuers with similar credit ratings.

NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants will become 100 percent vested in their accounts.

NOTE 5 – TAX STATUS

The IRS has determined and issued a letter dated June 30, 2020, that the Volume Submitter Profit Sharing Plan and related trust as restated are designed in accordance with applicable sections of the Internal Revenue Code (IRC) for an exemption from federal income taxations under IRC Section 401(a) and IRC Section 501(a). Accordingly, no taxes have been provided for in the accompanying statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan Trustee has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax period in progress.

NOTE 6 – DISCRIMINATION TESTING

In accordance with the Tax Reform Act of 1986, a 401(k) Actual Deferral Percentage Test (ADP), which includes elective deferral contributions, and a 401(m) Actual Contribution Percentage Test (ACP), which includes employer matching contributions and reallocated forfeitures of employer matching contributions, were performed. For Plan years beginning in 1989, the Tax Reform Act of 1986 also requires completion of a test on Multiple Use of Alternative Limitations when more than one discrimination test is required. At December 31, 2024, the Plan was in compliance with regulations regarding discrimination testing.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 – SUMMARY OF INFORMATION CERTIFIED BY PLAN TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements held at December 31, 2024 and 2023, including the supplemental schedule of assets held for investment at December 31, 2024, net appreciation (depreciation) in fair value of investments, and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Newport Trust Company (the trustee of the plan).

NOTE 9 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Contract administrator fees paid directly by the Plan for the investment management services totaled \$64,892, fees for trustee services totaled \$7,359, and distribution, participant, audit and other service fees totaled \$19,567 for the year ended December 31, 2024. Custodian expenses of Matrix Trust Company are paid by Newport Trust Company. As described in note 2, the Plan pays all expenses of maintaining the Plan.

The above party-in-interest transactions are exempt from prohibited transactions rules of ERISA.

NOTE 10 – RECONCILIATION BETWEEN FINANCIAL STATEMENTS AND FORM 5500

There are no reconciling items between the financial statements and Form 5500 filed with the Department of Labor.

NOTE 11 – PLAN AMENDMENT SUBSEQUENT TO YEAR END

Effective April 28, 2025, the Plan was migrated to a new recordkeeping platform. The new platform does not support the Plan's requirement that requires an employee to complete ninety (90) days of service before they may participate in one or more components of the plan. In order for the new recordkeeping system to fully support the Plan's operation, the service requirement needed to be expressed in months of service rather than days of service. Thus, the Plan was amended to require an employee to complete three consecutive months of service from the date of employment. Employees are eligible to participate in the plan on the first day of the month coinciding with or following completion of three consecutive months of service.
