#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Fairbank Group Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Fairbank Group Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## NOTES TO FINANCIAL STATEMENTS SEPTEMBER 30, 2024 AND 2023

### 1. DESCRIPTION OF PLAN:

The following brief description of the Fairbank Group Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan established May 1, 1983 to provide benefits for all eligible employees of Jiminy Peak Mountain Resort, LLC and Cranmore Mountain Resort (collectively the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The trustee has sole responsibility for management of the assets held by the Plan. Further detailed information about the Plan is contained in the Plan document.

#### **Eligibility**

Employees of the Company who have reached the age requirement of 20 ½ years of age, are eligible to participate in the Plan at the time of hire.

#### **Contributions**

Participants can contribute up to 100% of their annual compensation, as defined by the Plan, limited to the maximum dollar limit on employee contributions as stipulated by the Internal Revenue Code. Additionally, participants over age 50 are eligible to make catch-up contributions, which are also limited by the Internal Revenue Code regulations.

The Company, at the discretion of management, may make matching contributions to the Plan. For the years ended September 30, 2024 and 2023, there were \$68,298 and \$62,670 in matching contributions made by the Company, respectively. For the years ended September 2024 and 2023, \$4,773 and \$842 of forfeitures were used to offset employer contributions, respectively.

#### **Administration**

The Company is the Plan sponsor and is responsible for the monitoring and administration of the Plan.

#### **Participant accounts**

Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contribution and (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant wages, account balances or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## NOTES TO FINANCIAL STATEMENTS SEPTEMBER 30, 2024 AND 2023

### 1. DESCRIPTION OF PLAN: (CONTINUED)

#### Vesting

All participants are immediately 100% vested in their voluntary, rollover and qualified non-elective contributions plus earnings thereon. A participant must complete at least 1,000 hours of service during a year to receive credit for a year of service. Vesting in the Company matching contribution and additional fixed non-elective contributions portion of the individual participant's accounts are based on the following schedule:

#### Forfeitures

A forfeiture is a loss of all or a portion of the Company contributions and earnings thereon allocated to an account of a participant separating from service before becoming 100 percent vested. The nonvested portion of this account represents the forfeitures which are used to reduce future Company contributions or used to reduce plan expenses. For the years ended September 30, 2024 and 2023, \$4,773 and \$842 of forfeitures were used to offset employer contributions, respectively. As of September 30, 2024 there was no forfeiture balance. As of September 30, 2023, there were forfeitures of \$38 that were available to offset future Company contributions or plan expenses.

#### Payment of benefits

On termination of service, death, disability or retirement a participant or their beneficiaries with a vested account balance less than \$1,000 will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants may also request distributions in the form of an annuity or an installment payment. For participants with a vested balance of greater than \$1,000 but less than \$7,000, the Plan will make a direct rollover of the participant's account to an individual retirement account designated by the Plan administrator. Participants with a vested balance of greater than \$7,000 may defer payment of benefits until a later date. Withdrawals of vested benefits may be made prior to severance of service if the participant has attained the age of 59 1/2 or upon the demonstration of financial hardship as defined in the Plan document. Distributions are subject to the applicable provisions of the Plan document.

#### Participant loans

A participant may borrow up to 50% of the value in the participant's vested account not to exceed \$50,000 and subject to a \$1,000 minimum. All participant loans are evidenced by a promissory note executed by the participant who has taken the loan. The loan term shall not exceed five years unless the loan qualifies as a home loan, then the term will be for ten years. The portion of the participant's account balance which was loaned to him/her shall be segregated into a separate account. Loans are collateralized by the balance in the participant's vested account and bear interest at the prime rate plus 1% with all interest rates presently at 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions so long as the participant is employed by the Company and thereafter by regular installment payments.

#### Plan termination

The Company presently expects to continue the Plan indefinitely but reserves the right to amend or terminate it, subject to the provisions of ERISA. If the Plan were terminated, all amounts credited to participants would be fully vested and non-forfeitable.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

#### **SECURE 2.0 Act of 2022**

The SECURE 2.0 Act of 2022 (the “Act”) was signed into law on December 29, 2022, to increase retirement savings, improve retirement rules, and lower employer costs of setting up a retirement plan. Plan amendments required by the Act generally need not to be made until the end of the first plan year beginning on or after January 1, 2026, however, plans must operate in accordance with effective dates of each new provision.

Major provisions of this Act that may effect the Plan include:

- Effective January 1, 2024, the limit for mandatory cash outs will be raised from \$5,000 to \$7,000.
- Effective January 1, 2025, further expansion of eligibility to long-term part-time workers, which will allow participation after two consecutive years of 500 or more hours.
- Effective January 1, 2025, plans must automatically enroll participants as they become eligible at a deferred rate of 3%.
- Effective January 1, 2026, catch up contributions for any participants over age 50 who earn over \$145,000 are now required to be made on a Roth basis.

#### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with generally accepted accounting principles in the United States of America.

#### **Investment valuation and income recognition**

Investments held by the Plan are stated at fair value, with the exception of fully benefit-responsive investment contracts which are stated at contract value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). Contract value reflects the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan and is the relevant measure for the portion of assets attributable to fully benefit-responsive investment contracts. All investments are participant directed.

The Plan administrator is responsible for determining the Plan’s valuation policies and analyzing information provided by the investment advisors, custodian and record keeper that is used to determine the fair value of the Plan’s investments. See Note 4 for further discussion of fair value measurements.

In accordance with the policy of stating investments at fair value, net unrealized appreciation in fair value is reflected in the Statements of Changes in Net Assets Available for Benefits. The net appreciation in the fair value of its investments consists of realized gains or losses and unrealized appreciation on those investments.

Purchase and sale of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest and other investment income is recorded as earned on an accrual basis. Earnings on investments, with the exception of participant loans, are allocated on a pro rata basis to individual participant accounts based on the type of investment and the ratio of each participant’s individual account balance to the aggregate of participant account balances. The portion of interest included in each loan payment made by a participant is recognized as interest income in the participant’s individual account.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES: (CONTINUED)

#### Participant loans receivable

Participant loans receivable are recorded at their unpaid balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed as incurred. Since the participant's remaining vested investment balance is sufficient to cover the outstanding loan amount, there is no allowance for doubtful accounts at September 30, 2024 and 2023. Interest is calculated and included in the repayment terms of the loan when the loan is initiated and is recognized with the amortization of the loan as each payment is remitted. Loans are monitored for repayment under the original loan terms and defaulted when active participants cease payments past the allowed grace period. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. For terminated participants, once a distribution is requested, the outstanding loan balance will be netted against the remaining vested investment balance.

#### Payment of benefits

Benefit payments are recorded upon distribution.

#### Plan expenses

Jiminy Peak Mountain Resort, LLC, the employer and Plan sponsor, pays all of the administrative expenses of the Plan, with the exception of certain transactional fees and investment management services which are paid directly by the Plan (see Note 7).

#### Use of estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America and the Department of Labor ("DOL") rules and regulations for reporting and disclosure under ERISA requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results could differ from those estimates.

### 3. INFORMATION CERTIFIED BY TRUSTEE:

The Plan administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, John Hancock Life Insurance Company, the trustee of the Plan, certified to the Plan administrator the fair value and physical custody of investments to be complete and accurate as of and for the years ended September 30, 2024 and 2023, and investments and participant loans included in the Statements of Net Assets Available for Benefits, investment income and net appreciation in the fair value of investments included in the Statements of Changes in Net Assets Available for Benefits and the information contained in Notes 4 and 5 concerning investments and information included in the Schedule of Assets (Held at End of Year).

#### 4. FAIR VALUE MEASUREMENTS:

The Plan follows established guidelines for a fair value hierarchy that prioritizes the inputs used to measure fair value. An asset or liability's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement. This hierarchy prioritizes the inputs into three broad levels as follows:

- Level 1 Quoted prices (unadjusted) in active markets for identical assets or liabilities. Market price is generally obtained from exchange or dealer markets.
- Level 2 Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. Inputs are obtained from various sources including market participants, dealers and brokers.
- Level 3 Unobservable inputs that are supported by little or no market activity as they trade infrequently or not at all and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation method used for assets measured at fair value. There have been no changes in the method used for the year ended September 30, 2024.

*Pooled separate accounts:* Valued at the net asset value ("NAV") per share based on the quoted market price of the underlying funds.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The pooled separate accounts invest in one or more publicly traded mutual funds and are valued daily using the NAV based upon quoted market prices of the underlying investments.

#### 5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS:

The guaranteed investment contract is a fully benefit-responsive investment contract, the (“Contract”), issued by John Hancock Life Insurance Company (“John Hancock”). The Contract invests primarily in guaranteed investment contracts (“GIC’s”) and security backed investment contracts. John Hancock maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fund is included in the financial statements at fair value and then adjusted to contract value as reported to the Plan by John Hancock. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting rate was 0.10% for 2024 and 2023. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan’s ability to transact at contract value with participants are not likely to occur.

#### 6. TAX STATUS:

The Plan received a determination letter on November 30, 2020 in which the Internal Revenue Service (“IRS”) states that the Plan, as then designed, was in compliance with Section 401(a) of the Internal Revenue Code. The Plan has not been amended since receiving the determination letter. The Plan Administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

During the year ended September 30, 2024, Plan management discovered an operational failure whereby the payroll system did not withhold elective deferrals for one employee who requested to participate in the Plan. The missed deferrals, employer match and lost earnings of \$3,473 were remitted into the Plan on December 1, 2023. Plan management believes the final outcome of the correction process will not have a material impact on the Plan’s financial statements or the Plan’s qualified tax status.

#### 6. TAX STATUS: (CONTINUED)

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of September 30, 2024 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to September 30, 2021.

#### 7. RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS:

Certain Plan investments are shares of pooled separate accounts managed by John Hancock Life Insurance Company, the trustee as defined by the Plan, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included in net appreciation in the fair value of the investments, as they are paid through revenue sharing rather than a direct payment.

Transactional fees paid by the Plan for distribution and loan services amounted to \$3,035 and \$1,920 for the years ended September 30, 2024 and 2023, respectively.

Certain employees and officers of the Company, who may also be participants in the Plan perform administrative services at no cost to the Plan.

#### 8. RISKS AND UNCERTAINTIES:

The Plan provides for various investment fund options in any combination of stocks, bonds, fixed income securities, mutual funds, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### 9. SUBSEQUENT EVENTS:

Management has evaluated subsequent events through July 11, 2025, the date on which the financial statements were available to be issued.
