Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of Mueller Companies Profit Sharing Plan & Trust (the "Plan") have been prepared on the accrual basis of accounting using accounting principles generally accepted in the United States of America (GAAP).

Investment Valuations and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants shall be measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Single Employer Plan

Mueller Companies Profit Sharing and Trust is classified as a single employer plan covering related employers. The related employers covered by the Plan are Mueller Roofing Distributors, Inc., Mueller Commercial Services, Inc., and MRD Logistics, LLC, collectively "the Company".

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Related-Party Transactions

Several employees of the Company provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan.

Certain plan assets are in investment funds managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC. Empower Annuity Insurance Company of America and Empower Trust Company, LLC is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

Benefit Payments to Participants

Benefit payments are recorded when paid.

Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Subsequent Events

The Plan has evaluated events subsequent to the statements of net assets available for benefits through July 2, 2025, which is the date the financial statements were available to be issued.

NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan. All employees of the Company who are 18 years of age are eligible to participate in the Plan after completing six months of service. Each employee automatically becomes enrolled in the Plan the month following eligibility. Participants are notified of the automatic enrollment provisions, as required by the Plan document, and the participants who become automatically enrolled are enrolled at a default rate of 3% of eligible compensation unless they specifically elect a different rate or choose not to participate. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Notes to Financial Statements (Continued)

NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

Contributions

Both the participants and the Company may make contributions under the Plan. A participant may contribute up to 100% of compensation. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 plus a catch-up of \$7,500 for 2024). The Plan allows the Company to make discretionary matching contributions to all employees on a pay period basis. The Company has a match equal to 50 percent of the first 6 percent of base compensation that a participant contributes to the Plan. Employer matching contributions for 2024 were \$302,812. The Company may also make annual discretionary profit sharing contributions at the end of the Plan year. The Company elected not to make a profit sharing contribution for 2024.

Participants may make voluntary contributions to the Plan on an after-tax basis. Contributions are included in the participant's gross income. The combined amounts contributed pre-tax and after-tax are subject to certain stipulated maximums.

Rollover Contributions

Participants may roll over their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with the participant and Company's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants become immediately vested at the time of participation in the Plan in their contributions and employer matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants become partially vested after two years with 100% vesting being attained after six years. Employees hired prior to March 1, 2014 will remain 100% vested for purposes of matching contributions. Non-vested portions of participant accounts that are forfeited upon payment of benefits are used to reduce employer contributions or to pay administrative expenses of the Plan.

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company or termination of the Plan, the participant's account is distributed under several options. If the participant's vested interest is greater than \$5,000, the form of benefit payment is selected by the participant among various options including installment, lump sum, and partial withdraw. If the vested interest is \$5,000 or less, the payment will be in the form of a lump sum payment, payable as soon as administratively feasible.

Payment of Benefits (Continued)

In-service distributions are permissible from the Plan for participants that have attained the age of 59 1/2.

In conditions of "financial hardship", as defined, a participant may apply to the Plan administrator for approval to withdraw that portion of their elective deferrals necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

Forfeitures

As of December 31, 2024 and 2023, forfeited unallocated nonvested accounts totaled \$59,321 and \$40,740, respectively. There were \$12,500 of forfeitures used to pay administrative expenses of the Plan in 2024. There were no forfeitures used to reduce employer contributions in 2024.

Notes Receivable from Participants

Notes receivable from participants are available on amounts in the participant's account. Participants may borrow from their fund accounts the lesser of \$50,000 or one-half of their vested interest in the Plan. The \$50,000 limit is reduced by the current note receivable balance during a one-year period. Notes receivable are secured by the balance in the participants' accounts and bear interest at rates that range from 4.25 percent to 9.50 percent. All notes receivable must have a definite repayment period, generally not to exceed five years, which provides for payments to be made at least as frequently as quarterly. Outstanding note receivable balances are \$211,400 and \$146,894 at December 31, 2024 and 2023, respectively.

Expenses of the Plan

Certain expenses and costs of the Plan were paid by the Company and, accordingly, are not reflected in the Plan's financial statements. Certain investment related expenses are included in net appreciation in fair value of investments.

NOTE 3 FAIR VALUE MEASUREMENTS

GAAP provisions for Fair Value Measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP provisions for Fair Value Measurements are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value.

Mutual funds: Value at the net asset value ("NAV") of shares held by the plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The following information provided by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustee of the Plan, for the years ended December 31, 2024 and 2023, was certified by them to be accurate and complete with respect to the following:

- (a) The assets held at December 31, 2024 and 2023, as well as the transactions involving these assets for the year ended December 31, 2024.
- (b) The amount of investment income for the year ended December 31, 2024.
- (c) The Schedule H, Line 4i – Schedule of Assets (Held at End of Year) at December 31, 2024.

NOTE 5 TAX STATUS

The Company has adopted a prototype plan which has received an opinion letter from the IRS dated November 14, 2022, which states that the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Furthermore, the Plan has been amended since receiving the opinion letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt, as of the financial statement date.

NOTE 6 BENEFIT RESPONSIVE CONTRACT

The Plan entered into a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include Plan termination and contract termination prior to Empower Annuity Insurance Company of America recovering all start-up costs. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable. Either party may terminate the contract with at least 60 days advance written notice to the other party.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
