Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Melton Machine & Control Company 401(k) Plan (The Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended September 30, 2024 and 2023, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023 and for the years ended September 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Plan Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Allowance for Credit Losses

Effective October 1, 2023, the Plan adopted ASC 326: Financial Instruments-Credit Losses, using a modified-retrospective approach. The standard requires entities to record an estimate of expected losses on financial assets for the remaining estimated life of the asset. The standard applies to the Plan's contribution receivable. The adoption did not have a material impact on these financial statements. The Company has concluded that no allowance for current expected credit losses was necessary at September 30, 2024 and September 30, 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Transfers from and to Other Plan

Transfers from and to other plan reflect balances transferred between the Plan and the 401(k) Plan of the plan sponsor's wholly owned subsidiary, Computech Manufacturing Company, Inc.

Subsequent Events

The Plan has evaluated subsequent events through July 15, 2025, the date the financial statements were available to be issued.

NOTE 2: DESCRIPTION OF THE PLAN

The following description of the Melton Machine & Control Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

NOTE 2: DESCRIPTION OF THE PLAN, CONTINUED

General

The Plan is a defined contribution 401(k) plan originally effective October 1, 2002 and has been most recently restated effective October 1, 2021. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The 401(k) Plan Trustees are responsible for oversight of the Plan. The 401(k) Plan Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Eligibility

Employees of Melton Machine & Control Company (the Company) are eligible to participate in the Plan upon turning 21 years of age and completing six months of service. An eligible employee becomes a participant on the first day of the month immediately following or coincident with the completion of the eligibility requirements.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Service Code. Eligible participants are permitted to elect to have a percentage of their annual year-end bonus, not to exceed federal statutory limits, contributed as pre-tax 401(k) to the Plan. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. In accordance with a recent amendment effective October 1, 2023, eligible participants were permitted to elect to have a percentage of their weekly compensation (excluding bonus) contributed to the Plan. Effective January 1, 2024, the Plan allowed for participants to contribute on an after tax (Roth) basis to the Plan.

The Company will make safe harbor contributions to the Plan in an amount not less than 3% of participants' eligible plan year compensation. The Company may, at its discretion, elect to make a qualified matching contribution or profit sharing contribution to the Plan. For the years ended September 30, 2024 and 2023, the Company made a safe harbor contribution of 3% of current plan year compensation allocated to eligible participants. For the year ended September 30, 2024, the Company made a profit sharing contribution of 2% of current plan year compensation allocated to eligible participants and no profit sharing contribution for the year ended September 30, 2023. There were no Company matching contributions for the years ended September 30, 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's safe harbor contribution, allocation of any Company discretionary contribution, forfeitures and Plan earnings. Participant accounts are charged with an allocation of Plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 2: DESCRIPTION OF THE PLAN, CONTINUED

Vesting

Participants are immediately vested in their contributions, Company safe harbor contributions, any rollover contributions, plus the earnings on those amounts. Vesting in any discretionary Company matching and profit sharing contributions, plus the actual earnings thereon, is based on years of credited service. A participant is 100% vested after 6 years of credited service. While an employee, a participant will become 100% vested upon attainment of normal retirement age, which is age 55 under the Plan, death or disability.

Benefit Payments

Vested account balances are payable upon retirement, death or disability, or termination of employment. Normal retirement age under the Plan is age 55.

Forfeitures

Forfeited nonvested accounts as of September 30, 2024 and 2023 totaled \$3,102 and \$2,845 respectively. Forfeitures can be used to pay plan expenses, reduce future Company contributions or are reallocated to participant accounts as an additional nonelective contribution. There were no forfeitures used for the years ended September 30, 2024 and 2023.

NOTE 3: CERTIFICATION OF INVESTMENT INFORMATION

Capital Bank and Trust Company, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of September 30, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of September 30, 2024.

NOTE 4: FAIR VALUE MEASUREMENTS

FASB ASC 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 4: FAIR VALUE MEASUREMENTS, CONTINUED

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at September 30, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5: RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 6: INCOME TAX STATUS

The Plan is placing reliance on an opinion letter dated January 15, 2021 received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore not subject to tax under current income tax law. The Plan itself has not received a determination letter from the IRS. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As the Plan is tax-exempt, the Plan administrator has concluded that as of September 30, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7: PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by affiliates of Capital Bank and Trust Company, the Plan trustee. The investment transactions qualify as allowable party-in-interest transactions under the provisions of ERISA. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment. Actual fees paid by the Plan for recordkeeping also are intended to qualify as exempt party-in-interest transactions and are included in administrative expenses in the accompanying financial statements.

NOTE 8: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, employees become 100% vested in their account balances.

NOTE 9: RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Net assets available for benefits reported in the financial statements at September 30, 2024 and 2023 agree to net assets available for benefits reported at September 30, 2024 and 2023 in the Form 5500. There were no reconciling adjustments in either year.
