NOTES TO FINANCIAL STATEMENTS

DESCRIPTION OF PLAN

The following description of Jefferson Homebuilders, Inc. Employees' Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan of Jefferson Homebuilders, Inc., Culpeper of Fredericksburg, Inc., Culpeper of Columbia, Inc., Culpeper of New England, LLC, Culpeper of Roanoke Rapids, LLC, Culpeper of Belchertown, LLC, Culpeper of Athens, LLC, Culpeper of Fruitland, LLC, Culpeper of Federalsburg, LLC, Culpeper of Leola, LLC, Culpeper of Sweetwater, LLC, Culpeper of Orangeburg, LLC, Culpeper of Ramseur, LLC, Culpeper of Cove City, LLC, Culpeper of Branchville, LLC, and Culpeper Trucking, LLC (the Companies). The Plan covers all employees of the Companies who have at least one year of service and are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In August 2024, Culpeper of Federalsburg, LLC, a participating employer of the Plan, acquired an additional wood preserving facility located in Hebron, Maryland. Culpeper of Hebron, LLC is a single-member entity wholly-owned by Culpeper of Federalsburg. In September 2024, Jefferson Homebuilders, Inc. acquired two additional wood preserving facilities located in Elizabeth City, North Carolina and High Point, North Carolina. Culpeper of Elizabeth City, LLC and Culpeper of High Point, LLC are single-member entities wholly-owned by Jefferson Homebuilders, Inc. Upon acquisition, the Plan was amended to include these new companies as adopting employers of the Plan and to honor prior years of service with respect to eligibility and vesting within the Plan.

Contributions

Participants may elect to defer up to 100% pretax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). In addition, the Companies may make discretionary safe harbor and profit sharing contributions to the Plan. The Companies made safe harbor contributions for the year ended September 30, 2024 equal to 3% of eligible compensation, for a total safe harbor contribution of \$1,085,523. For the year ended September 30, 2024, the Companies made profit sharing contributions of \$2,382,900.

Participants direct the investment of pretax salary deferrals, rollovers, and employer safe harbor contributions into various investment options offered by the Plan. The Trustee directs the investment of profit sharing contributions to the Plan. Contributions are subject to certain limitations. Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

NOTES TO FINANCIAL STATEMENTS

Participant Accounts

Each participant's account is credited with (a) the participant's contribution, (b) an allocation of the Companies' contribution, and (c) an allocation of Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Companies' safe harbor contributions, plus actual earnings thereon. Vesting in the Companies' profit sharing contributions, plus earnings thereon, is based on years of continuous service. A participant is partially vested after two years of credited service and 100% vested after six years of credited service.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the vested interest in his or her account in either a lump-sum amount or in annual installments over a specified period, or to roll over the balance into an individual retirement account. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution.

Forfeited Accounts

Forfeitures may be used to reduce future employer contributions or pay Plan administrative expenses. At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$52,737 and \$20,954, respectively. Forfeited nonvested accounts amounting to \$52,737 were used to reduce employer contributions for the year ended September 30, 2024 that were paid during 2025. Forfeited nonvested accounts amounting to \$20,954 were used to reduce employer contributions for the year ended September 30, 2023 that were paid during 2024.

SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See the **FAIR VALUE MEASUREMENTS** note for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses paid by the Plan Sponsor are excluded from these financial statements. These fees will not be reimbursed by the Plan. John Hancock Life Insurance Company (U.S.A.) (John Hancock) investment-related expenses are included in the net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 14, 2025, which is the date the financial statements were available to be issued.

INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by John Hancock Life Insurance Company (U.S.A.) and was not subjected to any auditing procedures performed:

- a. Total investments and cash, as shown in the accompanying statements of net assets available for benefits, of \$52,783,531 as of September 30, 2024, and \$40,228,656 as of September 30, 2023.
- b. Net appreciation in fair value of investments, in the accompanying statement of changes in net assets available for benefits, of \$9,649,203 for the year ended September 30, 2024.
- c. All investment-related information in the accompanying supplementary Schedule H, Line 4i - schedule of assets (held at end of year) as of September 30, 2024.

FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of September 30, 2024 and 2023.

Pooled separate accounts are carried at fair value. Fair value of shares of an underlying fund equals the number of shares of the respective underlying fund multiplied by the closing net asset value per share quoted by that fund divided by units held by the pooled separate account. Unit values are calculated daily before taking into consideration unitholders' contributions and withdrawals made on that day. The prices are declared and posted daily on John Hancock's website and are the basis for transactions.

RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Company contributions to the Plan or benefits accrued or paid by the Plan for participants are not considered party in interest transactions.

The Plan allows for transactions with certain parties who may perform services for or have fiduciary responsibilities to the Plan, including the Companies. Certain Plan investments were managed by John Hancock, the custodian of the Plan, and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for these services amounted to \$186,061 for the year ended September 30, 2024.

PLAN TERMINATION

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in employer contributions.

TAX STATUS OF THE PLAN

The Plan Sponsor adopted Actuarial Benefits & Design Company's volume submitter plan document. The Internal Revenue Service has issued an opinion letter, dated June 30, 2020, that the volume submitter plan sponsored by Actuarial Benefits & Design Company is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has subsequently been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
