## Notes to Financial Statements

December 31, 2024 and 2023

### (1) Description of the plan

The following brief description of The Reese Group, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### (a) General

The Plan is a defined contribution plan covering all full-time employees of The Reese Group, Inc. (the “Plan Sponsor”) who are age twenty or older. The Plan, which was adopted by action of the Plan Sponsor’s Board of Directors on January 1, 1995, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### (b) Contributions

Each year, participants may defer up to 100% of their pretax annual compensation as defined in the plan agreement as well as after-tax Roth contributions, not to exceed the maximum annual amount as determined by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan Sponsor matched 100% of each participant’s contribution up to \$500 and \$400 for the plan years ended December 31, 2024 and 2023, respectively. The contribution for 2024 totaled \$48,304, which was reduced by forfeitures available of \$23,530 for a net deposit in 2025 of \$24,774. The Plan Sponsor may also contribute an additional discretionary contribution amount each year. However, an additional discretionary contribution was not made for 2024 or 2023.

#### (c) Participant accounts

Each participant's account is credited with the participant's contributions and the Plan Sponsor’s contributions, as well as allocations of plan earnings or losses. Participant accounts may be charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested balance.

#### (d) Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the Plan Sponsor’s contribution portion of their account plus actual earnings (losses) thereon is based on years of continuous service. A participant becomes 20% vested after two years of service and vesting increases 20% each year until the participant is 100% vested after six years of credited service.

**(1) Description of the plan, continued**

**(e) Payment of benefits**

On termination of service due to death, disability, retirement, or termination of service, a participant will receive a lump-sum or annuity distribution equal to the value of the participant's vested account.

**(f) Hardship withdrawals**

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals are limited to a participant's elective deferrals.

**(g) Forfeitures**

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor portion of their accounts. At December 31, 2024 and 2023, forfeited nonvested accounts available for future use totaled \$23,798 and \$19,000, respectively. Forfeitures totaling \$23,530 were used in 2025 against the Plan Sponsor contribution receivable as of December 31, 2024.

**(2) Summary of significant accounting policies**

**(a) Basis of accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**(b) Investment valuation and income recognition**

The Plan's investments are stated at fair value as reported by the custodian. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**(c) Contributions**

Contributions from plan participants and any respective matching contributions from the Plan Sponsor, if applicable, are recorded in the year in which the employee contributions are withheld from compensation.

**(2) Summary of significant accounting policies, continued**

**(d) Payment of benefits**

Benefits are recorded when paid.

**(e) Administrative expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to distributions are charged directly to the participant's account and are included in administrative expenses. The Plan holds assets in an expense balance account which receives deposits as a result of a revenue sharing agreement with a party-in-interest to the Plan. During 2024, deposits to the account were netted with administrative expenses and used to pay qualified plan expenses. See Note 6 for further disclosure.

**(f) Use of estimates**

The preparation of financial statements in accordance with U.S. generally accepted accounting principles ("GAAP") requires the Plan Sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**(g) Events occurring after the reporting date**

The Plan has performed an analysis of the activities and transactions subsequent to December 31, 2024, to determine the need for any adjustments or disclosures for the year then ended. The Plan has evaluated subsequent events through June 6, 2025, the date the financial statements were available to be issued.

**(3) Summary of information certified by the custodian**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments as of the date of the financial statements under audit and covered by the certification, and net appreciation in fair value of investments, and interest and dividends for the years ended December 31, 2024 and 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC ("Empower").

**(4) Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

(4) Fair value measurements, continued

The three levels of the fair value hierarchy under Topic 820 are described as follows:

**Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.**

**Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:**

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability; and
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3 – Inputs that are unobservable inputs for the assets or liability.**

Following is a description of the valuation methodologies used for assets measured at fair value.

*Common collective trust accounts* are valued at the net asset value (“NAV”) of units held by the account. The NAV, as provided by the custodians, is used to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a pooled separate account or common collective trust account, the investment advisor reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Guaranteed interest accounts* are valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer (see Note 8). Since the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, the Plan Sponsor evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate).

*Mutual funds* are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1 inputs).

**(6) Related party transactions**

Certain plan investments are managed by Empower. Empower is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Empower provides certain administrative services to the Plan pursuant to an agreement between the Plan Sponsor and Empower. Empower receives revenue from mutual fund service providers for services Empower provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the Plan.

If the revenue received by Empower from such mutual fund service providers exceeds the amount owed under the agreement, Empower remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay the Plan's administrative expenses or allocated to the accounts of the participants. During the plan year, there were no excess amounts. The Plan or Plan Sponsor may make a payment to Empower for administrative expenses not covered by revenue sharing.

**(6) Related party transactions, continued**

Certain administrative functions are performed by officers or employees of the Plan Sponsor and no such officer or employee receives compensation from the Plan.

Administrative expenses paid to the custodian and other parties-in-interest amounted to \$27,887 and \$22,316 for 2024 and 2023, respectively. The Plan Sponsor also pays for certain plan expenses for which it is not reimbursed by the Plan.

**(7) Plan termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**(8) Investment contract with insurance company**

The Plan has entered into an investment contract with the custodians, who maintain the Plan's contributions in guaranteed interest accounts. The accounts were credited with earnings of \$882 on the underlying investments and purchases totaling \$7,937, and charged for plan withdrawals and administrative expenses totaling \$535 in 2024. Net transfers into the fund amounted to \$6,337 in 2024. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the guaranteed interest accounts, which approximates fair value, was \$72,064 and \$57,473 as of December 31, 2024 and 2023, respectively. The average yield and crediting interest rates are reviewed on a quarterly basis for resetting and were 1.41% and 1.23% for 2024 and 2023, respectively.

**(9) Risks and uncertainties**

The Plan invests in various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits.

**(10) Income tax status**

The Plan Sponsor has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service ("IRS") dated November 14, 2022, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

**(10) Income tax status, continued**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(11) Benefits payable**

Amounts allocated to withdrawing participants that have been processed and approved for payable but not yet paid as of December 31, 2024 amounted to \$116,836.
