Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Misericordia University Tax-Deferred Annuity Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2024 and December 31, 2023, and for the period from January 1, 2024 to September 30, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Merger

As disclosed in Note 1 to the financial statements, the Plan merged into the Pennsylvania Association of Independent Colleges and Universities Multiple Employer Plan effective September 30, 2024 and all assets and liabilities were legally transferred as of that date. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Misericordia University Tax-Deferred Annuity Retirement Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Misericordia University Tax-Deferred Annuity Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Misericordia University Tax-Deferred Annuity Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Misericordia University Tax-Deferred Annuity Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan established effective January 1, 1956, as restated January 1, 2018. The Plan covered all employees, excluding student employees, of Misericordia University (the Organization). In addition, nonresident aliens, those covered by a collective bargaining agreement, students, clergy, and leased employees were not eligible to receive Organization contributions. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan management was responsible for oversight of the Plan and determined the appropriateness of the Plan's investment offerings, monitored investment performance, and reported to the Plan's management.

Effective September 30, 2024, the Plan merged into the Pennsylvania Association of Independent Colleges and Universities Multiple Employer Plan (MEP), and all assets were legally transferred to that plan on September 30, 2024.

Contributions

Each year, participants could contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants who had attained age 50 before the end of the plan year, as well as participants who had worked for the Organization for at least 15 years, were eligible to make catch-up contributions. Participants also could contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions, Organization matching contributions and an allocation of the Plan's earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled is the benefit that could be provided from the participant's account.

Vesting

Participants were vested immediately in their contributions and the Organization's contributions plus actual earnings thereon.

Notes Receivable From Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans were secured by the balance in the participant's account. The loan interest rate, determined daily, was set at the reasonable interest rate, as defined. Principal and interest were paid ratably through monthly payroll deductions. Terms ranged up to five years or greater for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant could elect to receive either a lump sum amount equal to the value of the participant's interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant could have received the value of the interest in his or her account as a lump sum distribution.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affected the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value (except for fully benefit-responsive investment contracts, which were reported at contract value). Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's management determined the Plan's valuation policies utilizing information provided by the investment advisers and custodians, as applicable. See Note 3 for discussion of fair value measurements.

The Plan's investments in fully benefit-responsive investment contracts were reported at contract value. Contract value was the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount participants normally would have received if they initiated permitted transactions under the terms of the Plan.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed as incurred.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Organization. Expenses that were paid by the Organization were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

Subsequent events were evaluated through July 15, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Separate accounts: Valued based on NAV per unit of participation in the accounts. The NAV was based on the fair value of the underlying investments held by the account less its liabilities and was considered to be a readily determinable fair value (RDFV). The accounts invested principally in equity securities, fixed income instruments and short-term instruments in accordance with each account's investment objectives.

Investment measured at NAV: Consisting of a separate account, valued at the NAV of units of participation in that account. The NAV, as provided by a custodian, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient was not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) could occur daily. Were the Plan to initiate a full redemption of the account, the investment adviser reserved the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations would be carried out in an orderly business manner.

Investment contracts at fair value: The guaranteed annuity contracts consisted of the Teachers Insurance and Annuity Association (TIAA) Traditional Annuity Account's RA and RC subaccounts and were reported at fair value, which approximated contract value per TIAA, based on TIAA's ability to pay the guaranteed claims in accordance with the terms of the contract. As of December 31, 2023, TIAA's credit ratings were as follows: A++ by A.M. Best Company, AAA by Fitch Ratings, Aa1 by Moody's Investors Service and AA+ by Standard & Poor's. The high credit ratings of TIAA as of the measurement date upheld their ability to meet obligations set forth in the contract.

Contract value was the aggregation of contributions, plus interest, less withdrawals, if any. Crediting rates were a combination of a guaranteed rate and an annually established discretionary rate. Additionally, the discretionary rate applied to contributions received during a reporting period may have varied from the discretionary rate applied to account balances at the end of the prior reporting period. Contract value approximated a discounted cash flow value calculated using an appropriate risk-adjusted market discount rate, which correlated closely with the historical crediting rates.

The TIAA Account had redemption restrictions based on the terms of the underlying contract selected by the participant and loan agreements with participants and claims against the contracts were solely supported by TIAA's ability to pay on such claims. The redemption restrictions did not have a material impact on the contract value.

4. Concentrations

At December 31, 2023, the Plan had \$30,693,186 that was concentrated in two investments.

5. Fully Benefit-Responsive Investment Contracts

The Plan offered the option to invest in the TIAA Traditional Annuity Account, a guaranteed annuity contract with TIAA. Plan participants entered into these contractual agreements with TIAA by selecting a TIAA Traditional Annuity Account. Participants of the Plan previously invested in the following transitional accounts: Group Supplemental Retirement Annuity (GSRA), Supplemental Retirement Annuity (SRA) and Retirement Annuity (RA). Currently, all new contributions, rollovers and external transfers were directed into the Retirement Choice (RC) or Retirement Choice Plus Annuity (RCP) accounts. All amounts in the GSRA, SRA and RA accounts remained in those accounts until distributed or transferred to another investment option by the participant.

The RCP, GSRA and SRA were considered fully benefit-responsive and were reported at contract value. Contract value, as reported to the Plan by TIAA, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The RA and RC were considered non fully-benefit responsive and were reported at fair value, as disclosed in Note 3.

The TIAA Traditional Annuity Account was a single group annuity contract with a fixed rate of interest. Interest was credited to the account and accumulations included a guaranteed rate, plus discretionary additional amounts determined annually by the TIAA Board of Trustees. The additional amounts, when declared, remained in effect through the "declaration year", which began each March 1. The guaranteed annual interest rate was 3% for all premiums remitted since 1979 under all TIAA Traditional Annuity accumulating contracts with the exception of the RC account. For the RC account, the guaranteed rate was between 1% and 3%. They was not a portfolio of contracts whose yields were based on changes in fair value of underlying assets, therefore the average yield earned by the Plan was the interest earned on the group annuity contract.

There were no reserves against contract value for credit risk of TIAA or otherwise. The crediting interest rate was based on a formula agreed upon by TIAA, which would not be less than zero. Such interest rates were reviewed on an annual basis for resetting. The TIAA Traditional Annuity Account did not permit TIAA to terminate the agreement prior to the scheduled maturity date.

No events occurred that limited the ability of the Plan to transact at contract value with TIAA nor limited the ability of the Plan to transact at contract value with the participants.

6. Information Certified by Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, TIAA and the College Retirement Equities Fund (CREF), the Custodians of the Plan, have certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of September 30, 2024 and December 31, 2023, and the related investment activity reported in accompanying Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2024 to September 30, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

7. Related-Party and Party in Interest Transactions

Certain plan investments were managed by TIAA and CREF, the Custodians, and therefore, these transactions qualified as party in interest transactions.

Fees incurred by the Plan for the investment management services were included in net appreciation (depreciation) in the fair value of the investment, as they were paid through revenue sharing, rather than a direct payment. The Custodians received revenue from investment fund service providers for services the Custodians provided to the funds. This revenue was used to offset certain amounts owed to the Custodians for its administrative services to the Plan. If the revenue received by the Custodians from such investment fund service providers exceeded the amount owed for its services, the Custodians remitted the excess to the Plan's trust on a quarterly basis. The Plan or Plan Sponsor may make a payment to the Custodians for administrative expenses not covered by revenue sharing.

Additionally, the Plan issued loans to participants, which were secured by the participant's account balances. These transactions qualified as party in interest transactions.

Certain administrative functions of the Plan were performed by officers or employees of the Organization. No such officer or employee received compensation from the Plan.

8. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

9. Tax Status

The Plan adopted a volume submitter plan offered by TIAA, stating that the written form of the underlying specimen plan was qualified under Section 403(b) of the IRC. The volume submitter plan received an Opinion (Advisory) Letter dated August 7, 2017, that the Plan was designed in accordance with the applicable sections of the IRC. Although the Plan had been amended since receiving the Opinion (Advisory) Letter, the plan administrator believes that the Plan was designed, and was operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan was qualified, and the related trust was tax exempt.

Plan management was required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
