Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The First National Bank in Sioux Falls Employees Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Description of Plan

The following is not a complete description of The First National Bank in Sioux Falls Employees Profit Sharing Plan (the Plan) and provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering qualified employees of The First National Bank in Sioux Falls (the Company) and Minnehaha Banshare Inc. (MBI). MBI owns 100% of The First National Bank in Sioux Falls. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established effective December 31, 1950. The Plan Administrator is the Retirement Plan Committee appointed by the Company.

Eligibility: Employees are eligible to participate in the deferral portion of the Plan if they have attained the age of 18. Employees are eligible to receive a profit sharing contribution after completing one year of service, attainment of age 18, and are employed on the last day of the Plan year. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has completed 1,000 or more hours of service. Employees are eligible to receive the profit sharing contribution if employment is terminated during the Plan year due to being deceased or disabled, or reaching normal retirement age.

Entry date: Employees may enter the deferral portion of the Plan immediately when they satisfy the Plan's eligibility requirements. Employees begin to participate in Company profit sharing contributions starting on the first day of the calendar month after meeting eligibility requirements.

Contributions: Each year, participants may contribute up to 85% of their pretax annual compensation, as defined by the Plan, but may not exceed the limits of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows participants to designate contributions as Roth 401(k) contributions. New participants are automatically enrolled in the Plan to contribute an automatic 3% of their compensation, unless they elect a different deferral percentage or elect to opt out. The Company contributes a profit sharing contribution equal to a fixed contribution of 10% of participants' eligible compensation. Additional amounts may be contributed at the discretion of the Company's Board of Directors. The Company contributed a total of 15% of participants' eligible compensation for the year ended December 31, 2024, which consisted of the fixed contribution of 10% as well as a 5% discretionary contribution. Participants may also contribute amounts representing distributions from other qualified plans. Contributions are subject to certain IRC limitations.

Participant accounts: Participant accounts are credited with the participant's contributions and allocations of the Company's contributions and Plan investment earnings. Participant accounts are charged for any administrative expenses related to the specific participant. Allocations are based on participant's compensation or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options: Participants may direct employee and Company contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options daily.

Notes to Financial Statements

Note 1. Description of Plan (Continued)

Vesting: Participants are vested immediately in their contributions, plus earnings thereon. Vesting in the Company's contributions and related earnings is based on years of credited service. A participant is 30% vested after one year, 40% after two years, 50% after three years, 60% after four years, 80% after five years and 100% after six years of credited service. Participants also become 100% vested upon death, disability or attainment of normal retirement age (65).

Forfeitures: As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,433 and \$27,006, respectively. These accounts will be allocated to participants or used to fund future Company contributions. During the year ended December 31, 2024, approximately \$27,000 from forfeited nonvested accounts were used to fund Company contributions.

Payment of benefits: Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or installments, as defined in the Plan document, if their account exceeds \$7,000, upon retirement, termination, death or disability. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$7,000 may be automatically paid out, with the balance rolled into a qualified individual retirement account. Distributions may be made at the participant's election prior to termination upon attainment of age 59½ as further described in the Plan document.

Death benefits: The designated beneficiary is entitled to a death benefit distribution equal to the participant's vested account balance.

Risks and uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 2. Significant Accounting Policies

Basis of presentation: The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion on fair value measurements.

Note 2. Significant Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions: Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. Profit sharing contributions from the employer are recorded in the year in which the eligible compensation is earned.

Payments of benefits: Benefit payments to participants are recorded upon distribution.

Administrative fees: Administrative expenses of the Plan are generally paid by the Company, and are excluded from these financial statements. In the event Plan expenses are not paid by the Company, such expenses become the responsibility of the Plan.

Subsequent events: The Plan Administrator has evaluated subsequent events through July 11, 2025, the date that the financial statements were available to be issued.

Note 3. Information Certified by the Custodian

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Matrix Trust Company, the custodian of the Plan. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

Note 4. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Money market mutual funds: Money market mutual funds are valued at the net asset value (NAV) of shares held by the Plan as of year-end, as a practical expedient.

Mutual funds: Mutual funds are valued at the NAV of identical shares as determined in active markets, held by the Plan as of year-end.

Collective trust fund: The collective trust fund is valued at fair value based on the NAV of the underlying assets held in the fund, as a practical expedient.

Cash surrender value of life insurance contracts: The cash surrender value of life insurance contracts are valued at the cash surrender value of the policies held as reported by the insurer, which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The objective of the money market mutual funds are to seek maximum current income, consistent with preservation of capital and maintenance of liquidity, by investing in a diversified portfolio of short-term U.S. government securities.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6. Income Tax Status

The Plan uses a nonstandardized form of a preapproved plan sponsored by OneAmerica Financial Partners Inc. OneAmerica Financial Partners Inc. received an opinion letter from the Internal Revenue Service (IRS), dated August 19, 2020, which states the preapproved plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related-Party and Party-in-Interest Transactions

Certain Plan investments as of December 31, 2023 were shares of a collective trust fund managed by an affiliate of OneAmerica Retirement Services LLC. OneAmerica Retirement Services LLC is the Plan's third-party administrator; therefore, this transaction qualifies as an exempt party-in-interest transaction.
