## **Note 1 – Plan Description and Basis of Presentation**

The following description of the BAPKO Metal, Inc. Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**Eligibility and Coverage** – The Plan was established on January 1, 2014 and was restated as of October 1, 2021. The Plan is a defined 401(k) profit sharing plan covering all eligible employees of BAPKO Metal, Inc. (the “Company” and “Plan Sponsor”) who have completed 90 days of service and have attained age 18. Participants, once eligible, may begin deferring a portion of their compensation into the Plan on the first day of the quarter coinciding with or next following the date on which such Employee met the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and Section 401(a) of the Internal Revenue Code (“IRC”). The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance.

**Participant Contributions** – Participants can contribute up to 100% of their salaries. In 2024, not more than \$23,000 may be contributed. Participants ages 50 or older may elect to defer additional amounts (called “catch-up” contributions) to the Plan. The maximum “catch-up” contribution that can be made in 2024 is \$7,500. The additional amount can be deferred regardless of any other limitations on the amounts that can be deferred to the Plan. Participants also have the option to make elective after-tax contributions to a Roth 401(k). Total Roth contributions for the year ended September 30, 2024 were approximately \$40,000. In addition, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“rollover”).

**Employer Contributions** – The Plan Sponsor has elected to provide a safe harbor contribution to each participant who has a deferral election on file. Participants will receive an allocation based upon eligible compensation as defined in the Plan agreement. The Plan Sponsor may also make a discretionary profit sharing contribution. Employees receive a pro rata allocation based upon the employee’s compensation. Contributions are subject to certain Internal Revenue Service limitations. During the year ended September 30, 2024, the Company made safe harbor and discretionary contributions of approximately \$436,000.

All contributions made on a participant’s behalf are deposited in the trust and allocated among the investment funds in accordance with the participant’s investment elections. A participant may elect to transfer investments from any investment fund to any other investment fund on a daily basis.

**Participant Accounts** – Each participant’s account is credited with the participant’s contributions, allocations of the Plan Sponsor’s contributions, Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** – Participants are immediately vested in their contributions and related investment activity thereon. Participants vest in Plan Sponsor contributions in annual ratable installments of 20% after the second year of service. Participants are fully vested upon attaining normal retirement age of 65.

**Forfeitures** – If a participant terminates prior to vesting 100% in the employer contributions, the forfeited balance will be used to reduce administrative expenses and future employer contributions. For the year ended September 30, 2024, employer contributions were reduced from forfeited non-vested accounts by \$17,387. At September 30, 2024 and 2023, there were no forfeited non-vested accounts.

**Payment of Benefits** – The Plan provides for the payment of benefits to the participant (or, if applicable, the beneficiary) at retirement, disability, death, financial hardship, or termination of employment. In-service distributions are also available to those participants who are age 62 or older. Participants who qualify for retirement benefits and withdrawals will receive their benefits as a lump sum in cash. The benefit to which a participant is entitled is the benefit that can be provided solely from the participant's vested account balance. Participants who separate from service and have vested account balances of \$5,000 or less are subject to an administrative lump sum distribution.

**Administrative Expenses** – As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

## **Note 2 – Summary of Significant Accounting Policies**

**Basis of Accounting** – The accompanying financial statements are prepared on the accrual basis of accounting under accounting principles generally accepted in the United States of America.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are stated at fair value and contract value as determined by John Hancock Life Insurance Company (U.S.A.). The carrying value of interest bearing money market accounts equal their fair value. Increases or decreases in fair value are recognized currently. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits** – Benefits are recorded when paid.

**Risk and Uncertainties** – The Plan provides for various investment securities. These investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with these securities and the level of uncertainty related to changes in value, it is at least reasonably possible that changes in the various risk factors in the near term would materially affect participants' account balances and the amounts reported in the accompanying financial statements.

## **Note 3 – Custodian Certification**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at September 30, 2024, and 2023, and net appreciation (depreciation) in fair value of investments, and interest and dividends for the year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (the custodian of the Plan).

## **Note 4 – Fair Value Measurements**

The accounting standards regarding fair value measurements define fair value, establish a framework for measuring fair value, and provide for enhanced disclosures about fair value measurements. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

- Level 1 Valuation is based upon quoted prices in active markets for identical securities.
- Level 2 Valuation is based upon other observable inputs (including quoted prices for similar securities, interest rates, prepayment speeds, credit risk, etc.).
- Level 3 Valuation is based upon unobservable inputs significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in methodologies used at September 30, 2024 and 2023.

### *Pooled Separate Accounts*

These investments are privately managed accounts valued using the net asset value (“NAV”) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. As the investments can be redeemed at NAV as of the measurement date, the administrator of the fund believes the investments have a “Readily Determinable Fair Value”.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Below are the Plan’s financial instruments carried at fair value on a recurring basis by the fair value hierarchy levels established in current accounting standards.

## **Note 5 – Related Party Transactions**

Certain Plan investments are shares of mutual funds managed by John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Fees paid by the Plan to the third party administrator and custodian for administrative expenses and other related fees related to the Plan's operations totaled approximately \$52,000 for the year ended September 30, 2024.

## **Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants' rights to their accrued benefits are non-forfeitable.

## **Note 7 – Income Tax Status**

The Plan has adopted the provisions of a volume submitter 401(k) Plan. The Plan obtained its latest opinion letter from the Internal Revenue Service dated December 29, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of September 30, 2024.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Note 8 – Subsequent Events**

The Plan has evaluated subsequent events through July 9, 2025, the date which the financial statements were available to be issued and concluded that there were no other events that require additional disclosure.
