Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of the Zinus, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements ("2024 Financial Statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1 – Description of the Plan

Zinus, Inc. 401(k) Plan (the “Plan”) is a defined contribution plan covering substantially all eligible employees of Zinus, Inc. (the “Plan Sponsor”). The Plan became effective December 28, 2019, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All Plan assets are held by Empower Trust Company, LLC (“Empower”) and Empower Annuity Insurance Company of America (“EAIC”). Participants should refer to the plan document for a more complete description of the Plan’s provisions.

Administration - The Plan Sponsor has contracted with Empower and EAIC to act as the custodian to the Plan, as well as an affiliate of Empower to process and maintain the records of participant data.

Eligibility – The Plan covers substantially all employees of the Plan Sponsor except union employees covered by a collective bargaining agreement, leased employees, certain nonresident aliens, and employees of any employer acquired unless otherwise stated. Eligible employees who are at least 21 may participate in the Plan after completing three months of service, as defined in the plan document.

Contributions - Participants are allowed to make elective pre-tax or after-tax (Roth) contributions to the plan of up to 100% of their annual eligible plan compensation, as defined by the plan document, subject to limitation under the Internal Revenue Code (“IRC”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing rollovers from other qualified retirement plans or individual retirement accounts.

Eligible employees are automatically enrolled in the Plan with a pre-tax contribution rate of 4% of their eligible compensation, unless they affirmatively opt out of participation.

The Plan Sponsor makes safe harbor matching contributions equal to 100% of the first 4% of the participant’s eligible deferred compensation, as defined in the plan document, for a total of approximately \$430,000 for the year ended December 31, 2024.

Participants direct the investment of contributions to their respective accounts into the investment options offered by the Plan.

Participant accounts - Participants direct the investment of their accounts among various investment options offered by the plan. Participants may change their investment options daily.

Each participant account is credited with (a) the participant’s contributions, (b) an allocation of employer contributions, and (c) certain administrative expenses. Allocations are based on participant earnings or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their elective contributions, rollover contributions, safe-harbor matching contributions, plus earnings thereon.

Notes receivable from participants - Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum of (a) \$50,000 reduced by the highest outstanding note receivable balance over the prior twelve months or (b) 50% of their vested account balance, whichever is less. Notes receivable from participants (“participant loans”) are secured by the vested balance in the participant’s account balance and bear interest. Principal and interest are paid ratably through payroll deductions over a period generally not to exceed five years, unless the funds are used for purchase of a principal residence, in which case repayment terms may be longer. Participant loans bear a rate of interest equal to the prime rate plus 1%.

Note 1 – Description of the Plan (continued)

Payment of benefits - Upon termination, the participants or beneficiaries may elect to leave their account balance in the Plan or receive their total vested benefits in a lump-sum amount. The Plan allows for the automatic lump-sum distribution of participant vested account balances that do not exceed \$5,000. Distributions are subject to the applicable provisions of the plan document.

In-service withdrawals of all or a portion of a participant's vested account balance may be withdrawn by a participant after reaching age 59 ½. In-service withdrawals of all or a portion of a participant's rollover account balance may be withdrawn at any time.

Withdrawals from the Plan may also be made upon circumstances of financial hardship in accordance with the provisions specific in the Plan document.

Distributions from the Plan will normally be subject to income taxes and in certain circumstances may also be subject to IRS penalties, unless the distribution is transferred to another qualified plan or individual retirement account.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates - The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits, and changes therein and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition – The investments are reported at fair value. The Plan's custodian, Empower, certifies the fair market value of all investments, except fully benefit responsive investments contracts, of which the contract value is certified by EAIC. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit responsive investment contracts because the contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants (notes receivable), are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent notes receivable are reclassified as distributions upon the occurrence of a distributable event based upon the terms of the plan document.

Payment of Benefits – Benefits are recorded when paid.

Plan Expenses – Certain expenses of maintaining the Plan are paid by the Plan Sponsor and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Certain transaction and maintenance fees are paid by the Plan.

Subsequent events – Effective January 1, 2025, the custodian to the Plan changed from Empower and EAIC to ADP Retirement Trust Services, LLC. The transition had no impact on the net assets available for benefits of the Plan as of December 31, 2024 and 2023. The Plan has evaluated subsequent events through July 09, 2025, which is the date the financial statements were available to be issued.

Note 3 – Information Certified by the Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower and EAIC, the custodians of the Plan, have certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments and notes receivable from participants reflected on the schedule of assets (held at end of year).

Note 4 – Fair Value Measurements

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4 – Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024, and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end investments that are registered with the U.S. Securities and Exchange Commission. These investments are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Collective Trust Funds: Units held in the collective trust funds (CCTs) are valued using the NAV practical expedient of the CCTs as reported by the CCT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by each CCT, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a CCT is calculated based on a compilation of primarily observable market information. There are no significant restrictions on redemption of units of investment in the funds.

Self-directed brokerage accounts: Investments elected by participants through the Plan’s individual brokerage accounts option include interest-bearing cash and common stock. All investments included in the brokerage accounts are valued at the closing price reported on the active market on which the individual securities are traded. Interest-bearing cash is valued at cost plus accrued interest.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Tax Status

The Plan has adopted a non-standardized pre-approved profit sharing plan document that has received an opinion letter dated November 23, 2020, from the Internal Revenue Service. The Plan Administrator believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the IRC and related state statutes, and therefore is exempt from federal income and state franchise taxes.

In accordance with guidance on accounting for uncertainty in income taxes (ASC 740-10), management evaluated the plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is at least reasonably possible given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

Note 7 – Related-Party and Party in Interest Transactions

Certain Plan investments are managed by Empower and EAIC, the custodians of the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan Sponsor pays certain fees and expenses on behalf of the Plan. These transactions qualify as party in interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

Note 8 – Prohibited Transactions

From 2021 through 2023, the Plan Sponsor erroneously failed to remit certain participant deferrals and loan repayments of \$73,573 within the period allowed by the DOL, of which \$25,937 remain uncorrected as of December 31, 2024. The Plan Sponsor intends to make contributions to the affected participants' accounts to compensate those participants for lost earnings due to the delays.

Note 9 – Operational Defects

The Plan Sponsor erroneously failed to withhold participant deferrals on bonuses and other eligible compensation for plan years 2021 and 2022. The Plan Sponsor also failed to enroll certain eligible employees in the Plan in a timely manner during 2022 and 2023. These contributions, along with calculated lost earnings, were fully remitted through self-correction subsequent to year end.

Note 10 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.
