We have performed audits of the financial statements of Keystops, LLC Employee Savings Plan (Plan), an employee benefit Plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**Note 1. Description of the Keystops, LLC Employee Savings Plan**

The following description of the Keystops, LLC (Company) Employee Savings Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution Plan sponsored by the Company for the benefit of its employees who have completed 90 consecutive days of service with at least 1 hour. Related employers who also participate in the Plan include Service Transport, LLC, Southern Kentucky Maintenance, LLC, and Key and Key Trucking, Inc. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Certain employees are the trustees of the Plan.

Prior to January 23, 2024, John Hancock Life Insurance Company (John Hancock) served as the custodian of the Plan. On January 24, 2024, Principal Financial Services, Inc. (Principal) became custodian of the Plan.

***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of eligible compensation. Employee rollover and Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Prior to December 31, 2023, the Plan permitted the Company to make discretionary profit-sharing contributions as directed by the Company's board of directors. After January 1, 2024, the Plan now permits the Company to make discretionary matching contributions using a uniform percentage each year. Contributions are subject to certain limitations.

***Participant Investment Account Options***

Each participant has the option of directing contributions into any of the various investment options offered by the Plan and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Company's contributions, Plan earnings, and forfeitures of terminated participants' nonvested accounts. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions, plus earnings thereon. Vesting in the Company's contribution portion of their accounts, plus earnings thereon, is based on years of continuous service. A participant is fully vested after six years of continuous service. The nonvested balance is forfeited upon termination of service. Forfeitures are allocated among active participants based upon compensation.

***Payment of Benefits***

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account if the total account balance is greater than \$5,000. All accounts with less than \$5,000 may only receive a lump-sum. Participant's attaining an age of 59½, normal retirement age, or separation of employment due to active duty, may also elect to receive a distribution of up to 100% of the participant's vested account.

***Forfeited Accounts***

At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$1,498 and \$7,481, respectively. Forfeitures are reallocated to participants in the same manner as employer contributions.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the quoted market price of shares held by the Plan at year-end.

The Plan's interest in the pooled separate accounts are valued at the net asset value (NAV) as provided by Principal and John Hancock. The NAV is used as a practical expedient to estimate the fair value of the pooled separate accounts.

Guaranteed interest contracts valued at fair value are calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants before December 15, 2024.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Custodian**

The Plan administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, the custodian of the Plan, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of September 30, 2024. Investments shown in the statements of net asset available for benefits as of September 30, 2023 were certified by John Hancock.
- Investment income as shown in the statements of changes in net assets available for benefits for the period from January 24, 2024 to September 30, 2024. For the period beginning October 1, 2022 through the period ending January 23, 2024, investment income as shown in the statements of changes in net assets available for benefits was certified by John Hancock.
- Investment information included in the accompanying schedule of assets (held at end of year) as of September 30, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such information to the related information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Plan Amendment**

Effective January 1, 2024, the Plan was amended and restated (Plan Amendment) and a new custodian of the Plan was appointed. Plan assets were transferred to the new custodian and invested in funds outlined in the service agreement and approved by Plan trustees. The conversion initiated a "Black Out" period beginning January 16, 2024, and continued through February 18, 2024. During this period, funds could not be applied to the employee-selected funds with the custodian or withdrawn from the Plan until the custodian had time to accurately complete the conversion. During this period, employee contributions continued to be made through payroll deductions, and the contributions were deposited and held in the Principal Guaranteed Option fund until the completion of the Black Out period. At the end of the Black Out period, these funds were invested in funds as requested by each participant or as directed by Plan trustees. In addition, the Plan was amended to provide a discretionary Company match of participant contributions. The match percentage is determined annually by the Company. The Plan was also amended to permit employee Roth contributions.

**Note 5. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer, or employee association or relatives of such persons.

Certain Plan investments are units of pooled separate accounts and guaranteed interest accounts managed by Principal and John Hancock. Principal and John Hancock served as Plan custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan sponsor pays directly any other fees related to the Plan's operations.

The Plan paid \$30,247 and \$0 of administrative fees during 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

**Note 6. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets.
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits. There have been no significant changes in the valuation techniques during the years ended September 30, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**Level 3 Activity**

During the years ended September 30, 2024 and 2023, the Plan purchased guaranteed interest accounts of \$123 and \$356, respectively. During the years ended September 30, 2024 and 2023, the Plan sold guaranteed interest accounts of \$6,158 and \$188, respectively.

The pooled separate accounts are valued based upon the NAV of the funds multiplied by the units held by the Plan at year-end. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. The underlying investments of the pooled separate accounts consist solely of mutual funds and the investment strategy of the respective pooled separate accounts aligns directly with the investment strategy of the underlying mutual fund investments.

Large-cap pooled separate accounts seek growth of capital and invest primarily in common stocks and seek to invest in companies that appear to offer superior opportunities for growth of capital. Mid-cap pooled separate accounts seek capital appreciation primarily in stocks of leveraged companies. Small-cap pooled separate accounts invest primarily in companies with lower market capitalization at the time of purchase and have potential for capital appreciation. International pooled separate accounts invest in non-U.S. companies offering opportunities for long-term growth of capital. Balanced pooled separate accounts seek to provide an aggregate total return of the market index composed of small-, medium-, or large-sized U.S. companies. Bond pooled separate accounts seek to provide consistent income through investments in debt securities offered by U.S. corporations and government agencies.

**Note 7. Investment Contract with Insurance Company**

The Plan entered into a fully benefit-responsive investment contract with Principal Life Insurance Company (Principal Life). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 8. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 9. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype profit-sharing/401(k) Plan and trust sponsored by Retirement Management Services, LLC. The Plan has not obtained or requested a determination letter. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan was the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in the values of investment securities will occur in the near term and such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 11. Subsequent Events**

Subsequent events have been evaluated through July 14, 2025, which is the date the financial statements were available to be issued.
