## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator of the  
Midway Products Group, Inc. 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Midway Products Group, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Midway Products Group, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### **Opinion**

### **Basis for Opinion**

**NOTE A - DESCRIPTION OF PLAN**

The following plan description of the Midway Products Group, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a single-employer plan covering all eligible employees of a group of businesses under common control (Company). The businesses include P & A Industries, Inc., Midway Products Group, Inc., Hudson Industries, Inc., Lakepark Industries of Indiana, Inc., Lakepark Industries, Inc., Findlay Products Corp., Progressive Stamping, Inc., Production Products, Inc., and GT Industries.

The Plan is a defined contribution plan covering all employees of the Company who have 90 days of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Company makes contributions to the 401(k) Trust on behalf of eligible employees at the direction of the employees (participants' contribution). The Company may make matching company contributions to the Trust which are dependent upon the amount of contributions the individual employees elect to have the Company make on their behalf. Currently, employees may elect to have the Company contribute, pre-tax, between 1% to 100% of their compensation, up to the maximum IRS limit, to the Trust. Upon eligibility, employees are automatically enrolled with a 4% contribution, unless the employee states otherwise. Employees may also designate all or a portion of their deferral contributions as ROTH elective deferral contributions. All active participants may also make voluntary and rollover contributions.

The company has the option to make a qualified nonelective contribution, voluntary contribution, and/or discretionary contribution for active participants on December 31. To receive the discretionary contribution, eligible employees must be active participants and have worked 1,000 or more hours during the year.

Participant accounts

The participant accounts are credited with each participant's contribution and allocation of the Company's discretionary contributions and Plan earnings and charged with an allocation of any administrative expenses. Allocations are based on the participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their participant and qualified nonelective contributions as well as any voluntary and rollover contributions, plus actual earnings thereon. Vesting in the remainder of their accounts (employer discretionary contributions) is 100% after one year of service.

NOTE A - DESCRIPTION OF PLAN – CONTINUED

Forfeited accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,750 and \$958, respectively. Forfeitures may first be used to pay Plan expenses. Any remaining forfeitures after paying Plan expenses are used to offset future employer contributions. During 2024, plan expenses and employer contributions were reduced by \$35,514 from forfeited nonvested accounts.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear fixed interest at rates ranging from 3.25% to 8.50%, which are commensurate with local prevailing rates as determined periodically by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Payment of benefits

On termination of service due to death, disability, retirement or other reason, a participant with a vested balance of more than \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a fixed period of whole years.

If a participant's vested balance is \$5,000 or less, the value of the vested interest will be paid out as a single lump sum.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED**

Investment valuation and income recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation, or depreciation, includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment, or a deemed distribution, based on the terms of the Plan document.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation, or depreciation, in value of investments.

Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participants' accounts.

Payment of benefits

Benefits are recorded when paid.

Date of management's review

Subsequent events have been evaluated through June 18, 2025, which is the date the financial statements were available to be issued.

**NOTE D - TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Trustee by a letter dated June 30, 2020 that the Prototype Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE E - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 – Inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

Level 2 – Inputs consist of observable inputs other than quoted prices for identical assets (Level 1).

Level 3 – Inputs are unobservable and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs are used if Level 1 or Level 2 inputs are not available.

Following is a description of the valuation methodologies used for the assets measured at fair value.

Mutual funds: Values are based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

Collective investment trusts (CITs): The CITs invest in a collective trust fund as well as a variety of separate accounts and mutual funds. The fair value of the collective trust fund and the separate accounts are not publicly quoted pricing units but are available to current investors through the trustee's website. The fair value of all these investments is used in determining the net asset value (NAV) of the CITs. The NAV is the basis for current transactions, and the CITs can be redeemed at NAV as of the measurement date. Therefore, the trustee believes these investments have a readily determinable fair value and are valued similar to mutual funds, which have publicly quoted pricing inputs. Based on this, the trustee believes the CITs should be Level 1 assets.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023 are reported in net appreciation (depreciation) in value of investments.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers of investments into or out of Level 3.

**NOTE F - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE G - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In 2008, the Plan entered into a benefit-responsive investment contract, Principal Fixed Income Guaranteed Option (PFIGO), with Principal Life Insurance Company (PLIC). PLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract (GIC) meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIC. The GIC is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by PLIC, represents contributions made under contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on an agreed-upon formula with the issuer, but it may not be less than 4.75%. Certain events limit the Plan's ability to transact at contract value with PLIC. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

**NOTE H - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' accounts will become 100% vested in their employer contributions.

NOTE I - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal Trust Company, the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

Fees paid by the Plan to Principal Trust Company for the investment management services amounted to \$75,066 and \$66,427 for the years ended December 31, 2024 and 2023, respectively.

Investment commissions are also paid by the trust fund and allocated to each respective participant. The amount is netted against participant earnings. The trust fund incurred no commission expenses for the years ended December 31, 2024 and 2023.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
