## **Note 1. Description of Plan**

### ***General***

The following description of the Port Consolidated 401(k) Salary Reduction Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

The Plan, which has an initial effective date of September 15, 1973 and a restatement effective date of January 1, 2016, is classified as a defined contribution 401(k) plan, covering employees of Port Consolidated Inc. (the “Company”) with at least one year of service, at least 1,000 hours of service during the Plan year, and who attained the age of 21. The primary purpose of the Plan is to provide retirement savings benefits to employees of the Company, which is the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan’s funds are held by John Hancock Trust Company, LLC (the “Plan Custodian”).

### ***Contributions***

Each year participants may contribute a percentage of their compensation via a salary reduction agreement, not to exceed the Internal Revenue Service (“IRS”) limit. The employer may make discretionary matching contributions on behalf of each participant at an amount equal to a percentage of the participant’s total deferral contributions made during such Plan year. For the year ended September 30, 2024, the Company contributed 50% up to the first 6% of the employee’s contribution to the Plan.

### ***Participant Accounts***

Under the Plan, a separate account is maintained for each participant. Each participant’s account is credited with the participant’s contributions, employer contributions, and allocations of Plan earnings, and is charged with an allocation of administrative expenses, if any. Participant contributions and employer matching contributions are allocated, at the participant’s election, to investment funds held by the Plan Custodian. Plan earnings are allocated based on actual earnings of the respective participant’s investments. Participants may change their investment options at any time with certain exceptions.

### ***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service, with 25% vesting beginning annually in year two.

### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50% of their vested account balance, but not to exceed \$50,000, by executing a note in accordance with the Plan’s provisions. A participant may only have one loan outstanding at a time. The notes are collateralized by the balance in the participant’s account and bear interest at rates from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

### ***Payment of Benefits***

Upon the death, permanent disability, or retirement of participants, their entire account balances become fully vested. Benefit payments are to be made in a lump-sum payment equal to the value of the account. Participants who terminate for reasons other than death, disability, or retirement are entitled only to their vested balances.

## **Note 2. Summary of Significant Accounting Policies**

The following is a summary of significant accounting policies followed in the preparation of these financial statements, which have been prepared in accordance with accounting principles generally accepted in the United States of America.

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared using the accrual method of accounting.

### ***Investment Valuation and Income Recognition***

The Plan's investments are held in mutual and money market funds and in an investment contract. Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan Custodian also offers investment contracts, which has the John Hancock Stable Value Fund as the underlying investment option. Investments held in the John Hancock Stable Value Fund were deemed to be fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Interest is credited, based upon the daily balance of the John Hancock Stable Value Fund, at a rate that is the daily equivalent of the effective annual rate of interest applicable for a six-month period. Interest rates are established every January 1 and July 1, and will generally be valid for six months. All regular ongoing contributions and contributions already invested in the fund will earn the declared interest rate until the next rate reset. The interest rate will never be less than 1%. The average yield earned by the Plan is equal to the actual interest rate credited to Plan participants. The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent upon the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants is not probable of occurring.

Withdrawals influenced by Company-initiated events, such as reallocation of investments, may result in a distribution at other than contract value. There are no reserves against contract values for credit risk of contract issuers or otherwise.

Purchases and sales of marketable securities are reflected on a trade-date basis, and interest income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation or depreciation in the fair value of the Plan's investments for each year is reflected in the statement of changes in net assets available for benefits as net appreciation or depreciation in fair value of investments.

### ***Contributions***

Contributions to the Plan are recorded in the period in which they become obligations of the Plan Sponsor.

***Corrective Distributions***

Corrective distributions may be required in the event that employee contributions exceed contribution limitations of the Plan. These amounts are recorded as a liability as of the Plan's year end and are reflected on the statement of changes in net assets available for benefits as an offset to contributions.

***Payment of Benefits***

Participant benefits are recorded when paid. As of September 30, 2024 and 2023, there were no amounts allocated to accounts of participants who elected to withdraw from the Plan but had not yet been paid.

***Administrative and Other Costs***

During 2024, the Plan Sponsor paid administrative expenses of approximately \$11,000 on behalf of the Plan. Plan administrative and other costs of approximately \$61,000 were charged directly to the Plan. Certain other investment fees, commissions and reporting expenses are included in net appreciation in fair value of investments.

***Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles and with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results may differ from those estimates.

***Subsequent Events***

The Plan has evaluated subsequent events for recognition and disclosure through July 15, 2025 which is the date the financial statements were available to be issued.

**Note 3. Plan Certification**

The Plan Custodian holds the Plan's investments and executes all investment transactions. All investment information disclosed in the financial statements and supplemental schedule, including investments held at September 30, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on fully benefit-responsive investment contracts for the year ended September 30, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Plan Custodian.

**Note 4. Fair Value Measurements**

The fair value of financial instruments is presented based upon a hierarchy of levels that prioritize the inputs of valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The three levels of the fair value hierarchy are described below:

**Level 1** Unadjusted quoted prices in active markets for identical assets or liabilities the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Significant, unobservable inputs for the asset or liability in which little or no market data exists.

**Note 5. Risks and Uncertainties**

The Plan's investments are not insured and are subject to credit and market risks. Financial information relating to those investments is included in these financial statements based on information provided by the Plan Custodian.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 6. Income Tax Status**

The adopted plan is a prototype plan prepared and maintained by a third party. The prototype plan obtained its latest determination letter on June 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the adopted plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the Plan assets will be distributed in proportion to participants' respective account balances as of the date of termination.
