We have audited the financial statements of Hyundai Capital America Profit Sharing Retirement Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) for the year ended December 31, 2024, and have issued our report thereon dated July 1, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by Fidelity Management Trust Company, the trustee, which is a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedule, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. ## **Significant Audit Matters**

### ***Qualitative Aspects of Accounting Practices***

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

### ***Form 5500 Procedures***

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor’s report. The purpose of this procedure is to identify any material

inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

### ***Difficulties Encountered in Performing the Audit***

We encountered no significant difficulties in dealing with management in performing and completing our audit.

### ***Corrected and Uncorrected Misstatements***

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. We are aware of no uncorrected misstatements that are material to the Plan's financial statements.

### ***Disagreements with Management***

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

### ***Management Representations***

We have requested certain representations from management that are included in the management representation letter dated July 1, 2025.

### ***Management Consultations with Other Independent Accountants***

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

### ***Other Audit Findings or Issues***

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

### ***Other Matters***

With respect to the ERISA-required supplemental schedule accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the ERISA-required supplemental schedule to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Hyundai Capital America Profit Sharing Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Hyundai Capital America Profit Sharing Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**A. General**

The Plan was adopted effective January 1, 2014 as a defined contribution plan to cover all eligible employees of Hyundai Capital America (Company or Plan Sponsor) not covered by a collective bargaining agreement. An employee is automatically enrolled once he or she is eligible to participate, on the first day of the pay period following hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**B. Contributions**

Participants may make pretax or Roth contributions of up to 75% of total eligible annual compensation, subject to limitations of the Internal Revenue Code (IRC). Participants who have attained the age of 50 before the close of the Plan year may make catch-up contributions in accordance with, and subject to limitations of, the IRC.

The Company makes safe harbor matching contributions at 100% of the first 3% of compensation deferred by eligible employees plus 50% of the next 3% deferred, up to a maximum Company contribution of 4.5% of compensation.

Contributions may be invested in any of the investment options available under the Plan, as directed by the participants. If no election is made by the participant, contributions are invested in the appropriate target-date mutual fund.

**C. Participant Accounts**

Each participant's account is credited with his or her contributions, rollover contributions and allocations of (a) the Company contributions and (b) earnings or losses. Earnings or losses are allocated to the participants' balances, based on the proportion each account bears to the total of all account balances within each investment fund. The benefit to which a participant is entitled is the benefit that can be provided from the vested account balance.

**D. Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting of Company contributions plus earnings thereon is based on years of service at a rate of 25% per year, except that safe harbor matching contributions are immediately 100% vested. A participant is 100% vested after four years of service, upon death, disability, or retirement.

**E. Notes Receivable from Participants**

A participant may borrow a minimum of \$1,000 up to the lesser of \$50,000 reduced by the highest outstanding loan balance during the previous 12 months or one-half of his or her vested account balance. The interest rate on such loans is the prime rate plus 1%. Related administrative expenses are charged to each participant's account.

**F. Payment of Benefits**

Upon termination of service or retirement, vested benefits over \$5,000 due to participants or their beneficiaries may be held in the Plan or paid in a lump sum. The Plan requires minimum distributions to be made to the participant or beneficiary no later than April 1 of the calendar year following the year in which the participant reaches 70½. Vested benefits of \$5,000 or less may be distributed to the participant or beneficiary in a lump sum without the participant's written consent. A participant may make a hardship withdrawal from his or her account subject to certain IRC provisions and the approval of the Retirement Committee.

**G. Forfeited Accounts**

Forfeitures of nonvested accounts of terminating participants are used to offset future Company contributions. At December 31, 2024 and 2023, forfeitures available for future use totaled \$1,676 and \$10,952, respectively. Forfeitures and dividends earned on forfeiture accounts during 2024 were \$1,610. During 2024, the Company used \$10,886 of forfeitures to pay for the plan's expenses.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**B. Use of Estimates**

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**C. Risks and Uncertainties**

Plan investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the various risk factors in the near term could materially affect participants' account balances and the amounts reported in the financial statements.

**D. Investment Valuation and Income Recognition**

The participants select how their share of plan assets will be invested among those investment vehicles made available. Participants may change their investment options at any time during the Plan year.

GAAP establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices in an active market. Level 2 inputs are

quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

**NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Sponsor elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee, certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments reported in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reported in the schedule of assets (held at end of year) - December 31, 2024.

The plan administrator instructed the Plan's independent auditors not to perform any auditing procedures on certified information, except for comparing such information with related information included in the financial statements and supplemental schedule.

**NOTE 4 - RELATED PARTY TRANSACTIONS**

Certain investments of the Plan are funds managed by Fidelity Management Trust Company or related entities (Fidelity). Fidelity is the trustee as defined by the Plan, and therefore, these transactions qualify as party in interest transactions.

**NOTE 5 - ADMINISTRATIVE EXPENSES**

Most expenses are paid by the Plan Sponsor. Participants are also charged fees for certain types of transactions such as loans and withdrawals. During the year ended December 31, 2024, a total of net administrative credits of \$16,019 were allocated to participants' accounts.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 7 - INCOME TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated April 18, 2017 that the Plan is designed in accordance with applicable sections of the IRC. The Plan has since been amended; however the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
