Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the International Data Group, Inc. Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (In Liquidation) as of September 30, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended September 30, 2024 (In Liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023 and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As further described in Note 1 to the financial statements, the Plan Sponsor, International Data Group, Inc., amended the Plan on October 14, 2021 to formally terminate the Plan, and management determined liquidation was imminent. In accordance with accounting principles generally accepted in the United States of America, the Plan has presented the financial statements on the liquidation basis of accounting. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Notes to Financial Statements

Note 1 - Description of the Plan

The following description of the International Data Group, Inc. Employee Stock Ownership Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement and amendments for complete information.

General, Sale of Plan Sponsor Stock and Plan Termination and Liquidation

The Plan is a noncontributory defined contribution plan originally established by International Data Group, Inc. and its subsidiaries (the "Employer" or "Company"), effective as of January 1, 1976. Employees became eligible to participate in the Plan after one hour of service provided they worked at least 1,000 hours during a Plan year ("Participants") except those covered by a separate collective bargaining agreement and non-resident aliens. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

As a result of the sale of the Company in 2017, the Plan was amended on May 24, 2017 (effective date March 22, 2017) to state that the Plan will no longer be an "Employee Stock Ownership Plan" within the meaning of Section 4975(e)(7) of the Internal Revenue Code and is to be designated a "profit-sharing plan." No new participants are allowed into the Plan and all participants are fully vested in their accounts.

On November 15, 2021, the Company was acquired by private equity funds managed by Blackstone.

On October 14, 2021, the Plan was amended ("Termination Amendment") to formally terminate the Plan effective September 1, 2021. As a result, management has commenced the process of liquidating the Plan.

Employer Contributions and Allocations

There are no further Employer contributions being made to the Plan.

Participant Accounts

Individual accounts were established for each participant. Each participant's account is credited with pro rata allocations of Plan earnings or losses and actual distributions. Allocations are based on account balances, participant earnings or specific participant transactions as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Pursuant to the sale noted above, all participants became 100% vested in their account balances.

Withdrawals and Distributions

A participant or beneficiary with a liquid balance in their accounts can withdraw 100% of such account. Distributions will be made on a quarterly basis.

Plan Administration

Plan operations are maintained on the accrual basis by the Plan's recordkeeper, Principal Bank ("Principal"), which also performs, on an annual basis, the relevant tax compliance test for the Plan. GreatBanc Trust Company ("GreatBanc") serves as Plan Trustee. Officers and employees of the Employer perform certain administrative functions. No such officer or employee receives compensation from the Plan. Administrative expenses of the Plan are paid by the Plan sponsor as provided in the Plan document.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the liquidation basis of accounting. Under the liquidation basis of accounting, the Plan records assets and liabilities at expected cash proceeds upon liquidation, less any selling costs, which may be different from fair value. The Plan's assets did not have any substantial difference in value between these bases of accounting.

Investments, Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Sale proceeds represents proceeds from the sale of interests in General Partnerships that management had previously determined to have a fair value of zero due to certain uncertainties related to value and when they could be sold.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Benefits to Participants

Benefit payments are recorded when paid.

Note 3 - Information Certified by the Trustee

Plan investments are held by the Plan's trustee, GreatBanc. The fair value of investments as of September 30, 2024 and 2023 and all investment transactions for the year ended September 30, 2024, including interest income and other income are reported to the Plan and certified as complete and accurate by GreatBanc. Information included in the supplemental schedules has also been derived from information certified by GreatBanc.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Interest-Bearing Cash and Money Market Account (Including Escrow Funds)

Valued at cost, which approximates the fair value of the deposits held in an interest-bearing bank account by the Plan at year end. Included in interest-bearing cash on the accompanying Statements of Net Assets Available for Benefits is \$50,208 and \$50,939 of cash held in escrow as of September 30, 2024 and 2023, respectively.

Note 5 - Risks and Uncertainties

The Plan's investment securities (primarily money market investment and cash held in escrow) are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as an international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect Participant's account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 6 - Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments include an interest-bearing money market cash account managed by the Plan's trustee, and therefore, these transactions qualify as party-in-interest transactions.

Note 8 - Tax Status

The Internal Revenue Service has determined and informed the Plan by a letter, dated November 28, 2017, that the Plan and related trust were designed in accordance with the applicable regulations of the Internal Revenue Code (the "Code"). The Plan has been amended since receiving the determination letter; however, the Company and the Plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code, and the Plan and the related trust continue to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - Subsequent Events

The Plan and Plan management have evaluated subsequent events through July 15, 2025, the date that the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
