### **Opinion**

**NOTE 1 - DESCRIPTION OF THE PLAN**

The San Diego County Theatrical Group Insurance Trust Health and Welfare Fund (the "Plan") is a multiemployer health and welfare plan formed in 1972 under an agreement between the San Diego Theatrical Union and the contributing employers. The Plan provides health and other benefits to eligible participants and covered dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**C. Estimated Future Benefits Based on Participants' Accumulated Eligibility**

The Plan is required to provide benefits to certain active Plan participants, if such participants have accumulated credit amounts (expressed as reserve) in excess of the contributions required for current coverage.

**D. Employer Contributions**

Employer contributions as reported are contributions made by employers on behalf of employees based on a percentage of wages earned during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts.

**E. Tax-Exempt Status**

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state California under Revenue and Taxation Code Section 23701i.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**F. Investment Valuation and Income Recognition**

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) of investments includes gains and losses on investments bought and sold as well as held during the year.

**NOTE 3 - RELATED PARTY TRANSACTIONS**

Through a lockbox system, the Plan collects employer remittances on behalf of two related funds, the San Diego County Theatrical Pension Plan ("Pension Plan") and the San Diego County Theatrical Training Fund ("Training Fund"), and then transmits to the Pension Plan and Training Fund the amounts collected on their behalf.

The Plan was owed \$8,674 from the San Diego County Theatrical Training Corp ("Corp") as of September 30, 2024.

The Plan owed \$3,000 to the San Diego County Theatrical Training Fund ("Training Fund") at September 30, 2024 and 2023.

**NOTE 5 - CONCENTRATION OF CREDIT RISK**

During the year ended September 30, 2024, the Plan maintained bank accounts with cash balances in excess of the federally insured limit of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances.

**NOTE 6 - HEALTH REIMBURSEMENT ARRANGEMENT (HRA)**

Effective April 1, 2018, the Plan established an active HRA to permit eligible participants to obtain reimbursement of medical care expenses on a non-taxable basis. Each HRA is funded exclusively through contributions made on a participant's behalf by an employer that contributes to the Plan under a collective bargaining or participation arrangement. The amount of contributions is determined by the Board of Trustees and is subject to change or discontinuance at any time. A participant's available balance may be used only for certain health care expenses that are not otherwise covered under the Plan. Participants are not vested in contributions made on their behalf. Forfeitures for the years ended September 30, 2024 and 2023 are immaterial.

**NOTE 7 - PLAN TERMINATION**

Although there has been no expressed intent to do so, the Plan may be terminated in accordance with the provisions of ERISA and related regulations. In the event of termination of the Plan, the assets then remaining, after providing for the expense of the Plan and for the payment of any distributions already approved, shall be distributed among the participants.

**NOTE 8 - RISKS AND UNCERTAINTIES**

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risk. Due to the level of risk associated with investments and the level of uncertainty with respect to the changes in the value of investments, it is reasonably possible that changes in risk in the near term would materially affect the amounts reported in the financial statements.

**NOTE 9 - PLAN AMENDMENTS**

On January 19, 2023, the Plan reinstated life insurance and accidental death and dismemberment (AD&D) benefits.

On January 19, 2023, the Plan was amended to account for the change to CIGNA Dental.

On May 3, 2023, the Plan was amended to account for the change to Aetna EAP.

On May 3, 2023, the Plan was amended to account for the change to Prudential Life Insurance.

On October 16, 2023, the Plan reduced the initial eligibility requirements from 1,600 hours in four months to 1,200 hours in a three month period.

On March 18, 2024 the Plan reinstated contributions to the Health Reimbursement Account for the work month of April 2024.
