### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements

We have performed the audit of the financial statements of Homestead Village, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2022, the related statement of changes in net assets available for benefits for the year ended June 30, 2022, and the related notes to the financial statements (2022 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. #### **Note 1 - Description of Plan**

The following description of the Homestead Village, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

##### **General**

The Plan is a defined contribution pension plan covering all eligible employees of Homestead Village, Inc. (Homestead) who have completed 60 days of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### **Contributions**

Each year, participants may contribute up to the maximum amount of pre-tax annual compensation as defined in the Plan. Participants may also designate all or a portion of their elective deferrals as after-tax Roth deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. Additionally, for enrolled participants, the deferral rate shall be increased 1% each year up to a maximum deferral rate of 15% of eligible compensation, unless the participant elects not to have this auto-escalation feature occur. Homestead matches 100% of the participant's salary deferral contributions that do not exceed 3% of the participant's compensation plus 50% of the participant's salary deferral contributions that exceed 3%, but do not exceed 5%, of the participant's compensation. Homestead may make a discretionary profit-sharing contribution. Homestead has not made a discretionary profit-sharing contribution for the years ended June 30, 2022 or 2021. Contributions are subject to certain IRS limitations.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Homestead's matching contributions, and allocations of (a) Homestead's profit-sharing contributions, (b) plan earnings, and charged with an allocation of administrative expenses. Additionally, each participant's account may also be credited with a portion of plan forfeitures, if applicable. Allocations are based on participant compensation and/or account balances, as defined. Loan and disbursement processing fees are charged directly to the respective participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are immediately vested in their contributions. Vesting in employer contributions, plus actual earnings thereon, are based on years of credited service. A participant is 100% vested after six years of credited service, based on the following vesting schedule:

##### Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless the loan is to acquire the participant's principal residence, in which case the loan may be for up to 15 years. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 2%, set at the time the loan is obtained. Principal and interest are paid ratably through payroll deductions.

##### Payment of Benefits

On termination of service due to retirement, disability, or death, distributions equal to the value of the participant's vested interest in their account will be paid as soon as administratively possible in a lump sum or as an annuity. On termination of service other than by retirement, disability, or death, a participant will receive a lump-sum payment if the total of their vested account balance does not exceed \$1,000. If the vested value of the participant's account is \$1,001 or more but less than \$5,000 and, if after receiving all required notices, the participant does not affirmatively elect a distribution method, the balance of the participant's vested account will be automatically rolled over to an individual retirement account. If the vested account balance equals or exceeds \$5,000, the assets will generally be held in a trust until the participant's normal or early retirement date or until the participant affirmatively elects a distribution method. In addition, the Plan allows for hardship distributions if certain criteria are met.

##### Forfeited Accounts

As of June 30, 2022 and 2021, forfeited nonvested accounts amounted to \$18,079 and \$5,039, respectively. Forfeitures of employer matching nonvested accounts and employer discretionary profit-sharing nonvested accounts can be used to pay future administrative expenses of the Plan or be allocated to all qualifying participants. During the years ended June 30, 2022 and 2021, there were \$-0- and \$2,571, respectively, of forfeitures applied against administrative expenses. During the years ended June 30, 2022 and 2021, no forfeitures were allocated to qualifying participants.

### **Note 2 - Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of June 30, 2022 and 2021.

#### **Excess Contribution Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2022 and 2021 excess contributions to the applicable participant prior to September 15, 2022 and 2021, respectively.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by Homestead. Expenses that are paid by Homestead are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Fees related to the distribution of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

#### **Note 3 - Information Certified and Provided by John Hancock Trust Company**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of June 30, 2022 and 2021, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended June 30, 2022 and 2021, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company, the trustee of the Plan.

#### **Note 4 - Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at June 30, 2022 and 2021.

Registered investment companies are valued at the net asset value of shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. #### Note 5 - Tax Status

Homestead has adopted a pre-approved plan document that was sponsored by John Hancock Retirement Plan Services LLC. The pre-approved document has received an opinion letter from the IRS, dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 6 - Plan Termination

Although it has not expressed any intent to do so, Homestead has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in all of their accounts.

#### Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
